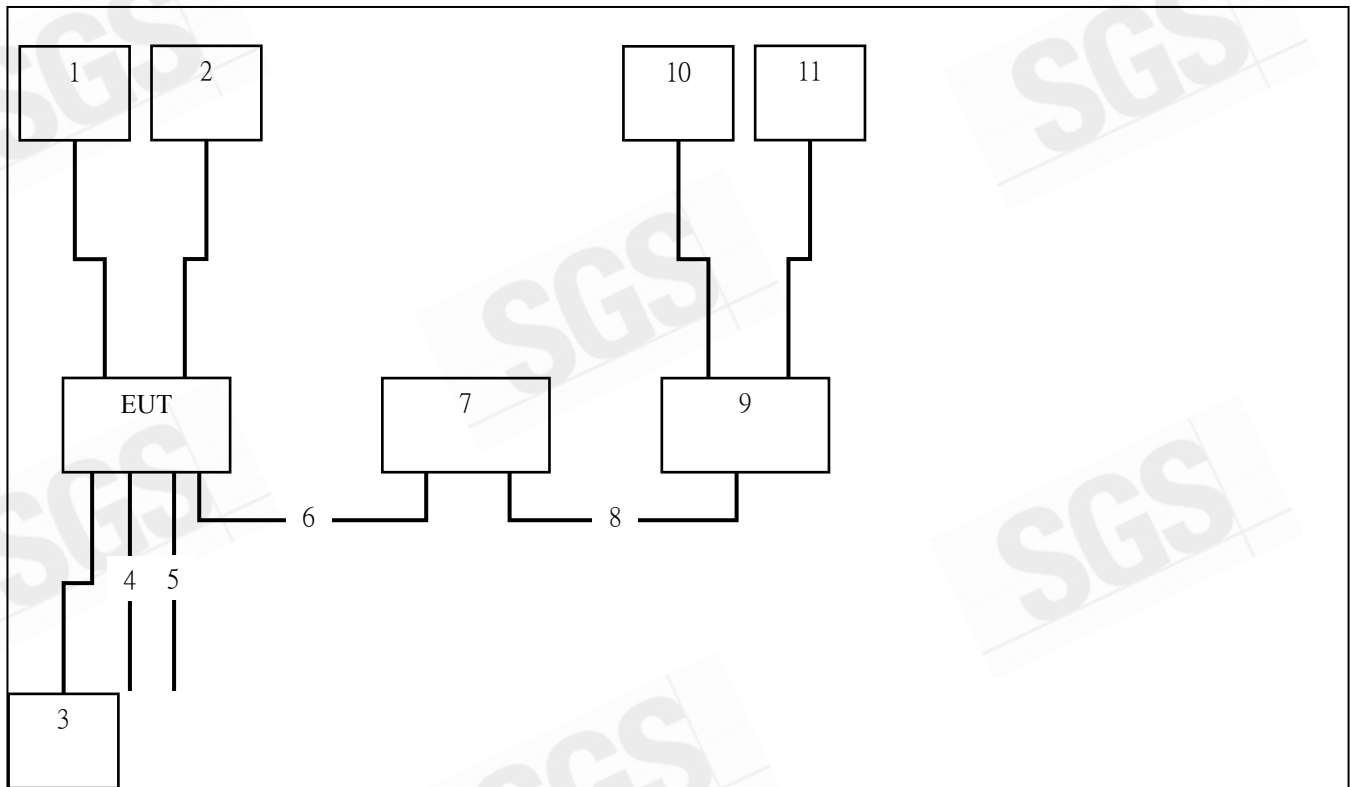

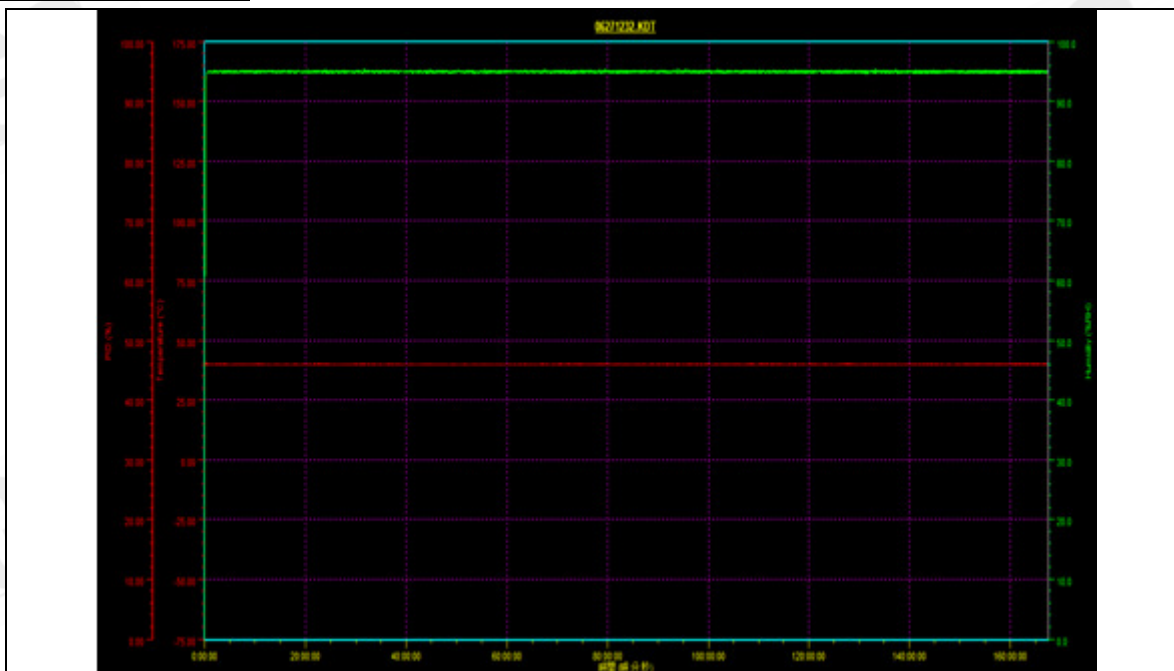

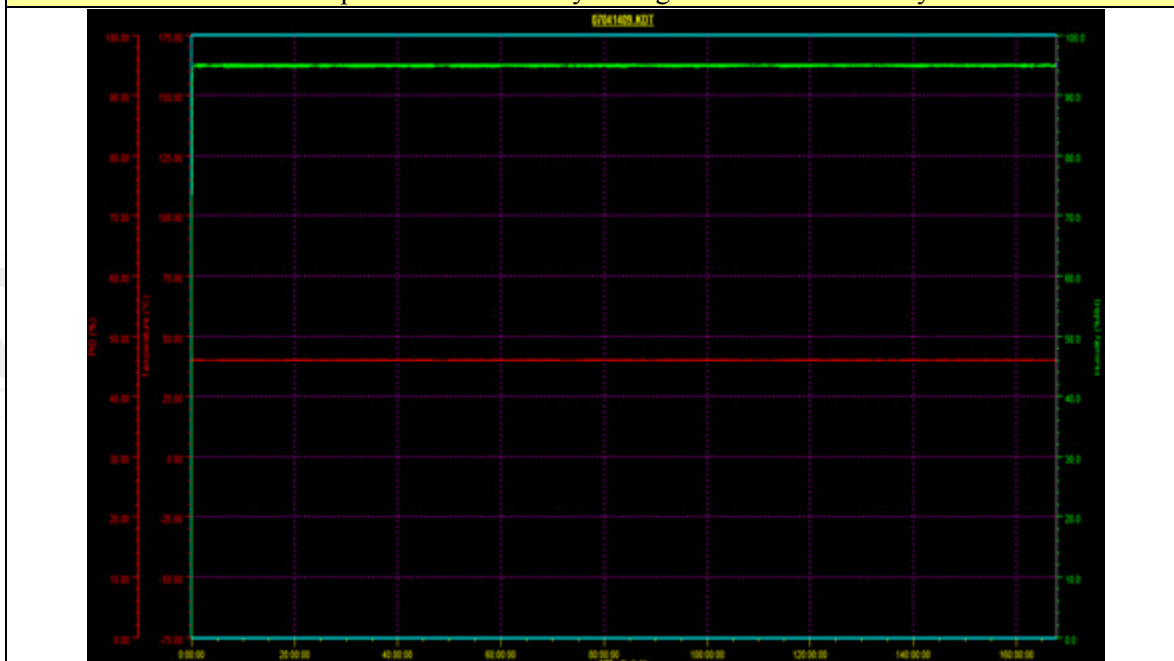

1. Temperature & Humidity Storage Test Profile --1<sup>ST</sup> cycle

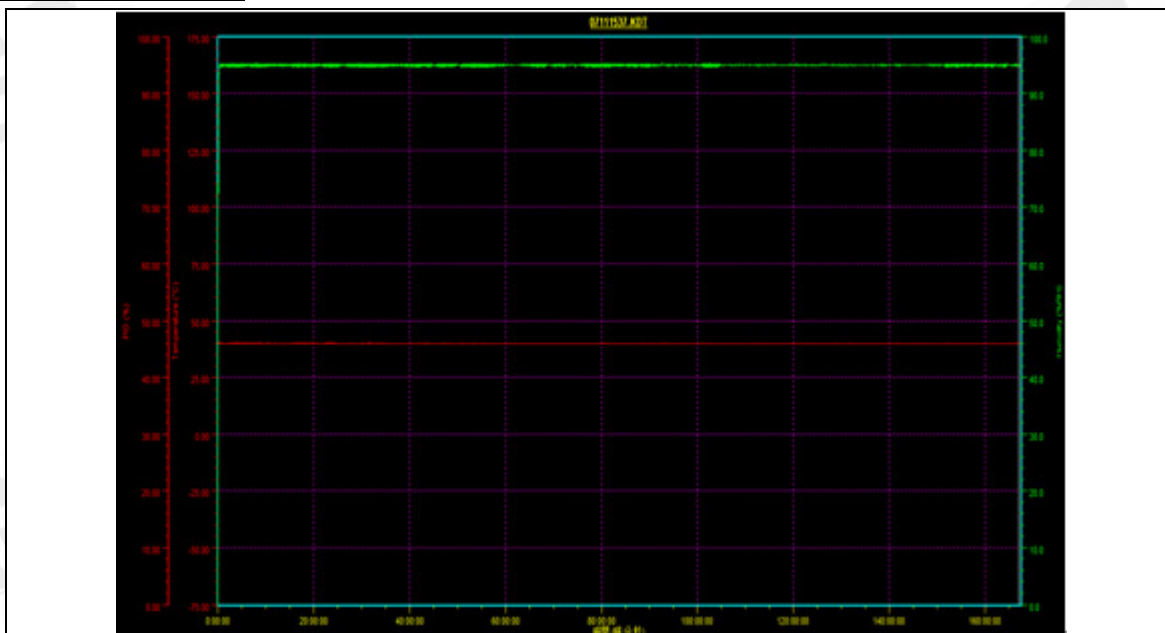


2. Temperature & Humidity Storage Test Profile --2<sup>ND</sup> cycle

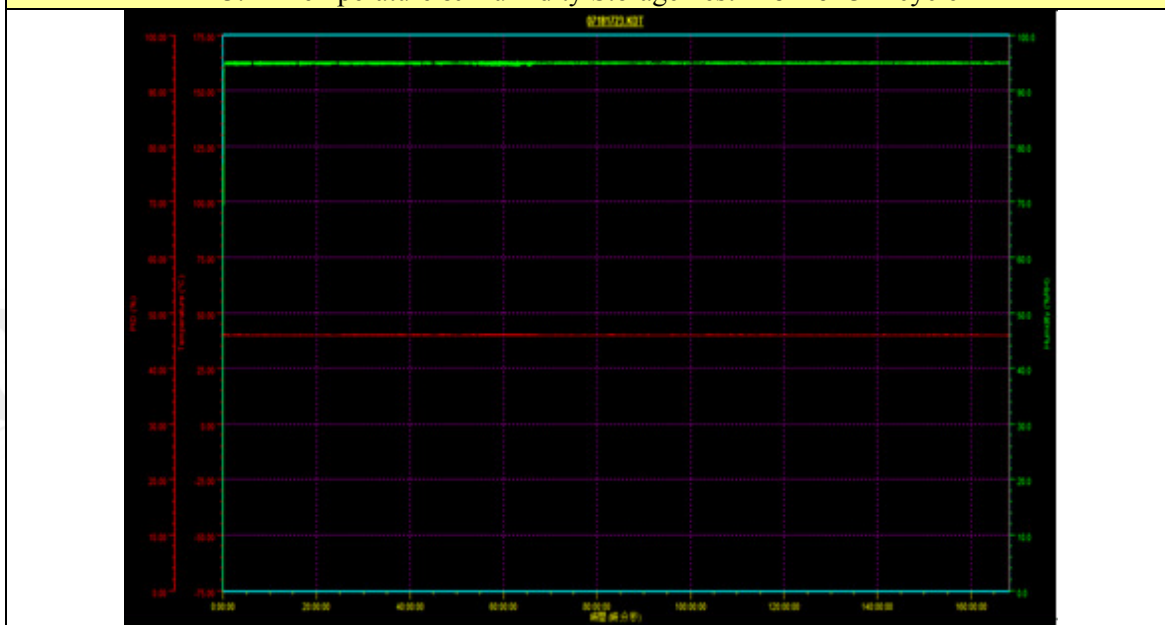
