


3.4 BLOCK DIGRAM SHOWING THE CONFIGURATION OF SYSTEM TESTED



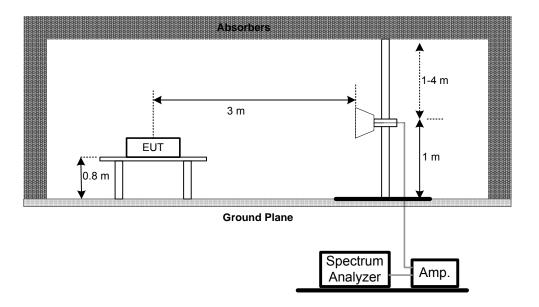


