2. System Test Configuration

2.1 EUT Configuration

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner which intends to maximize its emission characteristics in a continuous normal application.

2.2 EUT Exercise

The Transmitter was operated in the normal operating mode. The TX frequency was fixed which was for the purpose of the measurements.

2.3 Test Procedure

2.3.1 Conducted Emissions

The EUT is a placed on as turn table which is 10mm above ground plane. According to the requirements in Section 13.1.4.1 of ANSI C63.4-2009 Conducted emissions from the EUT measured in the frequency range between 0.15 MHz and 30MHz using CISPR Quasi-Peak and average detector mode.

2.3.2 Radiated Emissions

The EUT is a placed on as turn table which is 10mm above ground plane. The turn table shall rotate 360 degrees to determine the position of maximum emission level. EUT is set 3m away from the receiving antenna which varied from 1m to 4m to find out the highest emission. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical. In order to find out the max. emission, the relative positions of this hand-held transmitter(EUT) was rotated through three orthogonal axes according to the requirements in Section 13.1.4.1 of ANSI C63.4-2009.

2.4 Description of test modes

The EUT has been tested under normal operating condition.
 Let EUT transmit with highest power, and the worst result was reported with modulation GFSK. 3 channels of lower, medium and higher were chosen for test.

5. Radiated Emission Test

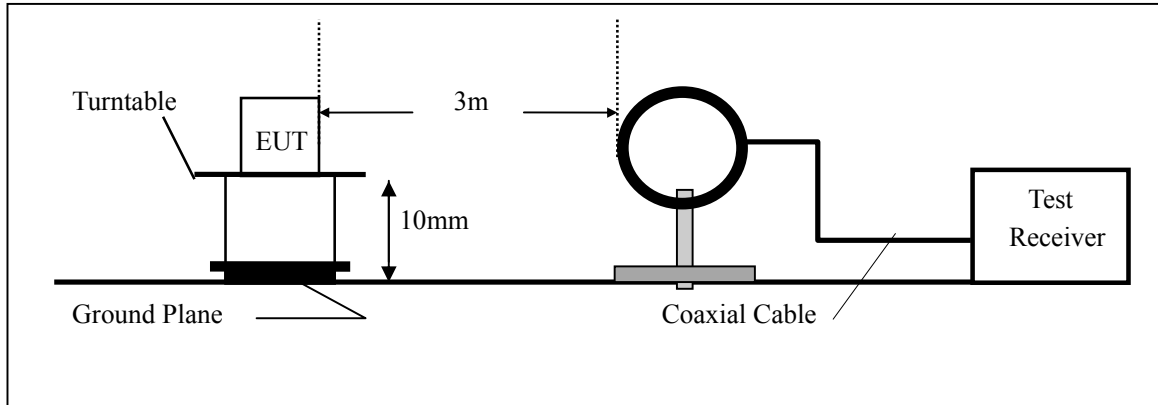
5.1 Measurement Procedure

- a. The EUT was placed on the top of a rotating table 10mm above the ground at a 3 meter Semi-anechoic chamber. The table was rotated 360 degrees to determine the position of the highest radiation.(below 1GHz)
- b. The EUT was placed on the top of a rotating table 0.8 meters above the ground at a 3 meter Semi-anechoic chamber. The table was rotated 360 degrees to determine the position of the highest radiation.(above 1GHz)
- c. The height of the equipment or of the substitution antenna shall be 0.8 m; the height of the test Antenna shall vary between 1 m to 4 m. Both horizontal and vertical polarizations of the antenna are set to make the measurement.
- d. The initial step in collecting conducted emission data is a spectrum analyzer peak detector Mode pre-scanning the measurement frequency range. Significant peaks are then marked and then AV detector mode re-measured.
- e. If the Peak Mode measured value compliance with and lower than Quasi Peak Mode Limit, the EUT shall be deemed to meet QP Limits and then no additional QP Mode measurement performed.

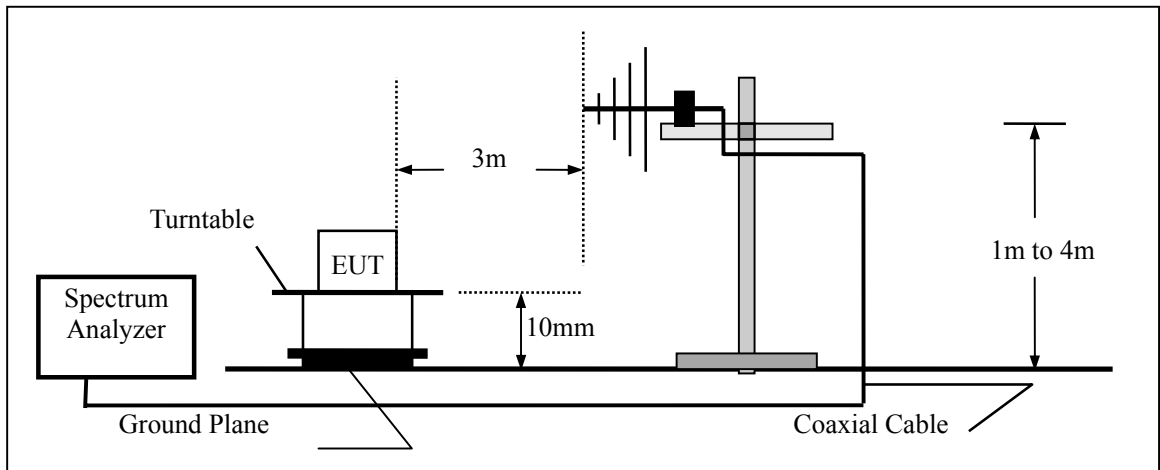
For emissions measurement set the bandwidth of the Spectrum's RBW at 1MHz

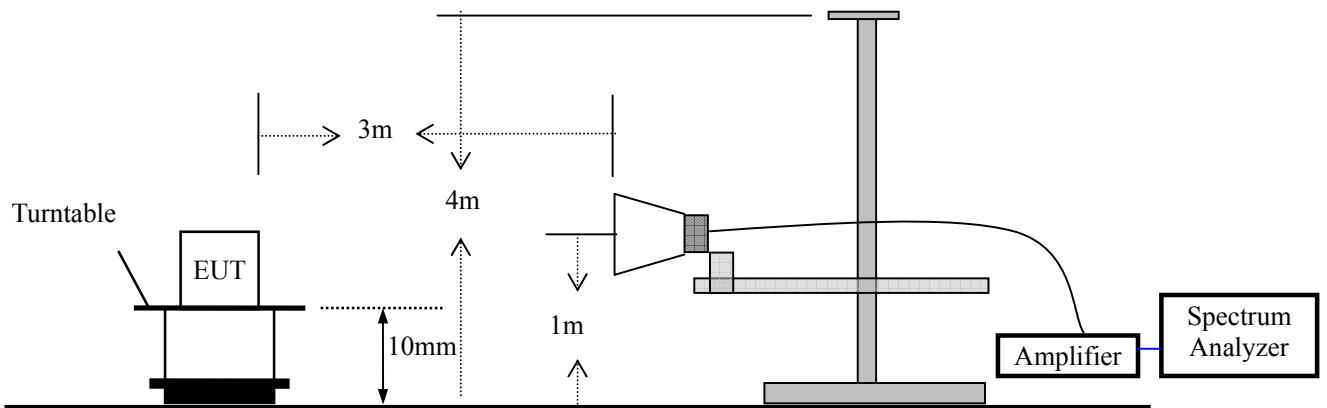
(A) Radiated Emission Test Set-Up, Frequency Below 30MHz

7. Band EDGE test

7.1 Measurement Procedure

9. Antenna Application

9.1 Antenna requirement

For intentional device, according to FCC 47 CFR Section 15.203, an intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. And according to FCC 47 CFR Section 15.249, if transmitting antennas of directional gain greater than 6dBi are used, the power shall be reduced by the amount in dB that the directional gain of the antenna exceeds 6dBi.
