- d. Allow trace to stabilize, use the marker-delta function to measure single pulse duration.
- e. Repeat above procedures until all test modes were measured.

11. ANTENNA REQUIREMENTS

11.1. Limit

Further, this requirement does not apply to intentional radiators that must be professionally installed, such as perimeter protection systems and some field disturbance sensors, or to other intentional radiators which, in accordance with §15.31(d), must be measured at the installation site. However, the installer shall be responsible for ensuring that the proper antenna is employed so that the limits in this part are not exceeded.
