




Fig.6-over view (type: HC42BL11S000100)





Fig.10 -main board view (type: HC42BL11S000100)






Fig.11 -main board view (type: HC42BL11S000100)





Fig.12-over view (type: HC42BL00S000000)






Fig.13-over view (type: HC42BL00S000000)






Fig.15 -over view (type: HC42BL00S000000)






Fig.18 -battery compartment view (type: HC42BL00S000000)






Fig.19 -internal view (type: HC42BL00S000000)





Fig.20 -main board view (type: HC42BL00S000000)





Fig.22 -main board view (type: HC42BL00S000000)







Fig.23-over view (type: HC42BL01S000100)






Fig.28 -over view (type: HC42BL01S000100)







Fig.29 -battery compartment view (type: HC42BL01S000100)





Fig.32-main board view (type: HC42BL01S000100)






Fig.33 -main board view (type: HC42BL01S000100)





Fig.34-over view (type: HC42BL10S000000)






Fig.35 -over view (type: HC42BL10S000000)




Fig.36 -over view (type: HC42BL10S000000)






Fig.40 -battery compartment view (type: HC42BL10S000000)






Fig.41 -internal view (type: HC42BL10S000000)





Fig.42 -main board view (type: HC42BL10S000000)






Fig.43 -main board view (type: HC42BL10S000000)





Fig.44 -main board view (type: HC42BL10S000000)
