

## **Neck tag install**

## \*\*FCC Radio frequency interference statement

It is recommended to make a list of the Tag ID numbers and the Animal ID associated with each tag and keep the hard copy as a reference.

- Don't put your hands through the moving bars
- Don't put your hands in the headlock.
- 1. The person attaching the tags stands to the right side of the animal's head. Hold the strap in two hands, the tag on the animal's right, the weight at the bottom of the strap and the buckle to the animal's left. The Tag ID number will be facing you.
- 2.Drop the loose end of the strap so it is next to the animal's neck.
- 3. With the right hand, reach through the stationary bars and catch the loose end of the strap. Bring both ends of the strap over the animal's neck and thread the loose end of the strap through the buckle and adjust it until the strap is next to the animal's neck, about one flat hand's width between the neck and the strap.
- 4. The strap should sit at the upper part of the neck, with the tag placed behind the animal's right ear. Now close the buckle firmly. Slide the end protector over the loose end of the strap, to hold it securely in place.
- 5. Before releasing the animal from the headlock or squeeze, double check your list, to see that the Animal ID and Tag ID are correct and the tag position and strap tension are also correct.

- To remove the tags from the animals, reach over the headlock, slide a screwdriver or flat tool under the buckle to release and pull up. Slide the strap protector down, over the end of the strap and gently remove the strap from the buckle, holding the buckle firmly, removing the collar from the animal's neck.
- 2. **It is important** to: Record the Tag ID number and the Cow ID, as a reference to remove the tag association from the system.
- 3. On the Animal Card or the Animals Tags report, change the tag type to "None", then save. This will remove the association of the tag and the animal and make the tag ID available to be reassigned to another animal.
