


CH Mid 2438MHz





Peak Power Output Data Plot(CH Low 2412MHz)









Radiated Emission Test Set-up Frequency Over 1GHz









CH Low 2412MHz Radiated Bandedge(Vertical)







CH High 2464MHz Radiated Bandedge(Horizontal)





Band Edge (Conducted Mode)







Power Spectral Density Test Plot(CH-Low)







Channel Low 2412MHz



Channel Middle 2438MHz


