5.1 FCC Radiofrequency radiation exposure limits:

5.2 IC Radiofrequency radiation exposure limits:

According to RSS-102 section 2.5.2, RF exposure evaluation is required if the separation distance between the user and/or bystander and the device's radiating element is greater than 20 cm, except when the device operates as follows:

below 20 MHz and the source-based, time-averaged maximum e.i.r.p. of the device is equal to or less than 1 W (adjusted for tune-up tolerance);

- at or above 20 MHz and below 48 MHz and the source-based, time-averaged maximum e.i.r.p. of the device is equal to or less than $4.49/f^{0.5}$ W (adjusted for tune-up tolerance), where f is in MHz;
- at or above 48 MHz and below 300 MHz and the source-based, time-averaged maximum e.i.r.p. of the device is equal to or less than 0.6 W (adjusted for tune-up tolerance);
- at or above 300 MHz and below 6 GHz and the source-based, time-averaged maximum e.i.r.p. of the device is equal to or less than 1.31 x $10^{-2} f^{0.6834}$ W (adjusted for tune-up tolerance), where f is in MHz;
- at or above 6 GHz and the source-based, time-averaged maximum e.i.r.p. of the device is equal to or less than 5 W (adjusted for tune-up tolerance).

For 2.4G device, the limit of worse case is 2.68 W

6.2 MPE Calculation

The Max Conducted Peak Output Power is 1.11mW in Middle channel of 8DPSK;

The best case gain of the antenna is 2dBi. 2dB logarithmic terms convert to numeric result is nearly 1.58 For FCC:

According to the formula S= $\frac{PG}{4R^2\pi}$, we can calculate S which is MPE.

Note:

- 1) P (Watts)
- 2) G (Antenna gain in numeric)
- 3) R = distance to the center of radiation of antenna (in meter) = 20cm
- 4) MPE limit = 1mW/cm²

$$S = \frac{PG}{4R^2\pi} = \frac{1.11 \times 1.58}{4 \times 400 \times 3.14} = 0.00035 \text{ mW/cm}^2 < 1 \text{mW/cm}^2$$

E.I.R.P.=P*G=1.754mW<2.68W

So the device is exclusion from SAR test.
