1. The modular transmitter must have its own RF shielding.	The module transmitter has its own RF shielding. Please see external photo, the shielding paste the label.
2. The modular transmitter must have buffered modulation/data inputs.	The modular has buffered data inputs, it is integrated in chip 88AP166. Please view the Schematic.
3. The modular transmitter must have its own power supply regulation.	All power lines derived from the host device are regulated before energizing other circuits internal to the Schematic.
4. The modular transmitter must comply with the antenna requirements of Section 15.203 and 15.204(c).	The Caprica 2L meets the FCC antenna requirements. It used no-standard electrical connector. Please see external photo.
5. The modular transmitter must be tested in a stand-alone configuration, i.e., the module must not be inside another device during testing.	The Caprica 2L was tested in a stand-alone configuration. Please see conducted set-up photo and spurious set-up photo.

The modular transmitter must be labeled with its own FCC ID number, and, if the FCC ID is not visible when the module is installed inside another device, then the outside of the device into which the module is installed must also display a label referring to the enclosed module.	The label position of Caprica 2L is clearly indicated. Please see the label.

The modular transmitter must comply with any specific rule or operating requirements applicable to the transmitter and the manufacturer must provide adequate instructions along with the module to explain any such requirements. A copy of these instructions must be included in the application for equipment authorization.	The Caprica 2L is compliant with all applicable FCC rules. Detail instructions are given in the User_Manual.
