6.2 MPE Calculation

According to the formula S= $\frac{PG}{4R^2\pi}$, we can calculate S which is MPE.

Note:

1) P (Watts) = Power Input to antenna = $10^{\frac{dBm}{10}}$ / 1000

2) G (Antenna gain in numeric) = 10[^] (Antenna gain in dBi /10)

3) R = distance to the center of radiation of antenna (in meter) = 20cm

4) MPE limit = 1mW/cm²

The Max Conducted Peak Output Power is 114.02mW in lowest channel of 802.11g; The best case gain of the antenna is 2dBi. 2dB logarithmic terms convert to numeric result is nearly 1.58

So, S=
$$\frac{PG}{4R^2\pi}$$
 = $\frac{114.02 \times 1.58}{4 \times 400 \times 3.14}$ =0.03597 mW/cm²

The BT and the DTS modules cann't simultaneous transmitting at frequency 2.4GHz band, according to the KDB447498 D01 section 7.2 determine the device is exclusion from SAR test.
