Band2-20MHz-QPSK-18700-1RB#0-Range2:0.15~30MHz

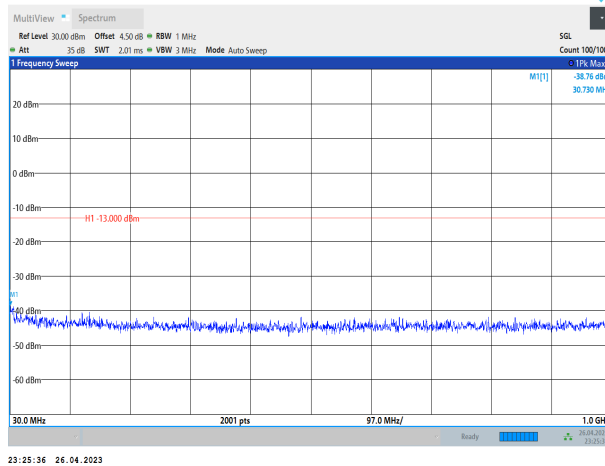
