Conducted emissions are measured with Line Impedance Stabilization Networks and EMI Test Receivers.

Calibrated wideband preamplifiers, coaxial cables, and coaxial attenuators are also used for making measurements.

All receiving equipment conforms to CISPR Publication 16-1, "Radio Interference Measuring Apparatus and Measurement Methods."

8.2 MAXIMUM PEAK OUTPUT POWER

<u>LIMIT</u>

§15.247(b)(1) For frequency hopping systems operating in the 2400-2483.5 MHz band employing at least 75 non-overlapping hopping channels, and all frequency hopping systems in the 5725-5850 MHz band: 1 watt. For all other frequency hopping systems in the 2400-2483.5 MHz band: 0.125 watts.

Test Configuration



TEST PROCEDURE

The RF power output was measured with a Spectrum Analyzer connected to the RF Antenna connector (conducted measurement) while EUT was operating in transmit mode at the appropriate center frequency.

Peak Power set:

- 1. Set the RBW = 1 MHz.
- 2. Set the VBW \geq [3 × RBW].
- 3. Set the span ≥ [1.5 × DTS bandwidth].
- 4. Detector = peak.
- 5. Sweep time = auto couple.
- 6.Trace mode = max hold.
- 7. Allow trace to fully stabilize.
- 8. Use the instrument's band/channel power measurement function with the band limits set equal to the DTS bandwidth edges (for some instruments, this may require a manual override to select the peak detector). If the instrument does not have a band power function, then sum the spectrum levels (in linear power units) at intervals equal to the RBW extending across the DTS channel bandwidth.

1. Measure the duty cycle D of the transmitter output signal

- 2. Set span to at least 1.5 times the OBW.
- 3. Set RBW = 1% to 5% of the OBW, not to exceed 1 MHz.

- 5. Number of points in sweep \geq [2 × span / RBW]. (This gives bin-to-bin spacing \leq RBW / 2, so that narrowband signals are not lost between frequency bins.)

8.3 HOPPING CHANNEL SEPARATION

LIMIT

§15.247(a)(1) Frequency hopping systems shall have hopping channel carrier frequencies separated by a minimum of 25 kHz or the 20 dB bandwidth of the hopping channel, whichever is greater. Alternatively, frequency hopping systems operating in the 2400-2483.5 MHz band may have hopping channel carrier frequencies that are separated by 25 kHz or two-thirds of the 20 dB bandwidth of the hopping channel, whichever is greater, provided the systems operate with an output power no greater than 125 mW. Duty Cycle









OUT-OF-BAND SPURIOUS EMISSIONS-CONDUCTED MEASUREMENT





8.9 POWERLINE CONDUCTED EMISSIONS

§ 15.207 (a) Except as shown in paragraph (b) and (c) this section, for an intentional radiator that is designed to be connected to the public utility (AC) power line, the radio frequency voltage that is conducted back onto the AC power line on any frequency or frequencies within the band 150 kHz to 30 MHz shall not exceed the limits in the following table, as measured using a 50 μ H/50 ohms line impedance stabilization network (LISN). Compliance with the provisions of this paragraph shall be based on the measurement of the radio frequency voltage between each power line and ground at the power terminal.


