## 1. RF Exposure Evaluation

### 1.1. Limits

According to FCC 1.1310: The criteria listed in the following table shall be used to evaluate the environment impact of human exposure to radio frequency (RF) radiation as specified in 1.1307(b)

Friis Formula

Friis transmission formula:  $P_d = (P_{out} * G) / (4 * \pi * r^2)$

Where

$P_d$  = power density in mW/cm<sup>2</sup>

$P_{out}$  = output power to antenna in mW

G = gain of antenna in linear scale

$\pi$  = 3.1416

R = distance between observation point and center of the radiator in cm

$P_d$  is the limit of MPE, 1 mW/cm<sup>2</sup>. If we know the maximum gain of the antenna and the total power input to the antenna, through the calculation, we will know the distance r where the MPE limit is reached.

### 1.2. Test Procedure

Software provided by client enabled the EUT to transmit and receive data at lowest, middle and highest channel individually.

The temperature and related humidity: 18°C and 78% RH.

#### Antenna Gain

Antenna Gain: The maximum Gain measured in fully anechoic chamber is 2.8 dBi in logarithm scale.

#### Output Power Into Antenna & RF Exposure Evaluation Distance (2.8 dBi):

The distance  $r$  (4<sup>th</sup> column) calculated from the Friis transmission formula is far shorter than 20 cm separation requirement.
