4.1. Antenna requirement


An intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator, the manufacturer may design the unit so that a broken antenna can be replaced by the user, but the use of a standard antenna jack or electrical connector is prohibited.

FCC CFR Title 47 Part 15 Subpart C Section 15.247(c) (1)(i):

(i) Systems operating in the 2400-2483.5 MHz band that is used exclusively for fixed. Point-to-point operations may employ transmitting antennas with directional gain greater than 6dBi provided the maximum conducted output power of the intentional radiator is reduced by 1 dB for every 3 dB that the directional gain of the antenna exceeds 6dBi.






TEST PROCEDURE

- 1. The EUT was setup according to ANSI C63.4: 2014 and tested according to ANSI C63.10: 2013 for compliance to FCC 47CFR 15.247 requirements.
- The EUT was placed on a platform of nominal size, 1 m by 1.5 m, raised 80 cm above the conducting ground plane. The vertical conducting plane was located 40 cm to the rear of the EUT. All other surfaces of EUT were at least 80 cm from any other grounded conducting surface.
- 3. The EUT and simulators are connected to the main power through a line impedance stabilization network (LISN). The LISN provides a 50 ohm /50uH coupling impedance for the measuring equipment.
- 4. The peripheral devices are also connected to the main power through a LISN. (Please refer to the block diagram of the test setup and photographs)
- 5. Each current-carrying conductor of the EUT power cord, except the ground (safety) conductor, was individually connected through a LISN to the input power source.
- 6. The excess length of the power cord between the EUT and the LISN receptacle were folded back and forth at the center of the lead to form a bundle not exceeding 40 cm in length.
- 7. Conducted emissions were investigated over the frequency range from 0.15MHz to 30MHz using a receiver bandwidth of 9 kHz.





- 2. The maximum peak conducted output power may be measured using a broadband peak RF power meter.
- 3. The power meter shall have a video bandwidth that is greater than or equal to the DTS bandwidth and shall utilize a fast-responding diode detector
- 4. Record the measurement data.





- 1. Connect the antenna port(s) to the spectrum analyzer input,
- Configure the spectrum analyzer as shown below: Center frequency=DTS channel center frequency Span =1.5 times the DTS bandwidth RBW = 3 kHz ≤ RBW ≤ 100 kHz, VBW ≥ 3 × RBW Sweep time = auto couple Detector = peak Trace mode = max hold
- 3. Place the radio in continuous transmit mode, allow the trace to stabilize, view the transmitter waveform on the spectrum analyzer.
- 4. Use the peak marker function to determine the maximum amplitude level within the RBW.
- 5. If measured value exceeds limit, reduce RBW (no less than 3 kHz) and repeat.






4.6. Restricted band (Conducted)

<u>LIMIT</u>

FCC CFR Title 47 Part 15 Subpart C Section 15.247 (d):

In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, radiated emissions which fall in the restricted bands, as defined in §15.205(a), must also comply with the radiated emission limits specified in §15.209(a) (see §15.205(c)).

TEST PROCEDURE

- According to KDB 558074 D01 V03R02 for Antenna-port conducted measurement. Antenna-port conducted measurements may also be used as an alternative to radiated measurements for demonstrating compliance in the restricted frequency bands.
 - 1) Measure the conducted output power (in dBm) using the Peak /average detector
 - 2) Add the maximum transmit antenna gain (in dBi) to the measured output power level to determine the EIRP level
 - Add the appropriate maximum ground reflection factor to the EIRP level 6 dB for frequencies ≤ 30 MHz
 4.7 dB for frequencies between 30 MHz and 1000 MHz
 0 dB for frequencies > 1000 MHz
 - 4) For devices with multiple antenna-ports, measure the power of each individual chain and sum the EIRP of all chains in linear terms
 - 5) Convert the resultant EIRP level to an equivalent electric field strength using the following relationship:

E = EIRP - 20log D + 104.8

where:

E = electric field strength in $dB\mu V/m$,

EIRP = equivalent isotropic radiated power in dBm

D = specified measurement distance in meters.

6) Compare the resultant electric field strength level to the applicable limit

2. Peak power measurement procedure

Peak emission levels are measured by setting the instrument as follows

- RBW = 1MHz, VBW \ge 3 x RBW
- Detector = Peak, Sweep time = auto




4.7. Band edge and Spurious Emission (conducted)

<u>LIMIT</u>

FCC CFR Title 47 Part 15 Subpart C Section 15.247 (d):

In any 100 kHz bandwidth outside the frequency band in which the spread spectrum intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement.

TEST PROCEDURE

- 1. The EUT was setup according to ANSI C63.4: 2014 and tested according to ANSI C63.10:2013 for compliance to FCC 47CFR 15.247 requirements.
- 2. The EUT is placed on a turn table which is 0.8 meter above ground. The turn table is rotated 360 degrees to determine the position of the maximum emission level.
- 3. The EUT was positioned such that the distance from antenna to the EUT was 3 meters.
- 4. The antenna is scanned from 1 meter to 4 meters to find out the maximum emission level. This is repeated for both horizontal and vertical polarization of the antenna. In order to find the maximum emission, all of the interface cables were manipulated according to ANSI C63.4:2014 on radiated measurement.
- 5. Use the following spectrum analyzer settings
 - (1) Span shall wide enough to fully capture the emission being measured;
 - (2) Below 1GHz, RBW=120KHz, VBW=300KHz, Sweep=auto, Detector function=peak, Trace=max hold; If the emission level of the EUT measured by the peak detector is 3 dB lower than the applicable limit, the peak emission level will be reported. Otherwise, the emission measurement will be repeated using the quasi-peak detector and reported.
 - (3) Above 1GHz, RBW=1MHz, VBW=3MHz for Peak value






