1. RF Exposure Evaluation

1.1. Limits

SAR Test Exclusion Thresholds for 100 MHz – 6 GHz and ≤ 50 mm

Approximate SAR Test Exclusion Power Thresholds at Selected Frequencies and Test Separation Distances are illustrated in the following Table. The equation and threshold in Note 1 must be applied to determine SAR test exclusion.

Note 1:

The 1-g and 10-g SAR test exclusion thresholds for 100 MHz to 6 GHz at test separation distances ≤ 50 mm are determined by:

$[(\text{max. power of channel, including tune-up tolerance, mW}) / (\text{min. test separation distance, mm})] * \sqrt{f(\text{GHz})} \leq 3.0$ for 1-g SAR and ≤ 7.5 for 10-g extremity SAR, where

- $f(\text{GHz})$ is the RF channel transmit frequency in GHz
- Power and distance are rounded to the nearest mW and mm before calculation
- The result is rounded to one decimal place for comparison
- 3.0 and 7.5 are referred to as the numeric thresholds in the step 2 below

The test exclusions are applicable only when the minimum test separation distance is ≤ 50 mm and for transmission frequencies between 100 MHz and 6 GHz. When the minimum test separation distance is < 5 mm, a distance of 5 mm according to 5) in section 4.1 is applied to determine SAR test exclusion.

1.2. Test Procedure

Software provided by client enabled the EUT to transmit and receive data at lowest, middle and highest channel individually.

The temperature and related humidity: 18°C and 78% RH.

1.3. Test Result of RF Exposure Evaluation

Antenna Gain: The maximum Gain measured in fully anechoic chamber is 0.91dBi for 2.4GHz in logarithm scale.

Output Power into Antenna:

Per FCC KDB 447498 D01v05r02, the SAR exclusion threshold for distances < 50mm is defined by the following equation:

$$\frac{\text{Max Power of Channel (mW)}}{\text{Test Separation Dist (mm)}} * \sqrt{\text{Frequency (GHz)}} \leq 3.0$$

Based on the maximum conducted power of Wi-Fi and the antenna to use separation distance, Wi-Fi SAR was not required;

$$[(9.57\text{mW}/5) * \sqrt{2.412}] = 2.97 < 3.0.$$

Based on the maximum conducted power of BLE and the antenna to use separation distance, Wi-Fi SAR was not required;

$$[(0.54\text{mW}/5) * \sqrt{2.440}] = 0.17 < 3.0.$$

Note: When the minimum test separation distance is < 5 mm, a distance of 5 mm is applied to determine SAR test exclusion.
