


Fig.1 Photograph of the SAR measurement System




Fig.2.1 Photograph of the Tissue Simulant Fluid liquid depth 15cm for Flat (Body) Fig.2.2 Photograph of the Tissue Simulant Fluid liquid depth 15cm for Flat (Body)




Fig.3 Front side of EUT is paralleled with flat phantom and spacing between EUT and Phantom is 10mm.
