A peak to average ratio measurement is performed at the conducted port of the EUT. 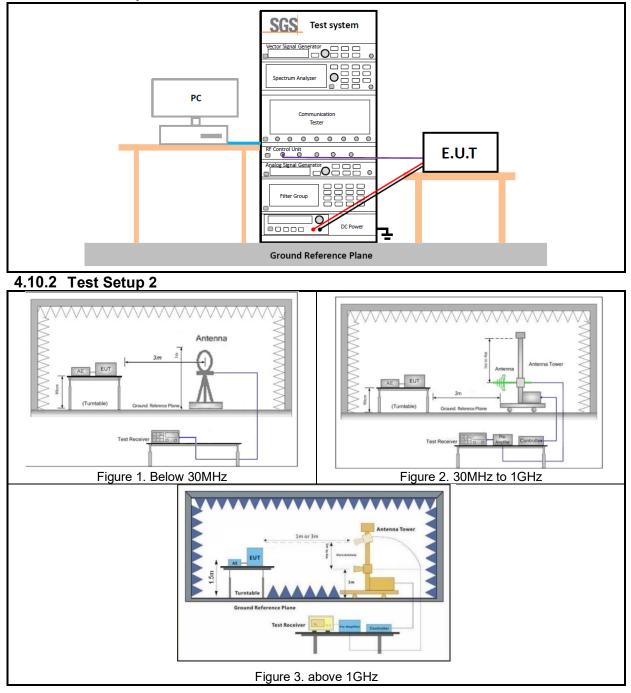
