However, the result indicates that compliance (non-compliance) is more probable than non-compliance) with the specification limit.







### 20dB Bandwidth (CH Low)




Transmit Freq Error 181.722 kHz x dB Bandwidth 219.865 kHz

#### 20dB Bandwidth (CH Mid)




Transmit Freq Error 197.207 kHz x dB Bandwidth 222.905 kHz




# **Detector mode: Average**




# **Band Edges (CH-High)**





### 6.5 FREQUENCY SEPARATION




# Test Configuration Below 30MHz


