Please be aware that the photo request is consistent with of 47 CFR 2.1033(c)(12) and KDB Publication 726920 D02.

The client is aware that External Photos and Test Setup Photos (which are not required for Parts 22/24/90 anyway) are not normally held for long term confidentiality. Due to the sensitive nature of the applicant's equipment, they require this sort of confidentiality, which is why the application is going through the FCC Direct Filing System rather than TCB (TCBs cannot mark these items confidentiality and obtain the grant without errors on the database). Previous applications were granted this way. Mr. Bruce Romano is aware of the situation.

The External Photos were marked for short term confidentiality because it was the only way that it could be uploaded. It was understood that the FCC would manually change this on their end upon completing the grant.

It is correct that Short Term confidentiality does not apply to this application, however, the items that are not normally held for confidentiality long term could not be properly marked as such without causing errors during the upload process. The FCC changes these to long term confidentiality manually upon

completing the grant.
