

4 RADIATED SPURIOUS EMISSIONS MEASUREMENT

4.1 LIMIT

The power of any emission outside of the authorized operating frequency ranges must be attenuated below the transmitting power (P) by a factor of at least 43 + 10 log(P) dB. The emission limit equal to -13dBm.

NOTE:

- (1) The measurements of emission power can be expressed in peak or average values, provided they are expressed in the same parameters as the transmitter power.


