## 1 Introduction

This document defines the FC908A and describes its air interfaces and hardware interfaces which are connected with your application.

This document can help you quickly understand module interface specifications, electrical and mechanical details, as well as other related information of the module. Associated with application notes and user guides, you can use FC908A to design and set up applications easily.

This equipment has been tested and found to comply with the limits for a Class B digital device, pursuant to Part 15 of the FCC Rules. These limits are designed to provide reasonable protection against harmful interference in a residential installation. This equipment generates, uses and can radiate radio frequency energy and, if not installed and used in accordance with the instructions, may cause harmful interference to radio communications. However, there is no guarantee that interference will not occur in a particular installation.

If this equipment does cause harmful interference to radio or television reception, which can be determined by turning the equipment off and on, the user is encouraged to try to correct the interference by one or more of the following measures:

- -- Reorient or relocate the receiving antenna.
- -- Increase the separation between the equipment and receiver.
- -- Connect the equipment into an outlet on a circuit different from that to which the receiver is connected.
- -- Consult the dealer or an experienced radio/TV technician for help.

This device complies with FCC radiation exposure limits set forth for an uncontrolled environment. In order to avoid the possibility of exceeding the FCC radio frequency exposure limits, human proximity to the antenna shall not be less than 20cm (8 inches) during normal operation.

- 2. This module is limited to installation in fixed applications, according to Part 2.1091(b).
- 3. The separate approval is required for all other operating configurations, including portable configurations with respect to Part 2.1093 and different antenna configurations



4. For FCC Part 15.31 (h) and (k): The host manufacturer is responsible for additional testing to verify compliance as a composite system. When testing the host device for compliance with Part

15 Subpart B, the host manufacturer is required to show compliance with Part 15 Subpart B while the transmitter module(s) are installed and operating. The modules should be transmitting and the evaluation should confirm that the module's intentional emissions are compliant (i.e. fundamental and out of band emissions). The host manufacturer must verify that there are no additional unintentional emissions other than what is permitted in Part 15 Subpart B or emissions are complaint with the transmitter(s) rule(s).

When the module is installed in the host device, the FCC/IC ID label must be visible through a window on the final device or it must be visible when an access panel, door or cover is easily re-moved. If not, a second label must be placed on the outside of the final device that contains the following text: "Contains FCC ID: XMR202206FC908A"

The FCC ID can be used only when all FCC compliance requirements are met.

Antenna Installation

- (1) The antenna must be installed such that 20 cm is maintained between the antenna and users,
- (2) The transmitter module may not be co-located with any other transmitter or antenna.
- (3) Only antennas of the same type and with equal or less gains as shown below may be used with this module. Other types of antennas and/or higher gain antennas may require additional authorization for operation.
  - (4) The max allowed antenna gain is 0.52 dBi for external antenna.

In the event that these conditions cannot be met (for example certain laptop configurations or co-location with another transmitter), then the FCC authorization is no longer considered valid and the FCC ID/IC ID cannot be used on the final product. In these circumstances, the OEM integrator will be responsible for re-evaluating the end product (including the transmitter) and obtaining a separate FCC/IC authorization.

## **2** Product Overview

## 2.1. General Description

FC908A is a Wi-Fi and Bluetooth module with low power consumption. It is a single-die WLAN (Wireless Local Area Network) and Bluetooth combo solution supporting IEEE 802.11b/g/n 2.4 GHz WLAN standards and Bluetooth 5.1 standard which enables seamless integration of WLAN and Bluetooth low energy technologies.

With a SDIO 2.0 interface for WLAN, a UART and a PCM interface for Bluetooth, FC908A can provide WLAN and Bluetooth functions.




Figure 1: Pin Assignment (Top View)

The FC908A is powered by VBAT. It is recommended to use a power chip with a maximum output current of more than 0.5 A. To ensure better power supply performance, it is recommended to parallel 100  $\mu$ F decoupling capacitors and 1  $\mu$ F and 100 nF filter capacitors near the input of the module VBAT. Meanwhile, it is recommended to add a TVS tube near the VBAT input terminal to improve the surge voltage bearing capacity of the module. In principle, the longer the VBAT line, the wider the line.

When paired with LTE, it is recommended to use 10 pF and 33 pF for C2/C4. The reference circuit of VBAT input terminal is as shown in the figure below:




Figure 2: VBAT Circuit




Figure 3: Power-up Timing

VIN\_LDO\_OUT/VIN\_LDO is the output and input pins of the buck circuit inside the module, and pin 20 is the dedicated GND pin of the buck circuit. Because the buck circuit is prone to high-frequency noise, special attention shall be paid to it. It is recommended to use 2.2  $\mu$ H inductors such as TFM201610ALM-2R2MTAA (TDK) and 4.7  $\mu$ F capacitors to ensure that the traces are as short as possible and the trace width shall not be less than 0.4mm. At the same time, it is recommended to route the wires away from sensitive signals.




Figure 4: Recommended Reference Design Circuit





To ensure that the interface design complies with the SDIO 2.0 specification, the following principles are recommended to be adopted:

- Route the SDIO traces in inner-layer of the PCB and the impedance is controlled at 50  $\Omega$  ±10 %.
- SDIO signals need to be keep away from sensitive signals, such as radio frequency, analog signals, clocks, and DC-DC noise signals.
- SDIO\_DATA 2 requires an external 10 k $\Omega$  resistor to be pulled up to VDDIO, and maintains a high level during the process of powering on the FC908A.
- SDIO signal traces need to be treated with equal length (the distance between the traces is less than 1 mm).
- The distance between SDIO signals and other signals must be greater than 2 times the trace width, and the busload capacitance must be less than 15 pF.

The maximum length of the internal wiring of the SDIO module is 5.71 mm.



### 3.5.2. WLAN\_EN

WLAN\_EN is used to control the WLAN function of the module. Wi-Fi function will be enabled when WLAN\_EN is at high level.




Figure 7: Block Diagram of Bluetooth Application Interface Connection




Figure 8: Reference Design for UART Interface Connection




Figure 9: PCM Interface Connection

#### 3.8.3. Reference Design

FC908Amodule provides an RF antenna pin for Wi-Fi/Bluetooth antenna connection. The RF trace in host PCB connected to the module's RF antenna pin shall be microstrip line or other types of RF trace, with characteristic impendence close to 50  $\Omega$ . FC908A comes with grounding pins which are next to the antenna pin in order to give a better grounding.

A reference circuit for the RF antenna interface is shown below. It is recommended to reserve a LC and Π-type matching circuit for better RF performance, and it is also recommended to reserve an ESD protection component. Matching components such as C1, R1, L2, L3, L4 and the protection component D1 shall be placed as close to the antenna as possible. The NM in the figure below is not attached by default.






Figure 10: Reference Design

### 3.8.4. Reference Design of RF Routing

For user's PCB, the characteristic impedance of all RF traces shall be controlled to  $50~\Omega$ . The impedance of the RF traces is usually determined by the trace width (W), the materials' dielectric constant, the height from the reference ground to the signal layer (H), and the spacing between RF traces and grounds (S). Microstrip or coplanar waveguide is typically used in RF layout to control characteristic impedance. The following are reference designs of microstrip or coplanar waveguide with different PCB structures.




Figure 11: Microstrip Design on a 2-layer PCB




Figure 12: Coplanar Waveguide Design on a 2-layer PCB






Figure 13: Coplanar Waveguide Design on a 4-layer PCB (Layer 3 as Reference Ground)




Figure 14: Coplanar Waveguide Design on a 4-layer PCB (Layer 4 as Reference Ground)

To ensure RF performance and reliability, the following principles shall be complied with RF layout design:

- Use impedance simulation tool to control the characteristic impedance of RF traces to 50 Ω.
- The GND pins adjacent to RF pins shall not be designed as thermal relief pins, and shall be fully connected to ground.
- The distance between the RF pins and the RF connector shall be as short as possible, and all the right-angle traces shall be changed to curved ones. The recommended trace angle is 135°.
- There shall be clearance area under the signal pin of the antenna connector or solder joint.
- The reference ground of RF traces shall be complete. Meanwhile, adding some ground vias around RF traces and the reference ground could help to improve RF performance. The distance between the ground vias and RF traces shall be no less than two times the width of RF signal traces (2 x W).
- Keep RF traces away from interference sources, and avoid intersection and paralleling between traces on adjacent layers.




Figure 15: Dimensions of the U.FL-R-SMT Connector (Unit: mm)




Figure 16: Mechanicals of U.FL-LP Connectors




Figure 17: Space Factor of Mated Connector (Unit: mm)




Figure 18: Top and Side Dimensions (Top and Side View)






Figure 19: Bottom Dimension (Top View)




Figure 20: Recommended Footprint (Top View)




Figure 21: Top and Bottom Views of the Module

# **6** Storage, Manufacturing & Packaging

### 6.1. Storage Conditions

The module is provided with vacuum-sealed packaging. MSL of the module is rated as 3. The storage requirements are shown below.

- 1. Recommended Storage Condition: The temperature shall be 23 ±5 °C and the relative humidity shall be 35–60 %.
- 2. The storage life (in vacuum-sealed packaging) is 12 months in Recommended Storage Condition.
- 3. The floor life of the module is 168 hours <sup>4</sup> in a plant where the temperature is 23 ±5 °C and relative humidity is below 60 %. After the vacuum-sealed packaging is removed, the module must be processed in reflow soldering or other high-temperature operations within 24 hours. Otherwise, the module shall be stored in an environment where the relative humidity is less than 10 % (e.g. a drying cabinet).
- 4. The module shall be pre-baked to avoid blistering, cracks and inner-layer separation in PCB under the following circumstances:
  - The module is not stored in Recommended Storage Condition;
  - Violation of the third requirement above occurs;
  - Vacuum-sealed packaging is broken, or the packaging has been removed for over 24 hours;
  - Before module repairing.
- 5. If needed, the pre-baking shall follow the requirements below:
  - The module shall be baked for 8 hours at 120 ±5 °C;
  - All modules must be soldered to PCB within 24 hours after the baking, otherwise they shall be put
    in a dry environment such as in a drying oven.

<sup>&</sup>lt;sup>4</sup> This floor life is only applicable when the environment conforms to *IPC/JEDEC J-STD-033*. It is recommended to start the solder reflow process within 24 hours after the package is removed if the temperature and moisture do not conform to, or are not sure to conform to *IPC/JEDEC J-STD-033*. And do not remove the packages of tremendous modules if they are not ready for soldering.



### NOTE

- 1. To avoid blistering, layer separation and other soldering issues, extended exposure of the module to the air is forbidden.
- 2. Take out the module from the package and put it on high-temperature-resistant fixtures before baking. All modules must be soldered to PCB within 24 hours after the baking, otherwise put them in the drying oven. If shorter baking time is desired, see *IPC/JEDEC J-STD-033* for the baking procedure.
- 3. Pay attention to ESD protection, such as wearing anti-static gloves, when touching the modules.

### 6.2. Manufacturing and Soldering

Push the squeegee to apply the solder paste on the surface of stencil, thus making the paste fill the stencil openings and then penetrate to the PCB. The force on the squeegee shall be adjusted properly to produce a clean stencil surface on a single pass. To ensure the module soldering quality, the thickness of stencil for the module is recommended to be 0.15–0.18mm. For more details, see **document [3]**.

The peak reflow temperature shall be 235–246 °C, with 246 °C as the absolute maximum reflow temperature. To avoid damage to the module caused by repeated heating, it is strongly recommended that the module shall be mounted only after reflow soldering for the other side of PCB has been completed. The recommended reflow soldering thermal profile (lead-free reflow soldering) and related parameters are shown below.




Figure 22: Recommended Reflow Soldering Thermal Profile

### **NOTE**

- 1. During manufacturing and soldering, or any other processes that may contact the module directly, NEVER wipe the module's shielding can with organic solvents, such as acetone, ethyl alcohol, isopropyl alcohol, trichloroethylene, etc. Otherwise, the shielding can may become rusted.
- 2. The shielding can for the module is made of Cupro-Nickel base material. It is tested that after 12 hours' Neutral Salt Spray test, the laser engraved label information on the shielding can is still clearly identifiable and the QR code is still readable, although white rust may be found.
- 3. If a conformal coating is necessary for the module, do NOT use any coating material that may chemically react with the PCB or shielding cover, and prevent the coating material from flowing into the module.
- 4. Avoid using ultrasonic technology for module cleaning since it can damage crystals inside the module.
- 5. Due to the complexity of the SMT process, please contact Quectel Technical Supports in advance for any situation that you are not sure about, or any process (e.g. selective soldering, ultrasonic soldering) that is not mentioned in *document* [3].




Figure 23: Carrier Tape Dimension Drawing





Figure 24: Plastic Reel Dimension Drawing




### 6.3.3. Packaging Process



Place the module into the carrier tape and use the cover tape to cover it; then wind the heat-sealed carrier tape to the plastic reel and use the protective tape for protection. 1 plastic reel can load 500 modules.

Place the packaged plastic reel, humidity indicator card and desiccant bag into a vacuum bag, vacuumize it.





Place the vacuum-packed plastic reel into the pizza box.

Put 4 packaged pizza boxes into 1 carton and seal it. 1 carton can pack 2000 modules.




Figure 25: Packaging Process
