Band26-10MHz-QPSK-26740-1RB#0-Range2:0.15~30MHz

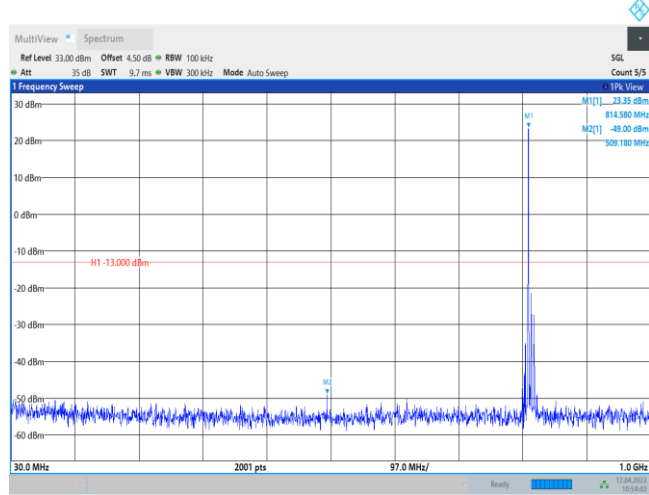

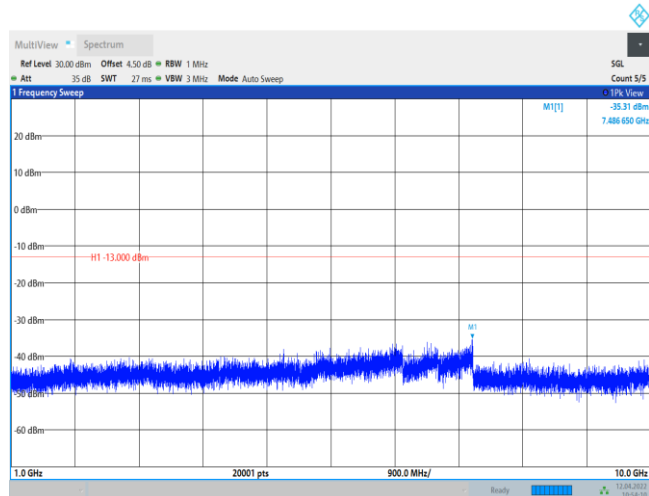
