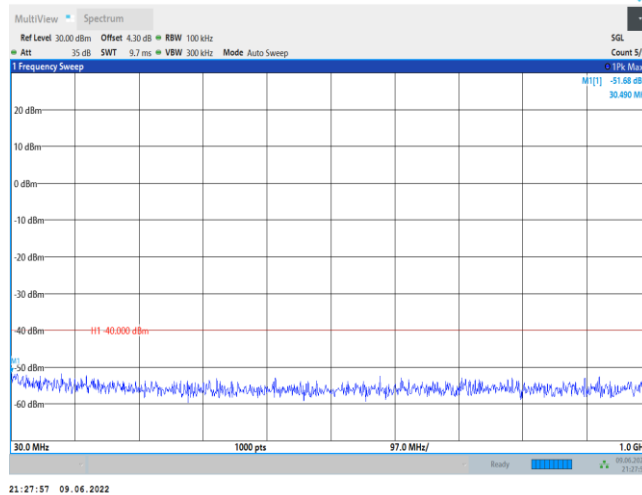
Band30-10MHz-QPSK-27710-1RB#0-Range2:0.15~30MHz

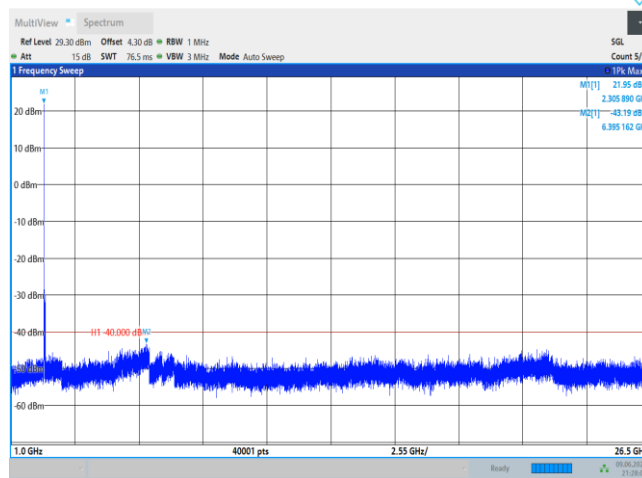
