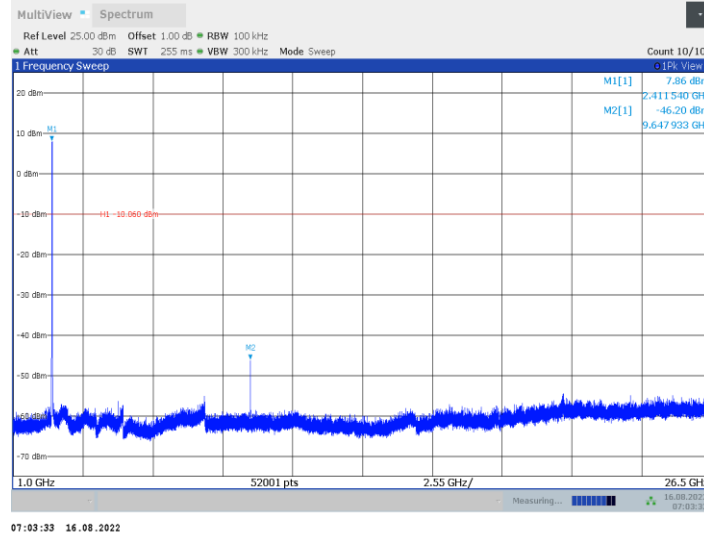
Conducted Spurious Emission Test Graphs



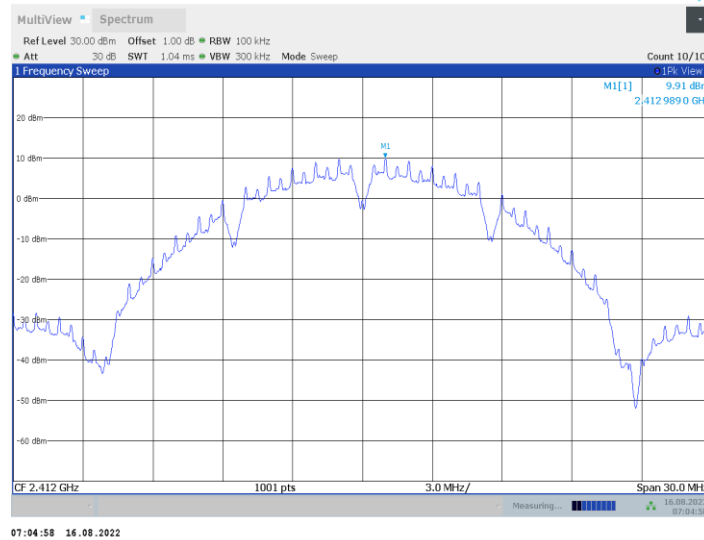
