The MPE was calculated at 20 cm to show compliance with the power density limit.

The following formula was used to calculate the Power Density:

$$S = \frac{PG}{4\pi R^2}$$

Where:

S = Power Density

P = Output Power at Antenna Terminals

G = Gain of Transmit Antenna (linear gain)

R = Distance from Transmitting Antenna

Note:

- For collocation analysis, LTE Band 13 is chosen for summation due to the highest (power density/limit) among all WWAN wireless modes.
- $\Sigma$ (Power Density / Limit): This is a summation of [(power density for each transmitter/antenna included in the simultaneous transmission) / (corresponding MPE limit)], for WWAN + Bluetooth or WLAN2.4GHz or WLAN5GHz.

Conclusion:

According to 47 CFR §2.1091, the RF exposure analysis concludes that the RF Exposure is FCC compliant.
