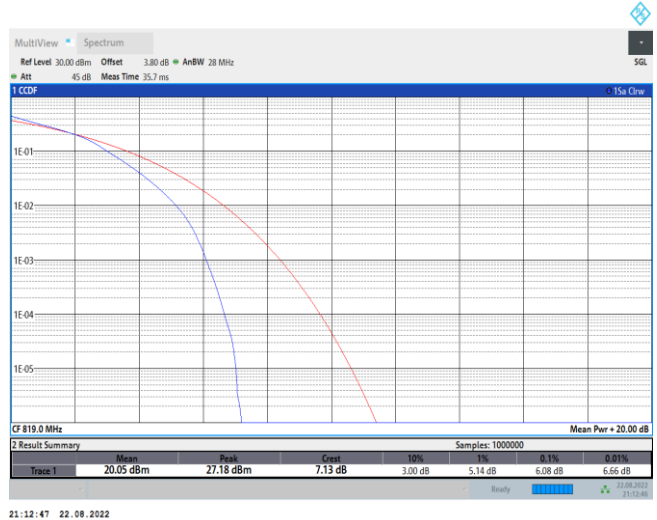

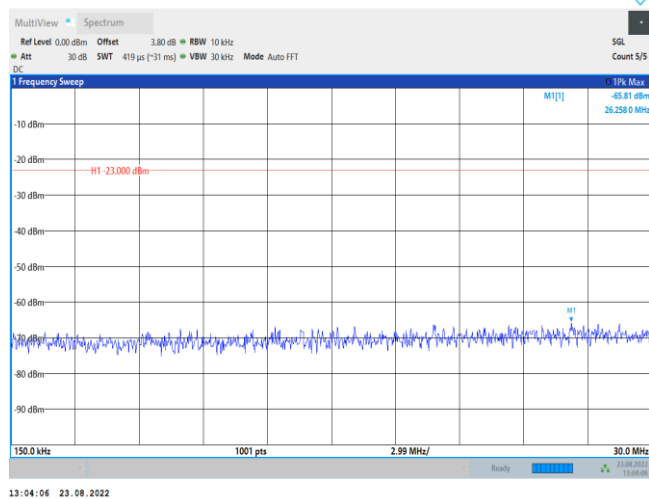

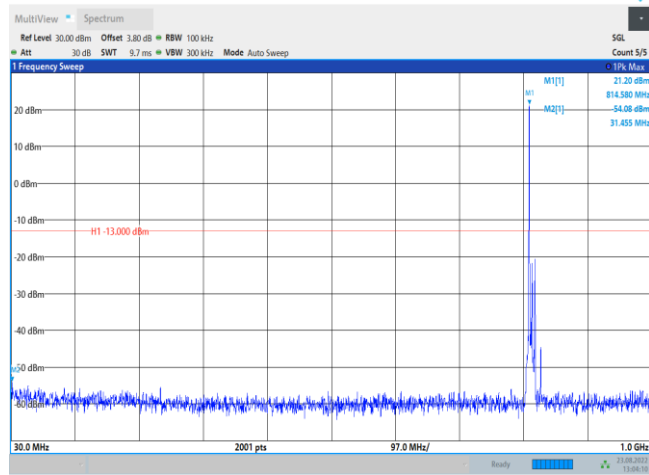
Band26-10MHz-QPSK-26740-1RB#0-Range1:0.009~0.15MHz



Band26-10MHz-QPSK-26740-1RB#0-Range2:0.15~30MHz

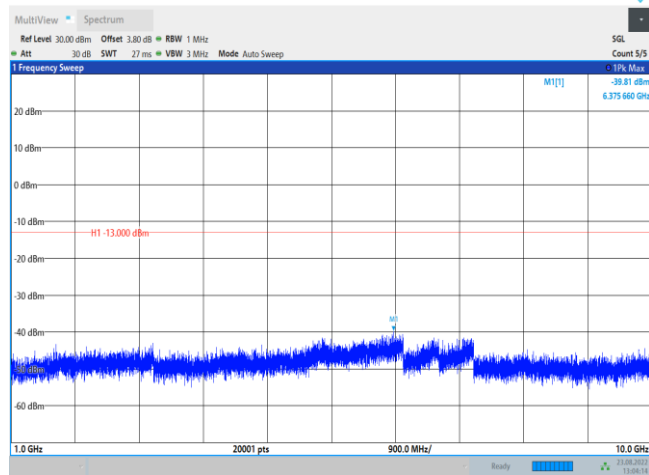


Band26-10MHz-QPSK-26740-1RB#0-Range3:30~1000MHz
