





4. MEASUREMENT UNCERTAINTY

Where relevant, the following test uncertainty levels have been estimated for tests performed on the EUT as specified in CISPR 16-4-2. This uncertainty represents an expanded uncertainty expressed at approximately the 95% confidence level using a coverage factor of k = 2.

Radiated Emission Measurement

Measurement Uncertainty for a Level of Confidence of 95% (U=2Uc(y)):

Horizontal: 9kHz~300MHz: 5.04dB

300MHz~1GHz: 4.95dB 1GHz~40GHz: 6.40dB

Vertical: 9kHz~300MHz: 5.24dB

300MHz~1GHz: 6.03dB 1GHz~40GHz: 6.40dB

Notes:

- The analyzer plots shown in this section were all taken with a correction table loaded into the analyzer.
 The correction table was used to account for the losses of the cables and attenuators used as part of the system to connect the EUT to the analyzer at all frequencies of interest.
- 2) Pre-Scan has been conducted to determine the worst-case mode from all possible combinations between available modulations the worst-case was found.
- 3) This report is based on the original application to change antenna and evaluate the radiated spurious emission.



5.2. Radiated Spurious Emissions Measurements

5.2.1.Test Limit

Out of band emissions: The power of any emission outside of the authorized operating frequency ranges must be lower than the transmitter power (P) by a factor of at least $70 + 10 \log (P) dB$. E $(dB\mu V/m) = EIRP (dBm) - 20 \log D + 104.8$; where D is the measurement distance in meters. The emission limit equal to $55.3dB\mu V/m$.


5.2.3.Test Setting

- 1. RBW = 1MHz
- 2. VBW≥ 3*RBW
- 3. Sweep time ≥ 10 × (number of points in sweep) × (transmission symbol period)
- 4. Detector = Peak
- 5. Trace mode = max hold
- 6. The trace was allowed to stabilize


