Radiated emission below 1GHz

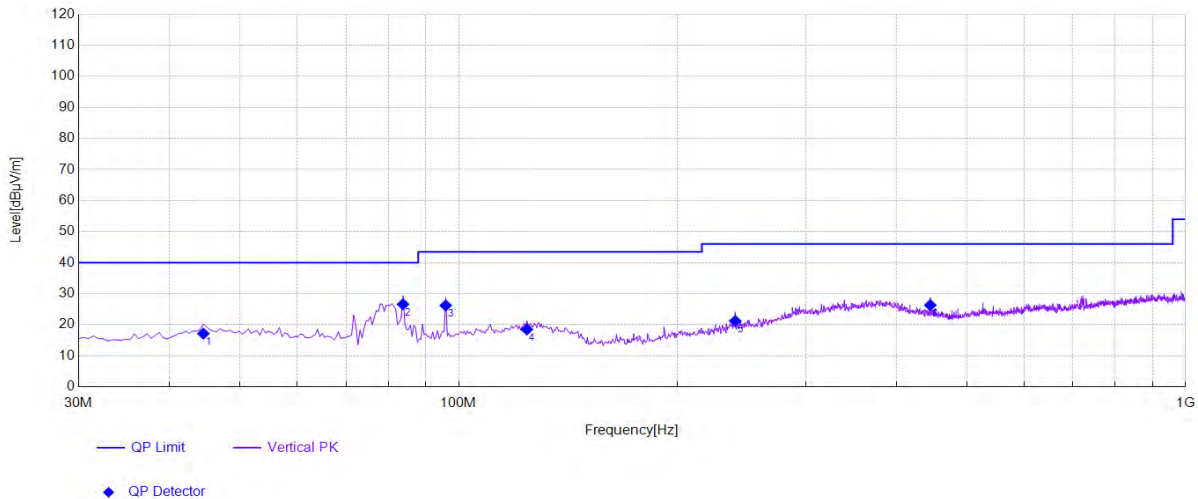
