Band26-1.4MHz-16QAM-26740-6RB#0



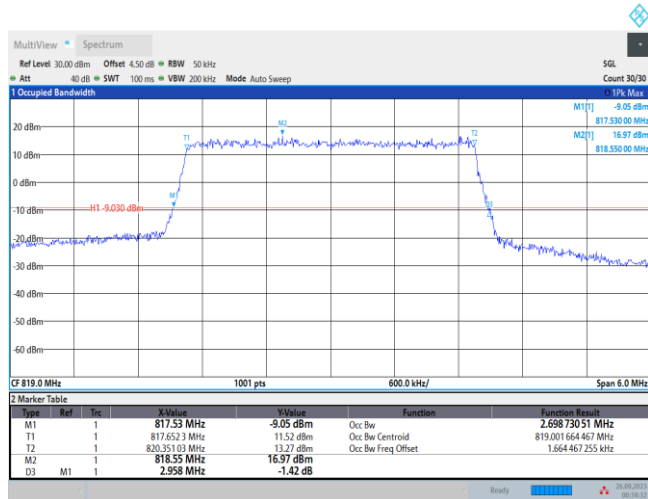
