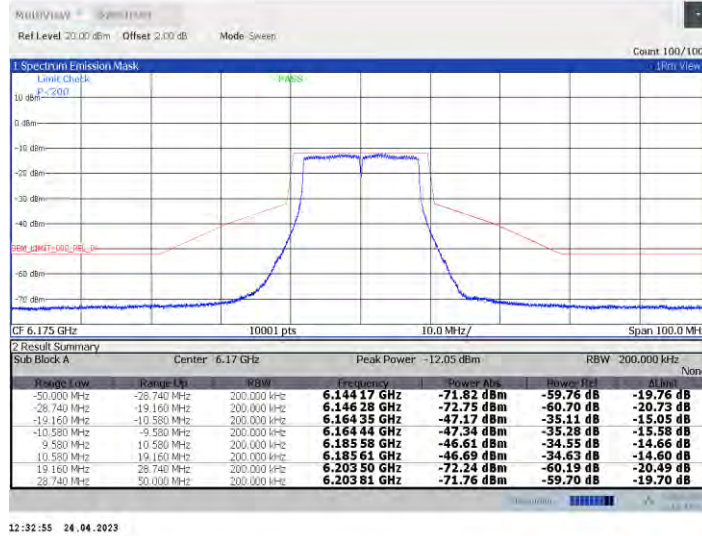
InBand Emissions Test Graphs



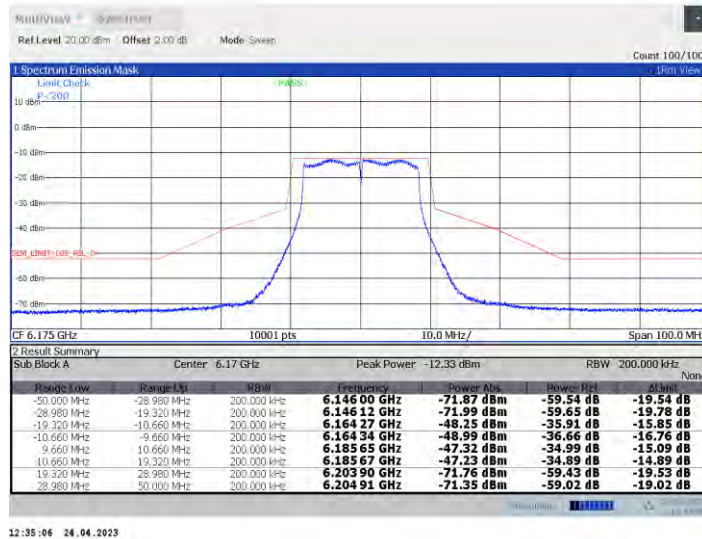
