



2.5 **EUT Operation Test Setup**

For FSK FHSS function, the engineering test program was provided and enabled to make EUT continuous transmit.

For AC power line conducted emissions, the EUT was set to connect with the WLAN AP under large package sizes transmission.

2.6 **Measurement Results Explanation Example**

For all conducted test items:

The offset level is set in the spectrum analyzer to compensate the RF cable loss and attenuator factor between EUT conducted output port and spectrum analyzer. With the offset compensation, the spectrum analyzer reading level is exactly the EUT RF output level.

Example:

The spectrum analyzer offset is derived from RF cable loss and attenuator factor.

Offset = RF cable loss + attenuator factor.

Following shows an offset computation example with cable loss 0.22 dB and 10dB attenuator.







Number of Hopping Channel Plot (Data Rate 50kbps)









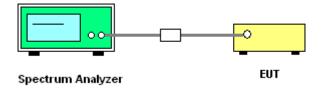









Channel Separation Plot on High CH






20 dB Bandwidth Plot on High Channel


99% Occupied Bandwidth Plot on High Channel


For radiated emissions below 30MHz


