#### 1. RF EXPOSURE

# 1.1. The Requirement

System operating under the provisions of this section shall be operated in a manner that ensures that the public is not exposed to radio frequency energy levels in excess of the Commission's guidelines. See Section 15.247(b)(4) and Section 1.1307(b)(1)

#### 1.3.MPE Calculations

$$E(V/m) = \ \frac{\sqrt{30 \times P \times G}}{d} \, ,$$

Power Density: 
$$S(mW/cm^2) = \frac{E^2}{377}$$

Where

E = Electric Field (V/m)

P = Peak Output Power (mW)

G = Antenna Numeric Gain (numeric) =  $10^x$ , x = Antenna Gain(dBi) /10

d = Separation Distance (cm)

We can change the formula to:

$$S = \frac{30 \times P \times G}{377 \times d^2} \text{ or, } d = \sqrt{\frac{30 \times P \times G}{377 \times S}}$$

Because the EUT is belong to general population/uncontrolled exposure. So

1.3.1. We considering the limit of minimum separation distance (d) is 20cm,

Maximum Output Power = 
$$1.01 \text{mW}$$
  
Antenna Gain =  $3(\text{dBi}) = 2 \text{ (numeric)}$   

$$S = \frac{30 \times P \times G}{377 \times d^2} = 4.0*10^{-4} \text{ mW/cm}^2 < 1.0 \text{ mW/cm}^2 \text{ (limit)}$$

Calculated RF Exposure power density is  $4.0*10^{-4}\,\text{mW/cm}^2$ , less than the limit.

1.3.2. We considering the limit of power density (S) is 1.0 mW/cm<sup>2</sup>,

Maximum Output Power = 1.01mW  
Antenna Gain = 3(dBi) = 2 (numeric)  

$$d = \sqrt{\frac{30 \times P \times G}{377 \times S}} = 0.16 \text{ cm} < 20 \text{ cm}$$

Calculated RF Exposure separation distance is 0.16 cm, less than the minimum separation distance

### 1.3.3.FCC Radiation Exposure Statement
