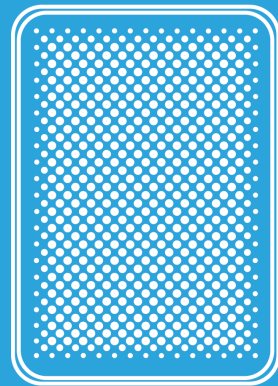

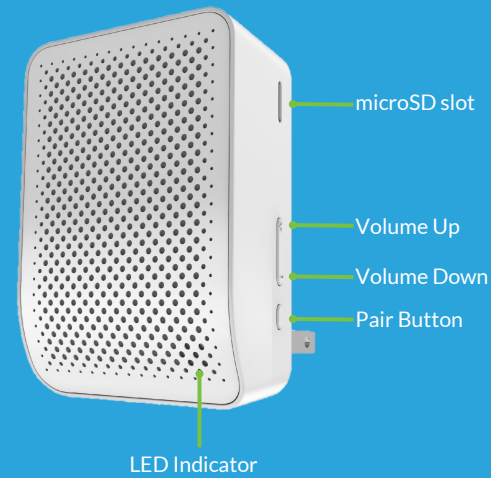

2. Pair your ClearSky CHIME+SIREN with your ClearSky Bridge

1. Press the learn button on the back of the ClearSky Bridge.
2. Plug the Chime+Siren into the AC outlet.
3. Once your ClearSky Chime+Siren is successfully paired, it will blink a green LED and play a chime sound.
