### Product Description for Equipment under Test (EUT)

The *LiveFree Emergency Response, Inc.*'s product, model number: *EZcare Plus (FCC ID: XTX-EZC)* or the "EUT" in this report was a *Fixed Wireless Phone named as Ezc*, which was measured approximately: 21.0 cm (L) x 14.0 cm (W) x 3.5 cm (H), rated with input voltage: DC 7.4 V rechargeable Li-ion battery or DC9.0 V from adapter.

### Objective

This test report is prepared on behalf of *LiveFree Emergency Response, Inc.* in accordance with Part 2-Subpart J, Part 22-Subpart H and Part 24-Subpart E of the Federal Communication Commissions rules.

The objective is to determine the compliance of the EUT with FCC rules for output power, modulation characteristic, occupied bandwidth, and spurious emission at antenna terminal, spurious radiated emission, frequency stability and band edge.

### Test Methodology

All tests and measurements indicated in this document were performed in accordance with the Code of Federal Regulations Title 47 Part 2-Subpart J as well as the following parts:

Part 22 Subpart H - Public Mobile Services

Part 24 Subpart E - Personal Communication Services

Applicable Standards: TIA/EIA 603-D, ANSI C63.4-2009.

All radiated and conducted emissions measurements were performed at Bay Area Compliance Laboratories Corp. The radiated testing was performed at an antenna-to-EUT distance of 3 meters.

Measurement uncertainty with radiated emission is 5.91 dB for 30MHz-1GHz.and 4.92 dB for above 1GHz, 1.95dB for conducted measurement.

## **Test Facility**

The test site used by Bay Area Compliance Laboratories Corp.(Shenzhen) to collect test data is located on the 6/F, the 3rd Phase of WanLi Industrial Building, ShiHua Road, FuTian Free Trade Zone Shenzhen, Guangdong, China.

Test site at Bay Area Compliance Laboratories Corp. (Shenzhen) has been fully described in reports submitted to the Federal Communication Commission (FCC). The details of these reports have been found to be in compliance with the requirements of Section 2.948 of the FCC Rules on December 06, 2010. The facility also complies with the radiated and AC line conducted test site criteria set forth in ANSI C63.4-2009.

The Federal Communications Commission has the reports on file and is listed under FCC Registration No.: 382179. The test site has been approved by the FCC for public use and is listed in the FCC Public Access Link (PAL) database.

No modification was made to the EUT.

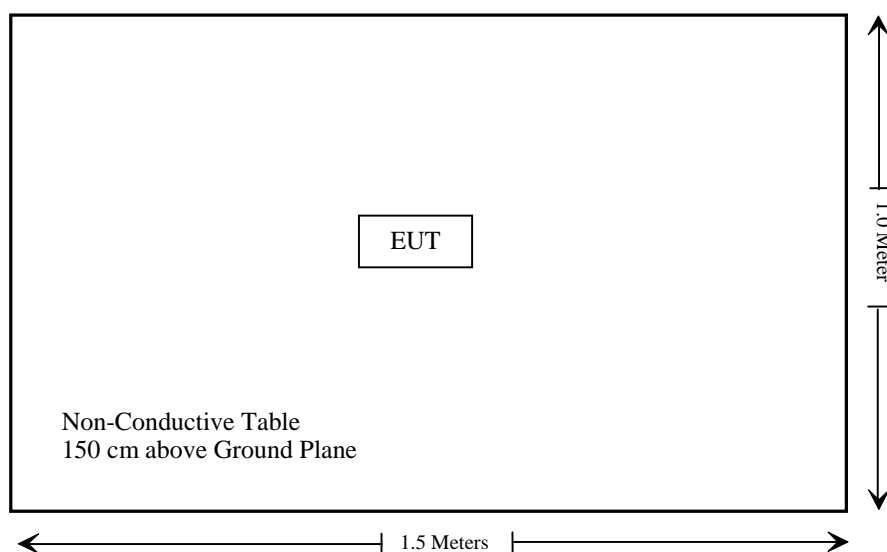
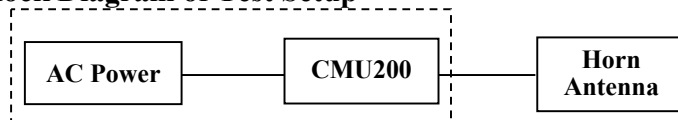

### Test Data

P = power input to the antenna (in appropriate units, e.g., mW).

G = power gain of the antenna in the direction of interest relative to an isotropic radiator, the power gain factor, is normally **numeric** gain.

R = distance to the center of radiation of the antenna (appropriate units, e.g., cm)

According to FCC § 2.1047(d), Part 22H & 24E there is no specific requirement for digital modulation, therefore modulation characteristic is not presented.



**FCC §2.1053, §22.917 & §24.238 - SPURIOUS RADIATED EMISSIONS****Applicable Standard**

**Test Procedure**

The transmitter was placed on a wooden turntable, and it was transmitting into a non-radiating load which was also placed on the turntable.

The measurement antenna was placed at a distance of 3 meters from the EUT. During the tests, the receiving antenna height and polarization as well as EUT azimuth were varied in order to identify the maximum level of emissions from the EUT. The test was performed by placing the EUT on 3-orthogonal axis.

The frequency range up to tenth harmonic of the fundamental frequency was investigated.

Remove the EUT and replace it with substitution antenna. A signal generator was connected to the substitution antenna by a non-radiating cable. The absolute levels of the spurious emissions were measured by the substitution.

Spurious emissions in dB = 10 lg (TXpwr in Watts/0.001) – the absolute level

Spurious attenuation limit in dB = 43 + 10 Log<sub>10</sub> (power out in Watts)
