3. TEST METHODOLOGY

Both conducted and radiated testing was performed according to the procedures in ANSI C63.4. Radiated testing was performed at an antenna to EUT distance 3 meters.

3.1 EUT CONFIGURATION

The EUT configuration for testing is installed for RF field strength measurement to meet the Commissions requirement, and is operated in a manner intended to generate the maximum emission in a continuous normal application.

3.2 EUT EXERCISE

The EUT is operated in the engineering mode to fix the Tx frequency for the purposes of measurement.

According to its specifications, the EUT must comply with the requirements of Section 15.407 under the FCC Rules Part 15 Subpart E.

3.3 GENERAL TEST PROCEDURES

Conducted Emissions

The EUT is placed on the turntable, which is positioned at 0.8 m above the ground plane. According to the requirements in Section 13.1.4.1 of ANSI C63.4, the conducted emission from the EUT is measured in the frequency range between 0.15 MHz and 30MHz, using the CISPR Quasi-Peak detector mode.

Radiated Emissions

The EUT is placed on the turntable, which is 0.8 m above the ground plane. The turntable is then rotated for 360 degrees to determine the proper orientation for the maximum emission level. The EUT is set 3m away from the receiving antenna, which is varied from 1m to 4m to find out the highest emission level. And, each emission is to be maximized by changing the horizontal and vertical polarization of the receiving antenna. In order to find out the maximum emissions, exploratory radiated emission measurements were made according to the requirements in Section 13.1.4.1 of ANSI C63.4.

(b) Except as provided in paragraphs (d) and (e), the field strength of emissions appearing within these frequency bands shall not exceed the limits shown in Section 15.209. At frequencies equal to or less than 1000 MHz, compliance with the limits in Section 15.209 shall be demonstrated using measurement instrumentation employing a CISPR quasi-peak detector. Above 1000 MHz, compliance with the emission limits in Section 15.209 shall be demonstrated based on the average value of the measured emissions. The provisions in Section 15.35 apply to these measurements.



3.5 DESCRIPTION OF TEST MODES

The EUT (model: TEW-680MB) had been tested under operating condition.

The EUT is a 3x3 configuration spatial MIMO (3Tx & 3Rx) without beam forming function that operate in triple TX chains and triple RX chains. The 3x3 configuration is implemented with three outside TX & RX chains (Chain 0, Chain 1 and Chain 2).

Software used to control the EUT for staying in continuous transmitting mode was programmed.

After verification, all tests were carried out with the worst case test modes as shown below except radiated spurious emission below 1GHz and power line conducted emissions below 30MHz, which worst case was in normal link mode only.

IEEE 802.11a mode / 5180 ~ 5240MHz:

Channel Low (5180MHz), Channel Mid (5220MHz) and Channel High (5240MHz) with 6Mbps data rate were chosen for full testing.

IEEE 802.11n HT 20 MHz mode / 5180 ~ 5240MHz:

Channel Low (5180MHz), Channel Mid (5220MHz) and Channel High (5240MHz) with 6.5Mbps data rate were chosen for full testing.

IEEE 802.11n HT 40 MHz mode / 5190 ~ 5230MHz:

Channel Low (5190MHz) and Channel High (5230MHz) with 13.5Mbps data rate were chosen for full testing.



4. INSTRUMENT CALIBRATION

4.1 MEASURING INSTRUMENT CALIBRATION

The measuring equipment, which was utilized in performing the tests documented herein, has been calibrated in accordance with the manufacturer's recommendations for utilizing calibration equipment, which is traceable to recognized national standards.

4.2 MEASUREMENT EQUIPMENT USED

5.2 EQUIPMENT

Radiated emissions are measured with one or more of the following types of linearly polarized antennas: tuned dipole, biconical, log periodic, bi-log, and/or ridged waveguide, horn. Spectrum analyzers with pre-selectors and quasi-peak detectors are used to perform radiated measurements.




Conducted emissions are measured with Line Impedance Stabilization Networks and EMI Test Receivers.

Calibrated wideband preamplifiers, coaxial cables, and coaxial attenuators are also used for making measurements.

All receiving equipment conforms to CISPR Publication 16-1, "Radio Interference Measuring Apparatus and Measurement Methods."

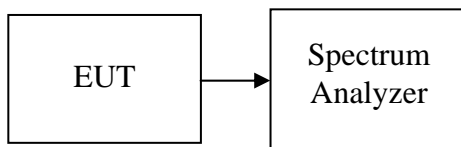
7. FCC PART 15 REQUIREMENTS

7.1 26 DB EMISSION BANDWIDTH

LIMIT

According to §15.303(c), for purposes of this subpart the emission bandwidth shall be determined by measuring the width of the signal between two points, one below the carrier center frequency and one above the carrier center frequency, that are 26 dB down relative to the maximum level of the modulated carrier. Compliance with the emissions limits is based on the use of measurement instrumentation employing a peak detector function with an instrument resolutions bandwidth approximately equal to 1.0 percent of the emission bandwidth of the device under measurement.

Test Configuration



TEST PROCEDURE

1. Place the EUT on the table and set it in the transmitting mode.
2. Remove the antenna from the EUT and then connect a low-loss RF cable from the antenna port to the spectrum analyzer.
3. Set the spectrum analyzer as RBW > 1%EBW, VBW > RBW, Span >26dB bandwidth, and Sweep = auto.
4. Mark the peak frequency and -26dB (upper and lower) frequency.
5. Repeat until all the rest channels were investigated.

7.2 PEAK POWER

LIMIT

According to §15.407(a),

- (1) For the band 5.15-5.25 GHz, the maximum conducted output power over the frequency band of operation shall not exceed the lesser of 50 mW or $4 \text{ dBm} + 10 \log B$, where B is the 26 dB emission bandwidth in MHz.
- (2) For the 5.25-5.35 GHz and 5.47-5.725 GHz bands, the maximum conducted output power over the frequency bands of operation shall not exceed the lesser of 250 mW or $11 \text{ dBm} + 10 \log B$, where B is the 26 dB emission bandwidth in MHz.

If transmitting antennas of directional gain greater than 6dBi are used, both the peak transmit power and the peak power spectral density shall be reduced by the amount in dB that the directional gain of the antenna exceeds 6dBi.

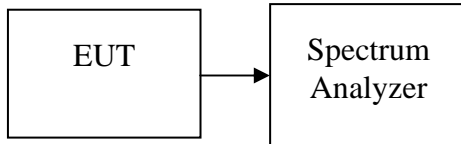

TEST PROCEDURE

Set span to encompass the entire emission bandwidth (EBW) of the signal.

Set RBW = 1 MHz / Set VBW = 3 MHz.

Use sample detector mode if bin width (i.e., span/number of points in spectrum display) < 0.5 RBW. Otherwise use peak detector mode. Use a video trigger with the trigger level set to enable triggering only on full power pulses. Transmitter must operate at full control power for entire sweep of every sweep. The 1 MHz band power levels to be summed can be obtained by averaging, in linear power terms, power levels in each frequency bin across the 1 MHz.

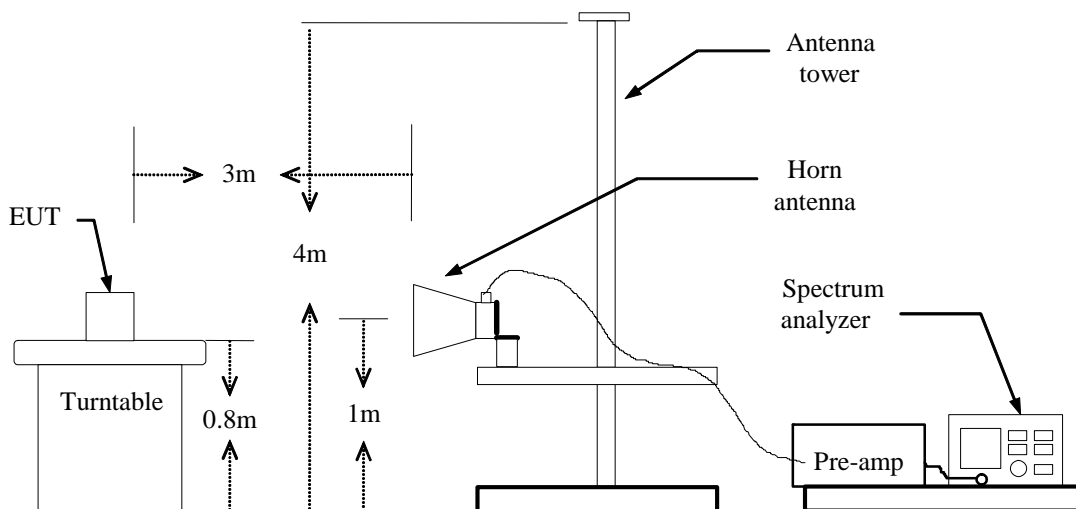
7.3 BAND EDGES MEASUREMENT

LIMIT

According to §15.407(b),

- (1) The provisions of Section 15.205 of this part apply to intentional radiators operating under this section.
- (2) When measuring the emission limits, the nominal carrier frequency shall be adjusted as close to the upper and lower frequency block edges as the design of the equipment permits.

5. Repeat the procedures until all the PEAK and AVERAGE versus POLARIZATION are measured.

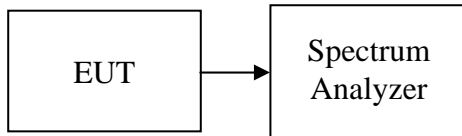


7.5 PEAK EXCURSION

TEST PROCEDURE

2. The turntable shall be rotated for 360 degrees to determine the position of maximum emission level.

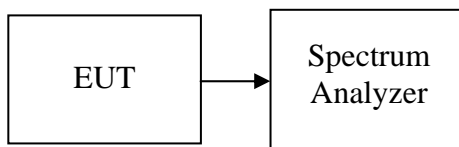

- (1) For transmitters operating in the 5.15-5.25 GHz band: all emissions outside of the 5.15-5.35 GHz band shall not exceed an EIRP of -27 dBm/MHz.
- (2) For transmitters operating in the 5.25-5.35 GHz band: all emissions outside of the 5.15-5.35 GHz band shall not exceed an EIRP of -27 dBm/MHz. Devices operating in the 5.25-5.35 GHz band that generate emissions in the 5.15-5.25 GHz band must meet all applicable technical requirements for operation in the 5.15-5.25 GHz band (including indoor use) or alternatively meet an out-of-band emission EIRP limit of -27 dBm/MHz in the 5.15-5.25 GHz band.

The provisions of §15.205 apply to intentional radiators operating under this section.

Conducted RF measurements of the transmitter output were made to confirm that the EUT antenna port conducted emissions meet the specified limit and to identify any spurious signals that require further investigation or measurements on the radiated emissions site.

The transmitter output is connected to the spectrum analyzer. The resolution bandwidth is set to 1 MHz. The video bandwidth is set to 1 MHz. Peak detection measurements are compared to the average EIRP limit, adjusted for the maximum antenna gain. If necessary, additional average detection measurements are made.

Measurements are made over the 30 MHz to 40 GHz range with the transmitter set to the lowest, middle, and highest channels.

7.8 POWERLINE CONDUCTED EMISSIONS

LIMIT

According to §15.207(a), except as shown in paragraphs (b) and (c) of this section, for an intentional radiator that is designed to be connected to the public utility (AC) power line, the radio frequency voltage that is conducted back onto the AC power line on any frequency or frequencies within the band 150 kHz to 30 MHz shall not exceed the limits in the following table, as measured using a 50 μ H/50 ohms line impedance stabilization network (LISN). Compliance with the provisions of this paragraph shall be based on the measurement of the radio frequency voltage between each power line and ground at the power terminal. The lower limit applies at the boundary between the frequency ranges.

1. The EUT was placed on a table, which is 0.8m above ground plane.
2. Maximum procedure was performed on the six highest emissions to ensure EUT compliance.
3. Repeat above procedures until all frequency measured were complete.

**test results**

The initial step in collecting conducted data is a spectrum analyzer peak scan of the measurement range. Significant peaks are then marked as shown on the following data page, and these signals are then quasi-peaked.

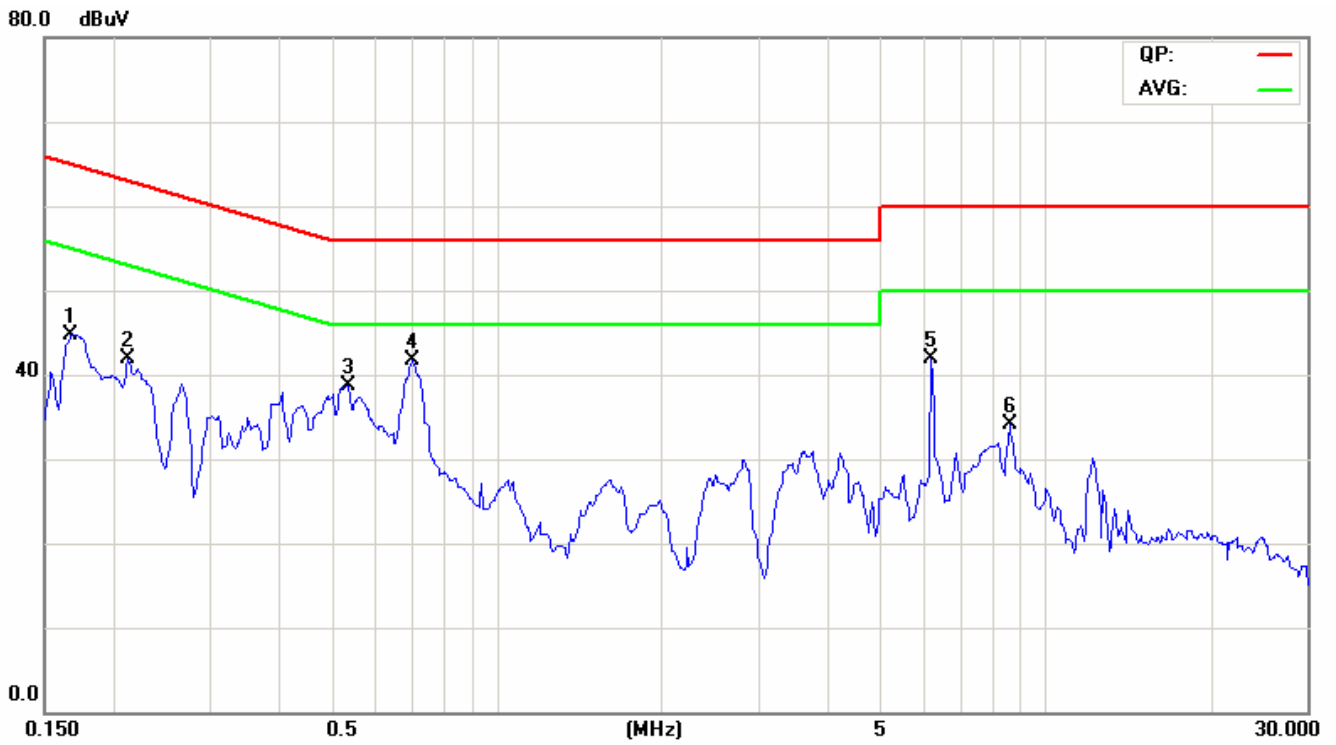

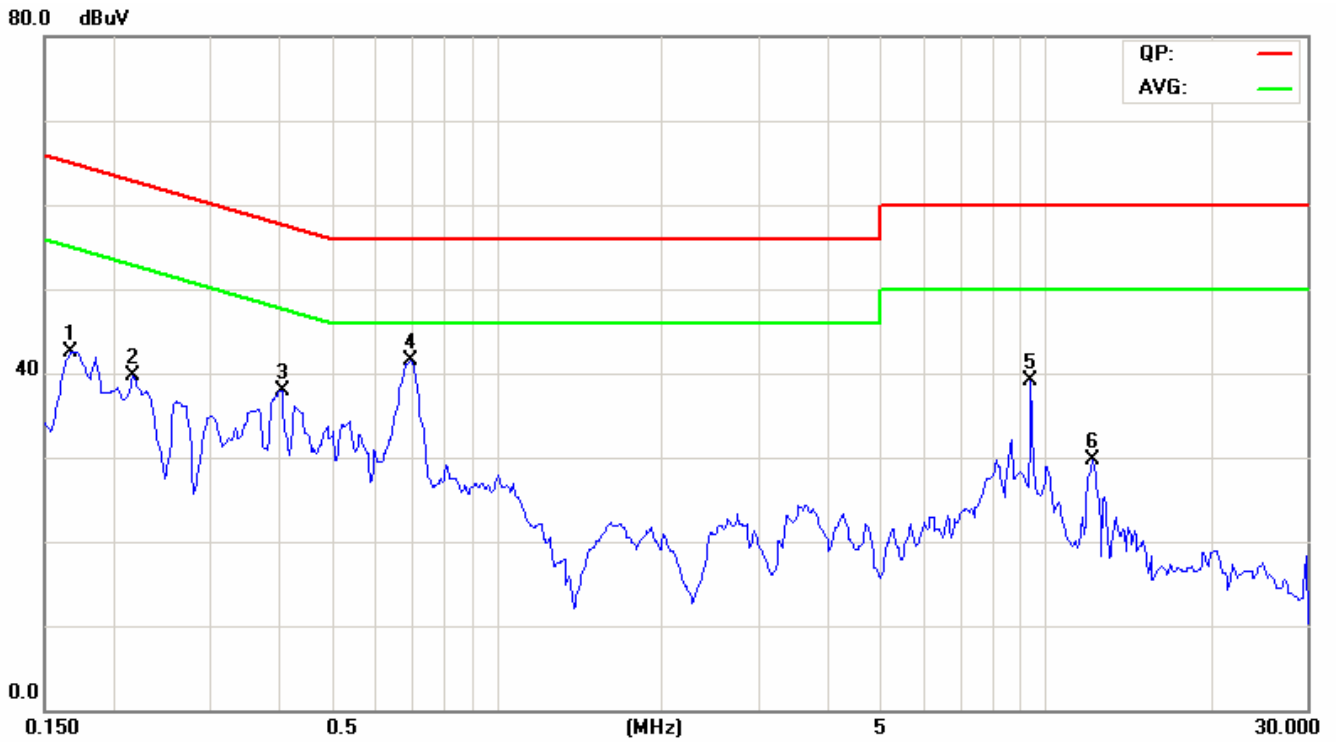


Test Plots

Conducted emissions (Line 2)



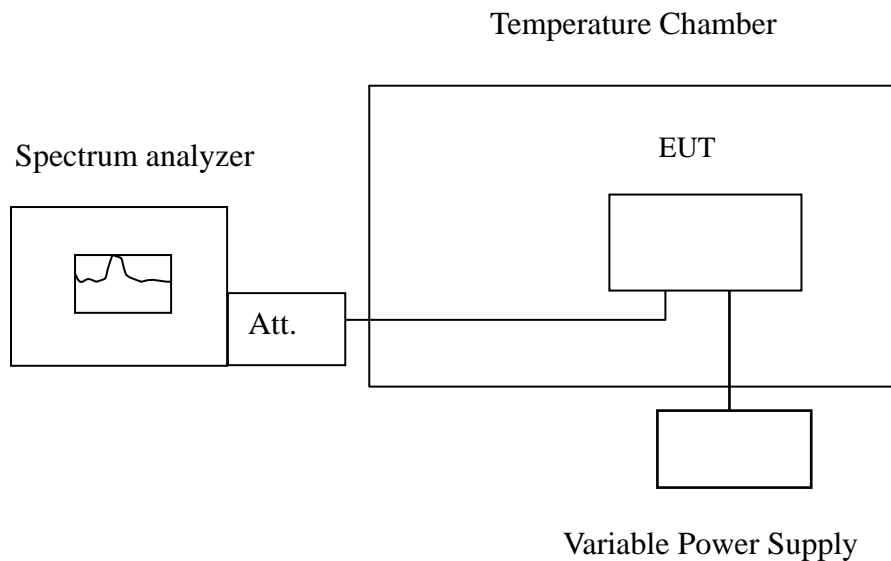


7.9 FREQUENCY STABILITY

LIMIT

TEST PROCEDURE

The equipment under test was connected to an external AC or DC power supply and input rated voltage. RF output was connected to a frequency counter or spectrum analyzer via feed through attenuators. The EUT was placed inside the temperature chamber. Set the spectrum analyzer RBW low enough to obtain the desired frequency resolution and measure EUT 20°C operating frequency as reference frequency. Turn EUT off and set the chamber temperature to -20°C. After the temperature stabilized for approximately 30 minutes recorded the frequency. Repeat step measure with 10°C increased per stage until the highest temperature of +50°C reached.
