### 2.2 MPE CALCULATION FORMULA

 $Pd = (Pout*G) / (4*pi*r^2)$ 

where

Pd = power density in mW/cm<sup>2</sup>

Pout = output power to antenna in mW

G = gain of antenna in linear scale

Pi = 3.1416

R = distance between observation point and center of the radiator in cm

## **CONCULSION:**

Both of the WLAN 2.4G & 5.0G can transmit simultaneously, the formula of calculated the MPE is:

CPD1 / LPD1 + CPD2 / LPD2 + .....etc. < 1

CPD = Calculation power density

LPD = Limit of power density

1. WLAN 2.4G + WLAN 5.0G = 0.222 + 0.271 = 0.493

Therefore, the maximum calculation of this situation is 0.493, which is less than the "1" limit.
