1.1 Overview of Type I Bullet Camera




Figure 1-1 Type I Bullet Camera




Figure 1-2 Type II Bullet Camera

1.2.1 Micro SD Card Slot & Reset/ WPS Button

Move the Micro SD / Reset/WPS Cover aside, and you can see the Reset button, WPS button and the micro SD card slot.




Figure 1-3 Move the Micro SD / Reset/WPS Cover

Installing the SD Card

Insert the micro SD card into the micro SD card slot.




Figure 1-4 Install the SD Card

Resetting the Camera

Press WPS/RESET about 10s when the camera is power on or rebooting to restore the default settings, including the user name, password, IP address, port No., etc.

Setting the WPS Protocol

A wireless router with the WPS function is required to enable the WPS function of the camera. Refer the steps below.

Steps:

- 1. Press the WPS button on the router.
- Press the WPS button (about 2s) on the camera within 120s you enable the WPS of the router to join in the wireless network.




Figure 1-6 WPS/Reset Button



- The WPS button works as a reset button only when you press it when the camera is powering on.
- Press the WPS button on the camera, and then press the WPS button on the router will work as well, and the expire time of WPS connection on the camera is 120s.
- The link indicator blinks if the wireless connection succeeded.



Screw the Micro SD / Reset/WPS Cover back to the camera after all settings.

1.2.2 PoE Power Supply Configuration (Optional)

This type of bullet camera support PoE power supply. The connection of PoE power cables is shown as follows. Connect the single-cable end to the PoE router. Connect the power and Ethernet cables on the other end to the corresponding cables of the camera.

2 Installation

Before you start:

- Make sure the device in the package is in good condition and all the assembly parts are included.
- The standard power supply is 12V DC or 24V AC, please make sure your power supply matches with your camera.
- Make sure all the related equipment is power-off during the installation.
- Check the specification of the products for the installation environment.
- Make sure that the wall is strong enough to withstand four times the weight of the camera and the bracket.

For the camera that supports IR, you are required to pay attention to the following precautions to prevent IR reflection:

- Dust or grease on the dome cover will cause IR reflection.
 Please do not remove the dome cover film until the installation is finished. If there is dust or grease on the dome cover, clean the dome cover with clean soft cloth and isopropyl alcohol.
- Make sure that there is no reflective surface too close to the camera lens. The IR light from the camera may reflect back into the lens causing reflection.
- The foam ring around the lens must be seated flush against the inner surface of the bubble to isolate the lens from the IR LEDS.
 Fasten the dome cover to camera body so that the foam ring and the dome cover are attached seamlessly.

2.1 Installation of the Bullet Camera



Both wall mounting and ceiling mounting are suitable for the IR bullet camera. Wall mounting will be taken as an example in this section. You can take steps of wall mounting as a reference if ceiling mounting is adopted.

Steps:

1. Drill the screw holes in the wall according to the drill template.




Figure 2-1 Drill Template

- 2. Route the corresponding cables.
- 3. Secure the camera to the wall with the supplied Screws.




Figure 2-2 Secure the Camera to the Ceiling

- 4. Connect the corresponding power/ Video Output cables.
- 5. Adjust the Lens.
 - 1). Loosen the adjustable nut.
 - 2). Adjust the pan direction [0°~360°].
 - 3). Adjust the tilt direction [0°~90°].
 - Rotate the camera [0~360°] to adjust the lens to the surveillance angle.
 - 5). Tighten the adjustable nut to complete the installation.




Figure 2-3 3-axis Adjustment

2.2 Installation of Water-proof Jacket

It is recommended to adopt the water-proof jacket (supplied) for the network interface when the camera is installed outdoor.

Steps:

- If the network cable has been settled down, cut off the plug of the network cable first.
- Route the network cable through the following components in sequence: fix nut, water-proof ring, and the main body of the water-proof jacket, as shown in the figure.
- Insert the water-proof ring into the main body of the water-proof jacket, to increase the sealing ability of the components.
- 4. Wire the plug and network cables up.
- Fix the O-ring to the network interface of the camera, and then connect the network cables

Wrap the network interface with the main body of the water-proof jacket, and then rotate the fix nut clockwise to assemble it to the main body of the water-proof jacket.




Figure 2-4 Install Water-proof Jacket

3 Setting the Network Camera over the LAN

Note:

You shall acknowledge that the use of the product with Internet access might be under network security risks. 3.1 Wiring

Please connect to the camera to the network according to the following figures

3.2 Activating the Camera

You are required to activate the camera first by setting a strong password for it before you can use the camera.

Activation via Web Browser, Activation via SADP, and Activation via Client Software are all supported. We will take activation via SADP software and Activation via Web Browser as examples to introduce the camera activation. Please refer to the User Manual of Network Camera for Activation via Client Software.

3.2.1 Activation via Web Browser

Steps:

- 1. Power on the camera, and connect the camera to the network.
- Input the IP address into the address bar of the web browser, and click Enter to enter the activation interface.

Notes:

- The default IP address of the camera is 192.168.1.64.
- For the camera enables the DHCP by default, you need to activate the camera via SADP software and search the IP address

Create a password and input the password into the password field

And we recommend you reset your password regularly, especially in the high security system, resetting the password monthly or weekly can better protect your product.

- 4. Confirm the password.
- 5. Click **OK** to save the password and enter the live view interface.

3.2.2 Activation via SADP Software

SADP software is used for detecting the online device, activating the camera, and resetting the password.

Get the SADP software from the supplied disk or the official website, and install the SADP according to the prompts. Follow the steps to activate the camera, please refer to the User Manual of Network Camera for other two activation methods.

Steps:

- Run the SADP software to search the online devices.
- Check the device status from the device list, and select the inactive device

Note:

The SADP software supports activating the camera in batch. Please refer to the user manual of SADP software for details.

Create a password and input the password in the password field, and confirm the password.



STRONG PASSWORD RECOMMENDED— We highly recommend you create a strong password of your own choosing (using a minimum of 8 characters, including upper case letters, lower case letters, numbers, and special characters) in order to increase the security of your product. And we recommend you reset your password regularly, especially in the high security system, resetting the password monthly or weekly can better protect your product.

4. Click OK to save the password.

You can check whether the activation is completed on the popup window. If activation failed, please make sure that the password meets the requirement and try again.

3.3 Modifying the IP Address

Purpose:

To view and configure the camera via LAN (Local Area Network), you need to connect the network camera in the same subnet with your PC. Then, install the SADP software or client software to search and change the IP of network camera. We will take modifying the IP Address via SADP software as an example to introduce the IP address modification.

Steps:

- Run the SADP software.
- 2. Select an active device.

Note:

Please refer to Chapter 3.2 to activate the camera if the camera is inactive.

 Change the device IP address to the same subnet with your computer by either modifying the IP address manually or checking the checkbox of Enable DHCP.

4. Input the password to activate your IP address modification.

The batch IP address modification is supported by the SADP; please refer to the User Manual of SADP for details.

4 Accessing via Web Browser

System Requirement:

Operating System: Microsoft Windows XP SP1 and above version

CPU: 2.0 GHz or higher

RAM: 1G or higher

Display: 1024×768 resolution or higher

Web Browser: Internet Explorer 8.0 and above version, Apple Safari 5.0.2 and above version, Mozilla Firefox 5.0 and above version and Google Chrome 18 and above version

Steps:

- 1. Open the web browser.
- In the browser address bar, input the IP address of the network camera, and press the Enter key to enter the login interface.

Note:

- The default IP address is 192.168.1.64.
- If the camera is not activated, please activate the camera first according to Chapter 3.2.
- 3. Input the user name and password.

The admin user should configure the device accounts and user/operator permissions properly. Delete the unnecessary accounts and user/operator permissions.

Note:

The device IP address gets locked if the admin user performs 7 failed password attempts (5 attempts for the user/operator).

4. Click Login.

You may have to close the web browser to finish the installation of the plug-in.




Figure 4-2 Download Plug-in
