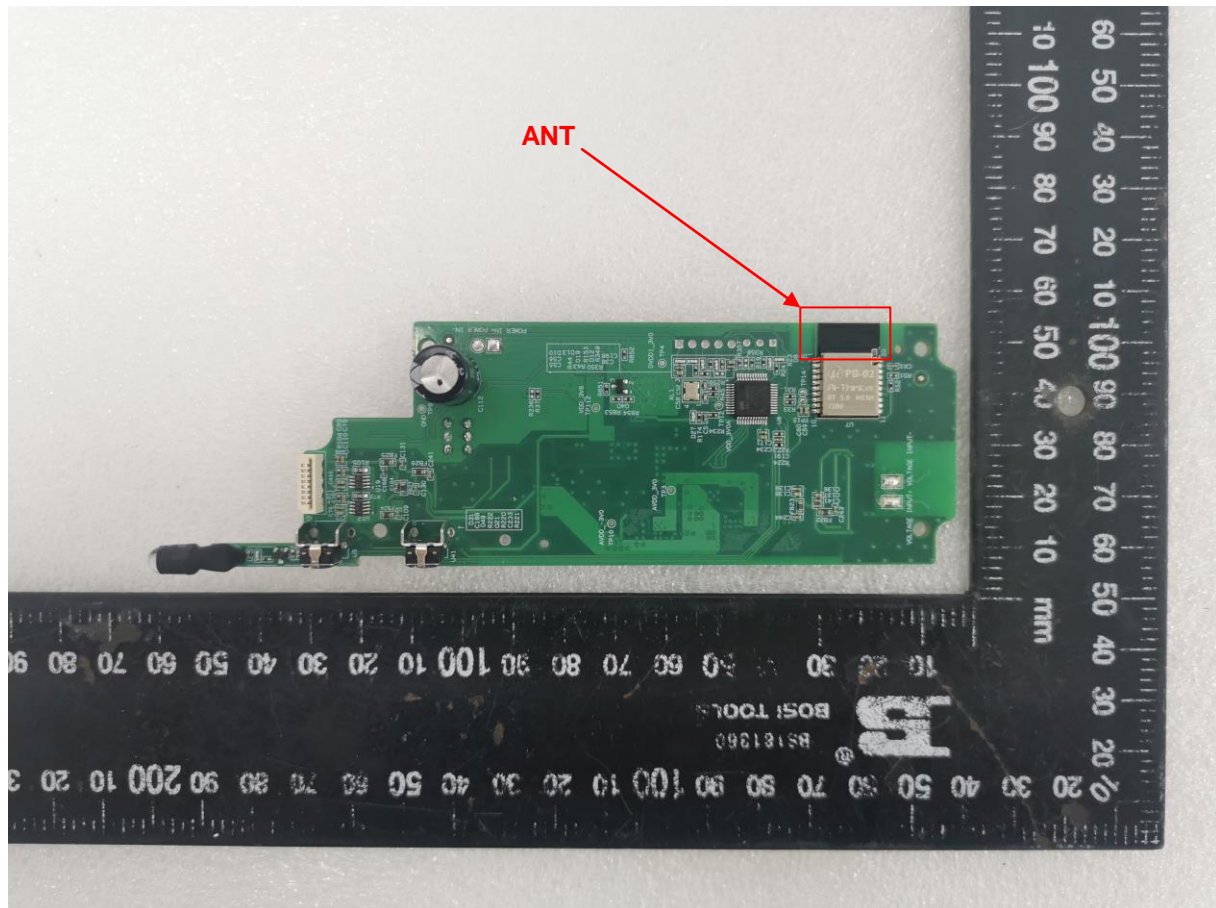

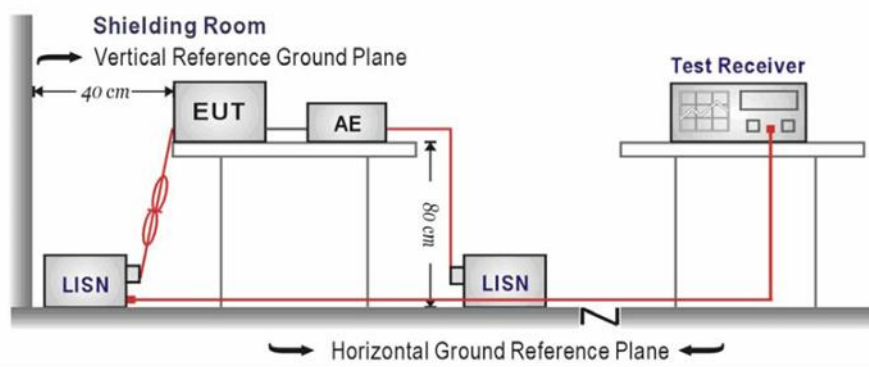

TEST PROCEDURE

1. The EUT was setup according to ANSI C63.10 requirements.
2. The EUT was placed on a platform of nominal size, 1 m by 1.5 m, raised 80 cm above the conducting ground plane. The vertical conducting plane was located 40 cm to the rear of the EUT. All other surfaces of EUT were at least 80 cm from any other grounded conducting surface.
3. The EUT and simulators are connected to the main power through a line impedances stabilization network (LISN). The LISN provides a 50 ohm /50uH coupling impedance for the measuring equipment.
4. The peripheral devices are also connected to the main power through a LISN. (Please refer to the block diagram of the test setup and photographs)
5. Each current-carrying conductor of the EUT power cord, except the ground (safety) conductor, was individually connected through a LISN to the input power source.
6. The excess length of the power cord between the EUT and the LISN receptacle were folded back and forth at the center of the lead to form a bundle not exceeding 40 cm in length.
7. Conducted emissions were investigated over the frequency range from 0.15MHz to 30MHz using a receiver bandwidth of 9 kHz.
8. During the above scans, the emissions were maximized by cable manipulation.

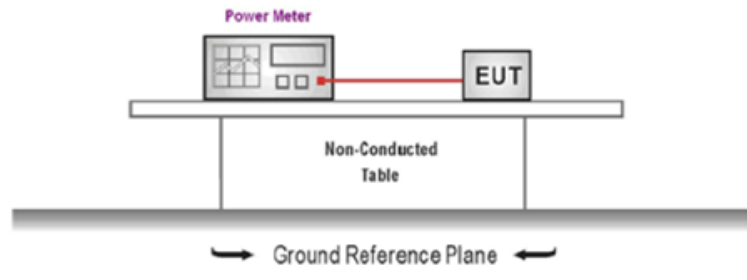

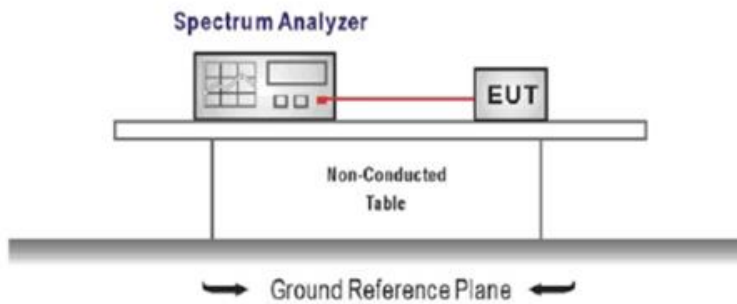

5. If measured value exceeds limit, reduce RBW (no less than 3 kHz) and repeat.

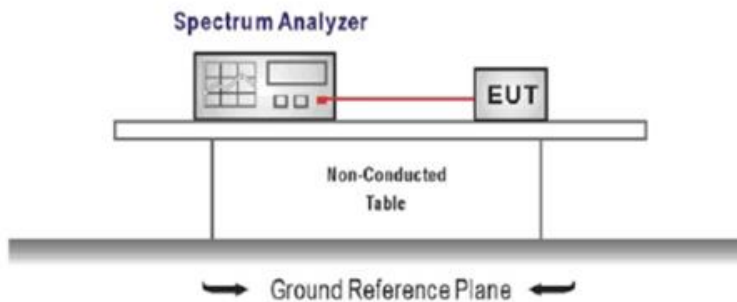

Measure the maximum width of the emission that is constrained by the frequencies associated with the two outermost amplitude points (upper and lower frequencies) that are attenuated by 6 dB relative to the maximum level measured in the fundamental emission, and record the pertinent measurements.

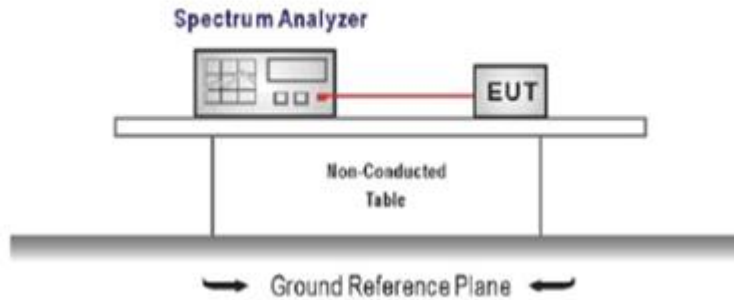

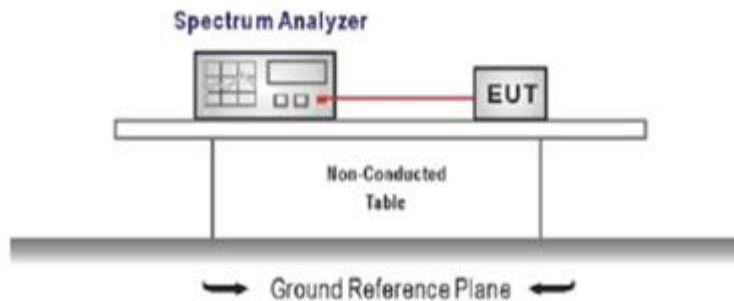

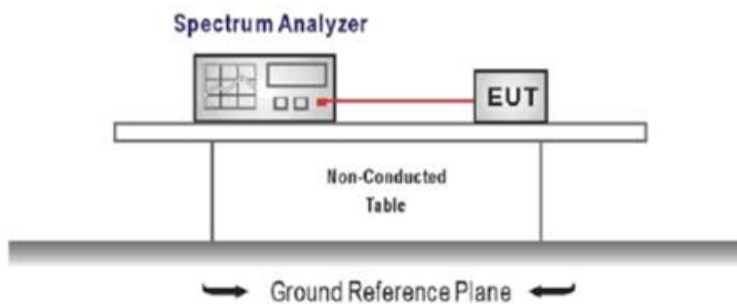

5.8. Conducted Band edge and Spurious Emission

Allow trace to fully stabilize
Use the peak marker function to determine the maximum amplitude level.
3. Place the radio in continuous transmit mode, allow the trace to stabilize, view the transmitter waveform on the spectrum analyzer.
4. Ensure that the amplitude of all unwanted emission outside of the authorized frequency band excluding restricted frequency bands) are attenuated by at least the minimum requirements specified (at least 20 dB relative to the maximum in-band peak PSD level in 100 kHz). 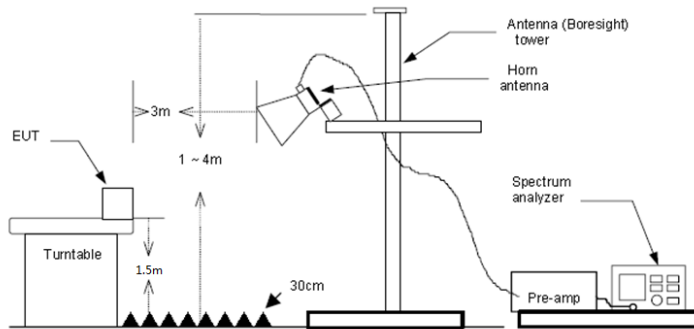

TEST PROCEDURE

1. The EUT was setup and tested according to ANSI C63.10 .
2. The EUT is placed on a turn table which is 1.5 meter above ground. The turn table is rotated 360 degrees to determine the position of the maximum emission level.
3. The EUT was positioned such that the distance from antenna to the EUT was 3 meters.
4. The antenna is scanned from 1 meter to 4 meters to find out the maximum emission level. This is repeated for both horizontal and vertical polarization of the antenna. In order to find the maximum emission, all of the interface cables were manipulated according to ANSI C63.10 on radiated measurement.
5. Use the following spectrum analyzer settings:
 - a) Span shall wide enough to fully capture the emission being measured
 - b) Set RBW=100kHz for <1GHz, VBW=3*RBW, Sweep time=auto, Detector=peak, Trace=max hold
 - c) Set RBW=1MHz, VBW=3MHz for >1GHz, Sweep time=auto, Detector=peak, Trace=max hold for Peak measurement

For average measurement:

 - VBW=10Hz, When duty cycle is no less than 98 percent
 - VBW \geq 1/T, when duty cycle is less than 98 percent where T is the minimum transmission duration over which the transmitter is on and is transmitting at its maximum power control level for the tested mode of operation, so refer to this clause 5.6 duty cycle.

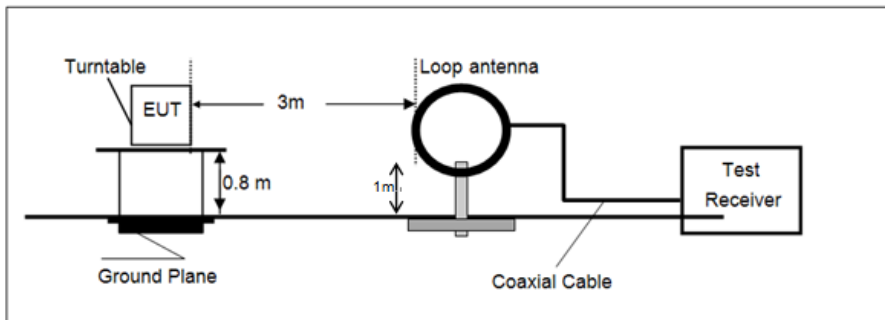

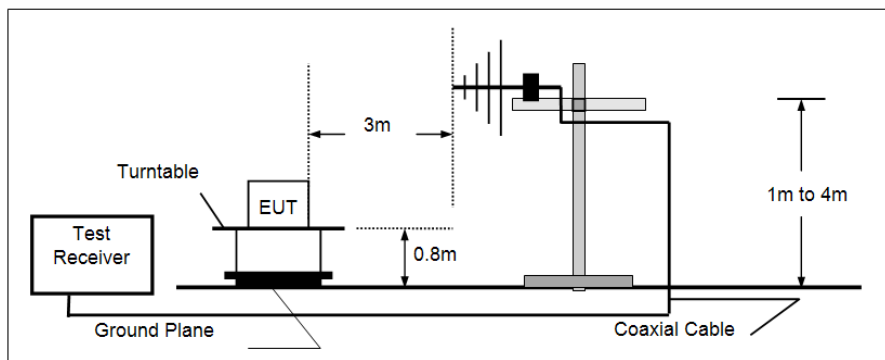

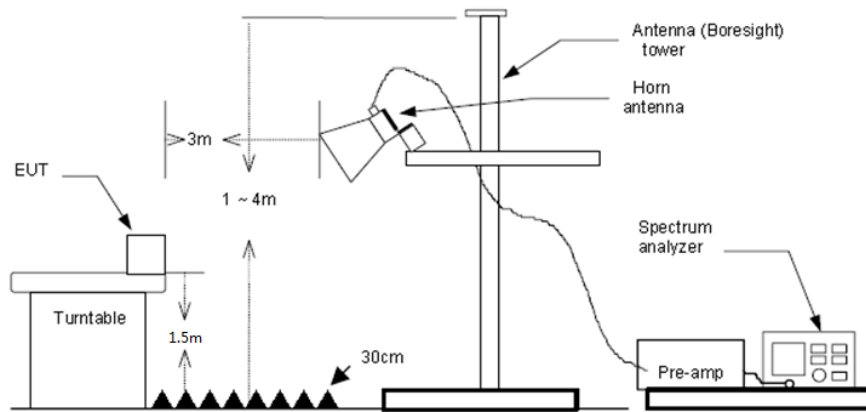

TEST PROCEDURE

1. The EUT was setup and tested according to ANSI C63.10 .
2. The EUT is placed on a turn table which is 0.8 meter above ground for below 1 GHz, and 1.5 m for above 1 GHz. The turn table is rotated 360 degrees to determine the position of the maximum emission level.
3. The EUT was set 3 meters from the receiving antenna, which was mounted on the top of a variable height antenna tower.
4. For each suspected emission, the EUT was arranged to its worst case and then tune the Antenna tower (from 1 m to 4 m) and turntable (from 0 degree to 360 degrees) to find the maximum reading. A pre-amp and a high pass filter are used for the test in order to get better signal level to comply with the guidelines.
5. Set to the maximum power setting and enable the EUT transmit continuously.
6. Use the following spectrum analyzer settings
 - a) Span shall wide enough to fully capture the emission being measured;
 - b) Below 1 GHz:
 - RBW=120 kHz, VBW=300 kHz, Sweep=auto, Detector function=peak, Trace=max hold;
 - If the emission level of the EUT measured by the peak detector is 3 dB lower than the applicable limit, the peak emission level will be reported. Otherwise, the emission measurement will be repeated using the quasi-peak detector and reported.
 - c) Set RBW=1MHz, VBW=3MHz for >1GHz, Sweep time=auto, Detector=peak, Trace=max hold for Peak measurement
 - For average measurement:
 - VBW=10Hz, When duty cycle is no less than 98 percent
 - $VBW \geq 1/T$, when duty cycle is less than 98 percent where T is the minimum transmission duration over which the transmitter is on and is transmitting at its maximum power control level for the tested mode of operation, so refer to this clause 5.6 duty cycle.
