

## 2. System Test Configuration

### 2.1 EUT Configuration

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner which intends to maximize its emission characteristics in a continuous normal application.

### 2.2 EUT Exercise

The Transmitter was operated in the normal operating mode. The TX frequency was fixed which was for the purpose of the measurements.

### 2.3 Test Procedure

#### 2.3.1 Conducted Emissions

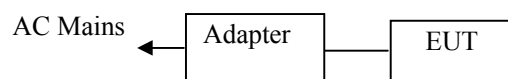
The EUT is a placed on as turn table which is 0.8 m above ground plane. According to the requirements in Section 13.1.4.1 of ANSI C63.4-2009 Conducted emissions from the EUT measured in the frequency range between 0.15 MHz and 30 MHz using CISPR Quasi-Peak and average detector mode.

#### 2.3.2 Radiated Emissions

The EUT is a placed on as turn table which is 0.8 m above ground plane. The turn table shall rotate 360 degrees to determine the position of maximum emission level. EUT is set 3m away from the receiving antenna which varied from 1m to 4m to find out the highest emission. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical. In order to find out the max. Emission, the relative positions of this hand-held transmitter (EUT) was rotated through three orthogonal axes according to the requirements in Section 13.1.4.1 of ANSI C63.4-2009.

### **3. Description of Test Modes**

The Transmitter of EUT is an Internet Tablet and powered by host equipment; these is Digital Transmission system (DTS) and have modulation OFDM, DSSS, DBPSK, DQPSK, CCK, 16QAM, 64QAM. According exploratory test, EUT will have maximum output power in those data rate (802.11b: 1 Mbps; 802.11g: 6 Mbps; 802.11n HT20: MCS0; 802.11n HT40: MCS0), so those data rate were used for all test.

For 802.11b/g/n HT20:

1. For lowest channel : 2412MHz (Channel 1)
2. For middle channel : 2437MHz (Channel 6)
3. For highest channel: 2462MHz (Channel 11)

For 802.11n HT40:

4. For lowest channel : 2432MHz (Channel 3)
5. For middle channel : 2437MHz (Channel 6)
6. For highest channel: 2452MHz (Channel 9)

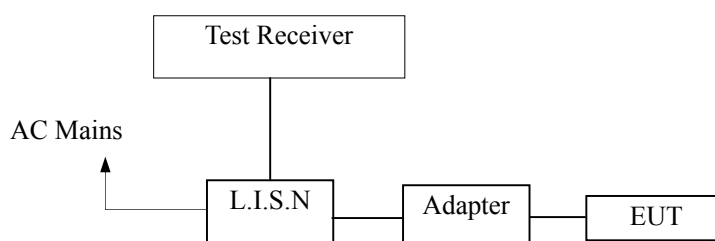

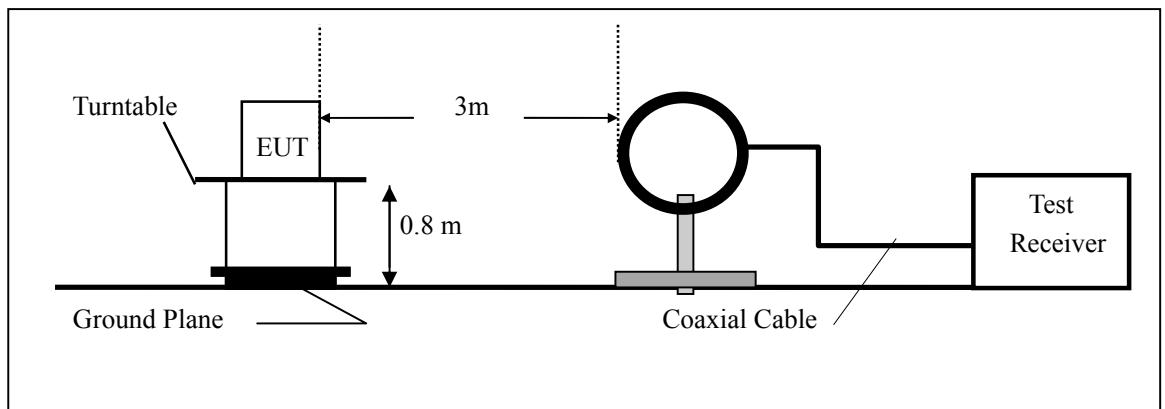
### 6.1 Measurement Procedure

4. Repeat above procedures until all frequency measured was complete.

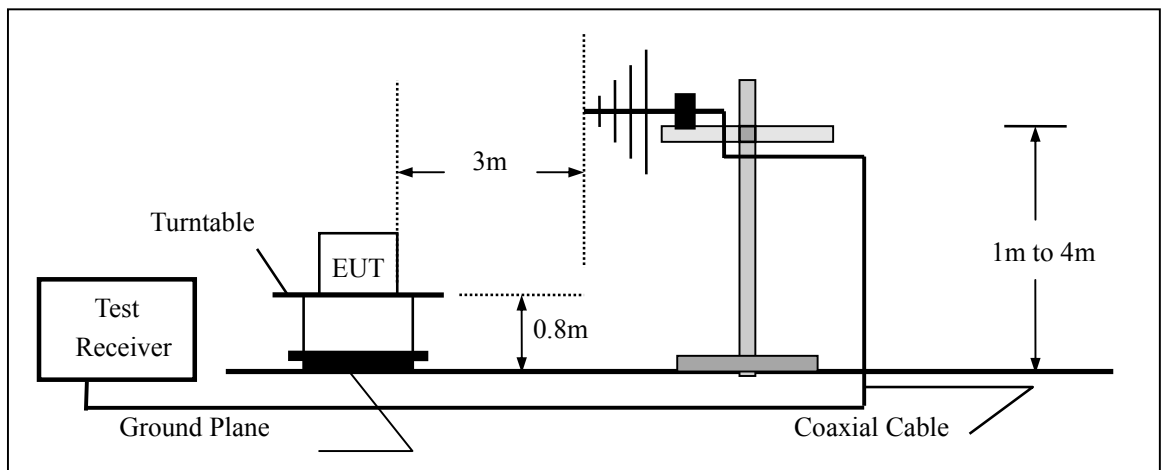
For emissions measurement set the bandwidth of the Spectrum's RBW at 1MHz

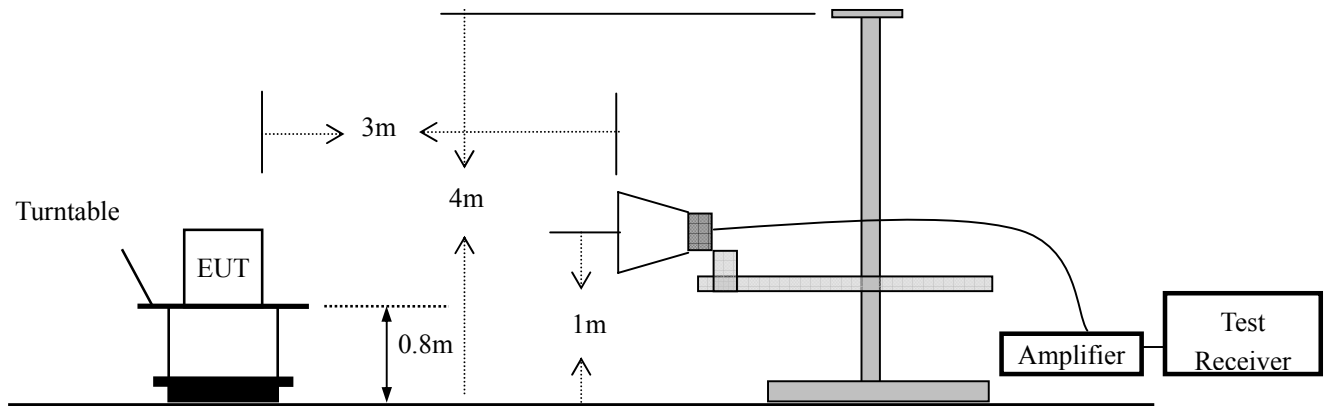
(A) Radiated Emission Test Set-Up, Frequency Below 30MHz

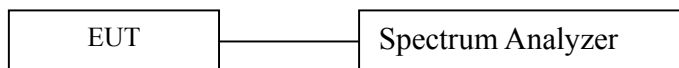
## 7. 6dB Bandwidth Test

### 7.1 Measurement Procedure

## 8. Maximum Peak Output Power Test

### 8.1 Measurement Procedure

The maximum peak conducted output power can be measured using a broadband peak RF power meter. The power meter must have a video bandwidth that is greater than or equal to the DTS bandwidth and shall utilize a fast, average-responding diode type sensor.

## **12. Antenna Application**

### **12.1 Antenna Requirement**

For intentional device, according to FCC 47 CFR Section 15.203, an intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. And according to FCC 47 CFR Section 15.247 (b), if transmitting antennas of directional gain greater than 6dBi are used, the power shall be reduced by the amount in dB that the directional gain of the antenna exceeds 6dBi.

### **12.2 Result**

The EUT'S antenna is Chip antenna. The antenna's gain is 2.51dBi and meets the requirement.
