5 Technical Requirements Specification

5.1 RF Exposure Evaluation

5.1.1 Limit & Test Method

KDB447498D01 General RF Exposure Guidance v06

The 1-g and 10-g SAR test exclusion thresholds for 100 MHz to 6 GHz at test separation distances ≤ 50 mm are determined by:

$$\frac{[(\text{max. power of channel, including tune-up tolerance, mW})/(\text{min. test separation distance, mm})] \cdot [\sqrt{f(\text{GHz})}]}{\leq 3.0 \text{ for 1-g SAR and } \leq 7.5 \text{ for 10-g extremity SAR, where}}$$

- $f(\text{GHz})$ is the RF channel transmit frequency in GHz
- Power and distance are rounded to the nearest mW and mm before calculation¹⁷
- The result is rounded to one decimal place for comparison

The test exclusions are applicable only when the minimum test separation distance is ≤ 50 mm and for transmission frequencies between 100 MHz and 6 GHz. When the minimum test separation distance is < 5 mm, a distance of 5 mm is applied to determine SAR test exclusion

5.1.2 Conclusion

The Maximum Conducted Peak Output Power is -3.08 dBm in channel 2.441 GHz;

-3.08 dBm logarithmic terms convert to numeric result is nearly 0.492 mW

$$[(\text{max. power of channel, including tune-up tolerance, mW})/(\text{min. test separation distance, mm})] \cdot [\sqrt{f(\text{GHz})}]$$

General RF Exposure = $(0.492 \text{ mW} / 5 \text{ mm}) \times \sqrt{2.441 \text{ GHz}} = 0.154$;

SAR requirement: $S = 3.0$;

∵ $0.154 < 3.0$ ∴ the SAR report is not required.
