

Use Your Receiver

- 1. Plug the audio cable or the RCA cable into the **AUDIO** jack, then connect to vour speaker or amplifier.
- Connect the supplied power adapter to the **DC IN** jack, then plug into a standard AC outlet. The indicator flashes red and your receiver starts to seartch for Bluetooth devices.
- 3. See instructions of your Bluetooth device to pair with the receiver. After successful pairing, the indicator lights blue. If vour device uses Bluetooth 2.0 or below, enter the password 0000 for Bluetooth connection.
- 4. Use the playback controls on your audio device.
- 5. Disconnect the Bluetooth connection after using, the indicator lights red.

- You can download Auvio EQ App free from the App StoreSM and Google Play™ to customize your calls and music.
- If your Bluetooth device is out of connection range and disconnects with the receiver, move back within range within 10 minutes to reconnect automatically.
- Using an adapter that does not meet the receiver's specifications could damage the receiver.
