## Single Modular Approval Letter

Dear application examiner,

NXP USA, Inc. (Successor in Interest to NXP Semiconductors USA, Inc.), would like to have your authorization as a modular approval on the BT radio module, with FCC ID: XXMQN9080M17 and IC: 8764A-QN9080M17. The requirements of CFR 47 part 15.212 and RSP-100 part 5.3 have been checked and shown in the following statement,

<ul><li>(vi) The modular transmitter must be equipped with either a permanently affixed label or must be capable of electronically displaying its FCC identification number.</li><li>If the FCC ID is not visible when the module is installed inside another device, then the outside of the device into which the</li></ul>	х		



module is installed must also display a label referring to the		
enclosed module. This exterior label can use wording such as		
the following: "Contains Transmitter Module FCC ID:		
XXMQN9080M17 " or "Contains FCC ID:		
XXMQN9080M17 ." The exact wording is not specified in our		
Rules (since modules are not specifically addressed), so you		
may use similar wording which expresses the same meaning.		
(vii) The modular transmitter must comply with any specific rules		
or operating requirements that ordinarily apply to a complete		
transmitter and the manufacturer must provide adequate		
instructions along with the module to explain any such	Х	
requirements. A copy of these instructions must be included in		
the application for equipment authorization.		
(viii) The modular transmitter must comply with any applicable		
RF exposure requirements in its final configuration.	Х
