(hereinafter each individually referred to as a "Party" and collectively referred to as the "Parties")

WHEREAS

In particular, the discussion of co-operation and technical details relating to providing technical support between parties is considered confidential as required by the FCC for non-consumer devices (KDB 26920)

In all contacts and information regarding technology and/or supply of parts and/or products and /or other technical information and/or other services:

The parties may, in conjunction with aforesaid, disclose to each other technical and commercial information relating to their respective business, facilities, products, techniques, processes, drawings and information of all kinds and in whatsoever form (hereinafter "Information") and the parties are willing to undertake to restrict the use and further disclosure of the information;

NOW, THEREFORE THE PARTIES HEREBY AGREE AS FOLLOWS

- 1) Any information exchanged by the Parties shall be deemed to be disclosed in confidence and will be used only for the co-operation between the Parties.
- 2) Any information disclosed hereunder shall only be disclosed by the receiving Party to employees or non executive directors of the receiving party on a need-to-know basis. It is the responsibility of the party to ensure that all persons provided with information are familiar with and accept to comply with this Agreement.
- 3) Documentation included in this agreement includes, but is not limited to, the following items:

- 4) The receiving party shall protect the information with the same degree of care that it uses to safeguard its own proprietary information from unauthorized use, disclosure or dissemination.
- 5) No license under any patents or copyrights is granted or implied by disclosure of information.
- 6) The Parties agree to report directly to each other if it has been observed or when it is feared that information covered by the Agreement has come to the knowledge of an unauthorized person.
- 7) The parties agree to return, upon each other's written request, all information received pursuant to the Agreement. The exception to this clause is where the receiving party has requested authorisation to archive information for the purposes of meeting approvals standards.
- 8) Information shall not be subject to this Agreement, if it is so publicly known, or is rightfully received from a third party, or is independently developed by the receiving Party or is approved for release by written authorization of the disclosing Party.
- 9) The rights and obligations of the parties under this Agreement shall cease to be in effect four (4) years from the date of signature, unless the Agreement is renewed by the Parties before such time.
- 10) This Agreement shall be subject to English Law. Any conflicts related to this Agreement shall – to the extent that an amicable solution cannot be found – be resolved in an English Court of Law.
