# ruwido

## **1** LED behaviour during regular operation

#### stb LED:

- red LED when BLE command is transmitted
- green LED when IR command is transmitted

#### tv LED:

green LED when IR command is transmitted

## 2 manual pairing

- power on STB
- press "On Demand" and "Play/Pause" keys for 3 sec to start pairing process (continues red flashing of LED)
  - → LED will stop flashing red if pairing was successful
- plug in the ble2ir dongle to an available USB of Set Top Box *in case dongle is used*
- to delete pairing from remote control press 4 and 6 keys for 3 seconds
  LED will flash 4 times red if pairing deletion was successful

## 3 factory settings

to set remote control back to factory mode press 7 and 9 keys for 3 seconds
 LED will flash 4 times

### 4 notes

- factory default setting: BLE mode
- pairing information will remain if batteries are being removed / changed
- mode settings will remain if batteries are being removed / changed
