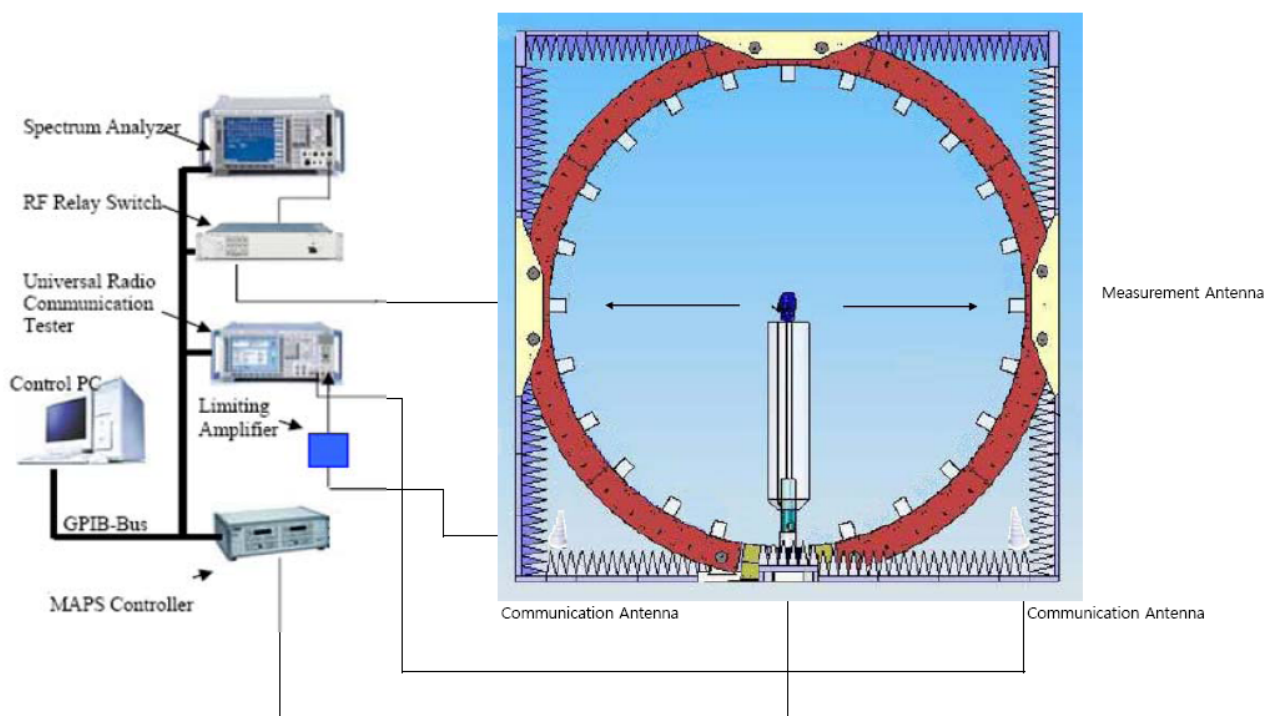

Free Space Right Impedance Setup



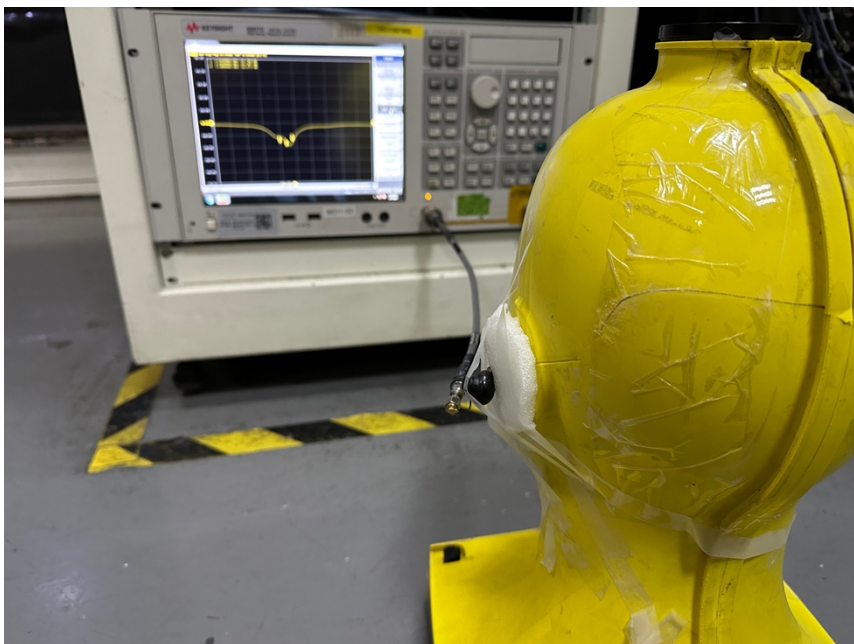

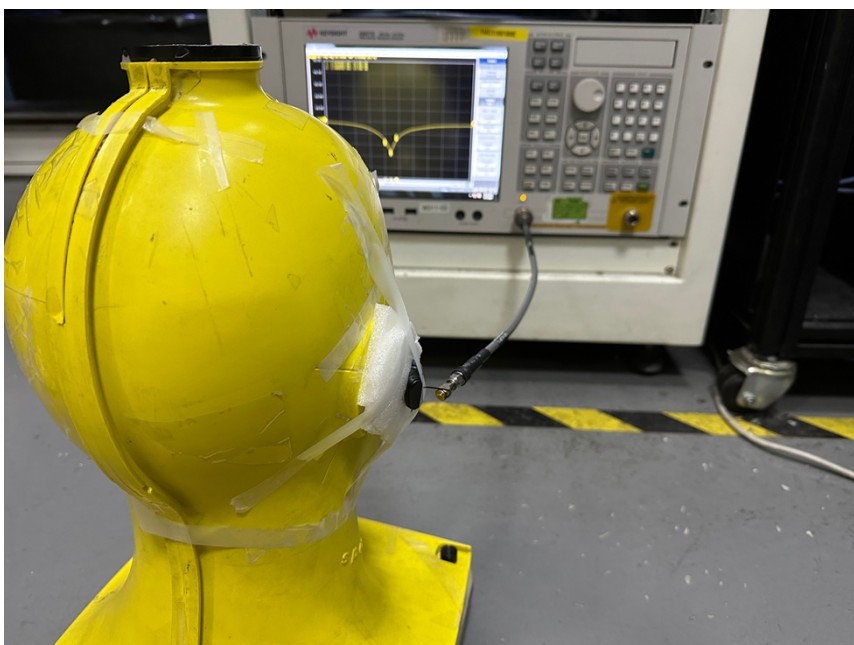
