



## 9. The SAR Measurement System



#### <SAR System Configuration>

- A standard high precision 6-axis robot with controller, teach pendant and software. An arm extension for accommodating the data acquisition electronics (DAE).
- An isotropic Field probe optimized and calibrated for the targeted measurement.
- Data acquisition electronics (DAE) which performs the signal amplification, signal multiplexing, AD-conversion, offset measurements, mechanical surface detection, collision detection, etc. The unit is battery powered with standard or rechargeable batteries. The signal is optically transmitted to the EOC.
- The Electro-optical converter (EOC) performs the conversion from optical to electrical signals for the digital communication to the DAE. To use optical surface detection, a special version of the EOC is required. The EOC signal is transmitted to the measurement server.
- The function of the measurement server is to perform the time critical tasks such as signal filtering, control of the robot operation and fast movement interrupts.
- The Light Beam used is for probe alignment. This improves the (absolute) accuracy of the probe positioning.
- A computer running WinXP or Win7 and the DASY4 software.
- Remote control and teach pendant as well as additional circuitry for robot safety such as warning lamps, etc.
- The phantom, the device holder and other accessories according to the targeted measurement.

## 9.2 SAM Twin Phantom



#### <SAM Twin Phantom>

The SAM twin phantom is a fiberglass shell phantom with 2mm shell thickness (except the ear region where shell thickness increases to 6mm). It has three measurement areas:

- Left head
- Right head
- Flat phantom

A white cover is provided to tap the phantom during off-periods to prevent water evaporation and changes in the liquid parameters. Free space scans of devices on the cover are possible.

On the phantom top, three reference markers are provided to identify the phantom position with respect to the robot.

Phantom specification:

**Description** The shell corresponds to the specifications of the Specific Anthropomorphic Mannequin (SAM) phantom defined in IEEE 1528-2003, IEC 62209-1 and IEC 62209-2. It enables the dosimetric evaluation of left and right hand phone usage as well as body mounted usage at the flat phantom region. A cover prevents evaporation of the liquid. Reference markings on the phantom allow the complete setup of all predefined phantom positions and measurement grids by teaching three points with the robot.

## 9.3 Device Holder for Transmitters



<Device Holder for Transmitters>

The SAR in the phantom is approximately inversely proportional to the square of the distance between the source and the liquid surface. For a source in 5mm distance, a positioning uncertainty of  $\pm$  0.5 mm would produce a SAR uncertainty of  $\pm$  20 %. An accurate device positioning is therefore crucial for accurate and repeatable measurements. The positions, in which the devices must be measured, are defined by the standards.

The DASY device holder is designed to cope with different positions given in the standard. It has two scales for the device rotation (with respect to the body axis) and the device inclination (with respect to the line between the ear reference points). The rotation centers for both scales are the ear reference point (ERP). Thus the device needs no repositioning when changing the angles.

The DASY device holder has been made out of low-loss POM material having the following dielectric parameters: relative permittivity = 3 and loss tangent = 0.02. The amount of dielectric material has been reduced in the closest vicinity of the device, since measurements have suggested that the influence of the clamp on the test results could thus be lowered.



# 10. Measurement for Tissue Simulant Liquid

The dielectric properties for this Tissue Simulant Liquids were measured by using the Agilent Model 85070D Dielectric Probe (rates frequency band 200 MHz to 20 GHz) in conjunction with Agilent E5070B Network Analyzer (9 kHz -3000 MHz). The Conductivity ( $\sigma$ ) and Permittivity ( $\rho$ ) are listed in Table 1.For the SAR measurement given in this report. The temperature variation of the Tissue Simulant Liquids was (22 ± 2) °C



# 11. SAR System Validation

The microwave circuit arrangement for system verification is sketched below picture. The da ily system accuracy verification occurs within the flat section of the SAM phantom. A SAR measurement was performed to see if the measured SAR was within +/- 10 % from the ta rget SAR values. These tests were done at 900/1800/1950/2450 MHz. The tests were condu cted on the same days as the measurement of the EUT. The obtained results from the syste m accuracy verification are displayed in the table C-1 (A power level of 250 mW was input to the dipole antenna). During the tests, the ambient temperature of the laboratory was in th e range 22 °C, the relative humidity was in the range 60 % and the liquid depth above the ear reference points was above 15 cm in all the cases. It is seen that the system is operat ing within its specification, as the results are within acceptable tolerance of the reference values.

# 12. Operation Configurations

For the RFID Reader SAR tests, a communication link is set up with the test mode software for can be controlled by pc via USB test. The Absolute Radio Frequency Channel Number is allocated to 1,25and 50 respectively in the case of 917.1 ~ 926.9 MHz.During the test,at the each test frequency channel, theEUT is operated at the RF continuous emission mode.Each channel should be tested at the max power data rate.



## 13. SAR Measurement Procedures

#### **Step 1: Power Reference Measurement**

The Power Reference Measurement and Power Drift Measurements are for monitoring the power drift of the device under test in the batch process. The Minimum distance of probe sensors to surface determines the closest measurement point to phantom surface. The minimum distance of probe sensors to surface is 2.1 mm. This distance cannot be smaller than the Distance of sensor calibration points to probe tip as defined in the probe properties.

#### Step 2: Area Scan

The Area Scan is used as a fast scan in two dimensions to find the area of high field values, before doing a fine measurement around the hot spot. The sophisticated interpolation routines implemented in DASY software can find the maximum locations even in relatively coarse grids. When an Area Scan has measured all reachable points, it computes the field maximal found in the scanned area, within a range of the global maximum. The range (in dB) is specified in the standards for compliance testing. For example, a 2 dB range is required in IEEE Standard 1528 and IEC 62209 standards, whereby 3 dB is a requirement when compliance is assessed in accordance with the ARIB standard (Japan). If only one Zoom Scan follows the Area Scan, then only the absolute maximum will be taken as reference. For cases where multiple maximums are detected, the number of Zoom Scans has to be increased accordingly.

#### Step 3: Zoom Scan

Zoom Scans are used to assess the peak spatial SAR values within a cubic averaging volume containing 1 g and 10 g of simulated tissue. The Zoom Scan measures  $\Box$ 7x7x9 (above 4.5 GHz) or 5x5x7 (below 3 GHz) points within a cube whose base faces are centered on the maxima found in a preceding area scan job within the same procedure. When the measurement is done, the Zoom Scan evaluates the averaged SAR for 1 g and 10 g and displays these values next to the job's label.

#### **Step 4: Power drift measurement**

The Power Drift Measurement measures the field at the same location as the most recent power reference measurement within the same procedure, and with the same settings. The Power Drift Measurement gives the field difference in dB from the reading conducted within the last Power Reference Measurement. This allows a user to monitor the power drift of the device under test within a batch process. The measurement procedure is the same as Step 1.

#### Step 5: Z-Scan

The Z Scan measures points along a vertical straight line. The line runs along the Z-axis of a onedimensional grid. In order to get a reasonable extrapolation, the extrapolated distance should not be larger than the step size in Z-direction.




Photograph of the SAR measurement System




