## **GENERAL INFORMATION**

#### **Product Description for Equipment under Test (EUT)**

The *Shenzhen Crystal Video Technology Co., LTD.*'s product, model number: CB8801-IL, CB8801, CB8806 (*FCC ID: Y3HCB880120120409*) ("EUT") in this report is a HD wireless video transmitter, which was measured approximately: 9.7cm (L) x 1.5cm (W) x1.4 cm (H), rated input voltage: DC 5V from adapter.

Adapter Information: MODEL: SSA051F050100USU INPUT: 100-240V~50/60Hz 0.2A OUTPUT: 5V 1A

Note: The series product, model CB8801-IL, CB8801, CB8806are electrically identical, the difference between them is just the model name, we selected CB8801 for fully testing, the details was explained in the attached declaration letter.

\* All measurement and test data in this report was gathered from production sample serial number: 12041114 (Assigned by Shenzhen BACL). The EUT was received on 2012-04-18.

## Objective

This type approval report is prepared on behalf of *Shenzhen Crystal Video Technology Co., LTD.* in accordance with Part 2-Subpart J, Part 15-Subparts A, B and E of the Federal Communication Commissions rules.

The tests were performed in order to determine compliance with FCC Part 15, Subpart E, section 15.203, 15.205, 15.207, 15.209 and 15.407 rules.

#### **Related Submittal(s)/Grant(s)**

No related submittal.

#### **Test Methodology**

All measurements contained in this report were conducted with ANSI C63.4-2009, American National Standard for Methods of Measurement of Radio-Noise Emissions from Low-Voltage Electrical and Electronic Equipment in the range of 9 kHz to 40 GHz.

All emissions measurement was performed and Bay Area Compliance Laboratories Corp. (Shenzhen). The radiated testing was performed at an antenna-to-EUT distance of 3 meters.

## **Test Facility**

The Test site used by Bay Area Compliance Laboratories Corp. (Dongguan) to collect test data is located on the No.69 Pulongcun, Puxinhu Industrial Zone, Tangxia, Dongguan, Guangdong, China

Test site at Bay Area Compliance Laboratories Corp. (Dongguan) has been fully described in reports submitted to the Federal Communication Commission (FCC). The details of these reports have been found to be in compliance with the requirements of Section 2.948 of the FCC Rules on February 02, 2012. The facility also complies with the radiated and AC line conducted test site criteria set forth in ANSI C63.4-2009.

The Federal Communications Commission has the reports on file and is listed under FCC Registration No.: 273710. The test site has been approved by the FCC for public use and is listed in the FCC Public Access Link (PAL) database.



## FCC §15.203 – ANTENNA REQUIREMENT

## **Applicable Standard**

According to § 15.203, an intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this section. The manufacturer may design the unit so that a broken antenna can be replaced by the user, but the user of a standard antenna jack or electrical connector is prohibited. The structure and application of the EUT were analyzed to determine compliance with section §15.203 of the rules. §15.203 state that the subject device must meet the following criteria: a. Antenna must be permanently attached to the unit.

b. Antenna must use a unique type of connector to attach to the EUT.

Unit must be professionally installed, and installer shall be responsible for verifying that the correct antenna is employed with the unit.

And according to FCC 47 CFR section 15.407 (a), if the transmitting antennas of directional gain greater than 6dBi are used, the transmit power and power spectral density shall be reduced by the amount in dB that the directional gain of the antenna exceeds 6 dBi.

## Antenna Connector Construction

The EUT has two Ceramic Chip Antenna, one for transmitting and receiving, the rest only for transmitting, which in accordance to section 15.203, the maximum gain is 2.9 dBi; please refer to the internal photos.




#### **Measurement Uncertainty**

All measurements involve certain levels of uncertainties, especially in field of EMC. The factors contributing to uncertainties are spectrum analyzer, cable loss, and LISN.

Based on NIS 81, The Treatment of Uncertainty in EMC Measurements, the best estimate of the uncertainty of any conducted emissions measurement at Bay Area Compliance Laboratory Corp. (Shenzhen) is  $\pm 2.4$  dB.





Unwanted emissions below 1 GHz must comply with the general field strength limits set forth in §15.209.


#### **Measurement Uncertainty**

All measurements involve certain levels of uncertainties, especially in field of EMC. The factors contributing to uncertainties are spectrum analyzer, cable loss, antenna factor calibration, antenna directivity, antenna factor variation with height, antenna phase center variation, antenna factor frequency interpolation, measurement distance variation, site imperfections, mismatch (average), and system repeatability.

Based on NIS 81, The Treatment of Uncertainty in EMC Measurements, the best estimate of the uncertainty of a radiation emissions measurement at Bay Area Compliance Laboratories Corp. (Shenzhen) is  $\pm 4.0$  dB.

#### **EUT Setup**

#### **Below 1GHz:**



The radiated emission tests were performed in the 3 meters, using the setup accordance with the ANSI C63.4-2009. The specification used was the FCC 15.209, and FCC 15.407 limits.

The external I/O cables were draped along the test table and formed a bundle 30 to 40 cm long in the middle.

The spacing between the peripherals was 10 cm.

The DVD was connected to a 120 VAC/60 Hz power source,

#### EMI Test Receiver & Spectrum Analyzer Setup

The system was investigated from 30 MHz to 40 GHz.

During the radiated emission test, the EMI test receiver & Spectrum Analyzer Setup were set with the following configurations:

#### **Test Procedure**

During the radiated emission test, the DVD was connected to the AC floor outlet.

Maximizing procedure was performed on the highest emissions to ensure that the EUT complied with all installation combinations.

Data was recorded in Quasi-peak detection mode for frequency range of 30 MHz-1GHz, peak and Average detection modes for frequencies above 1GHz.

## **Corrected Amplitude & Margin Calculation**

The Corrected Amplitude is calculated by adding the Antenna Factor and Cable Loss, and subtracting the Amplifier Gain from the Meter Reading. The basic equation is as follows:

Corrected Amplitude = Meter Reading + Antenna Factor + Cable Loss - Amplifier Gain

The "**Margin**" column of the following data tables indicates the degree of compliance with the applicable limit. For example, a margin of 7dB means the emission is 7dB below the limit. The equation for margin calculation is as follows:

Margin = Limit – Corrected Amplitude








#### 5190 MHz-Chain 0 (Below 1 G)

#### 5190 MHz-Chain 0 (26.5 G-40 G)






5190 MHz-Chain 1(1 G-26.5G)







#### 5230 MHz-Chain 1(Below 1 G)



The voltage was set to 80% and 115% of the nominal value and was then decreased until the transmitter light no longer illuminated. The output frequency was recorded for each voltage.
