## 3. TEST METHODOLOGY

The tests documented in this report were performed in accordance with ANSI C63.4 and FCC CFR 47 Part 15.207, 15.209 and 15.247.

#### 3.1 EUT CONFIGURATION

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner that intends to maximize its emission characteristics in a continuous normal application.

#### 3.2 EUT EXERCISE

The EUT was operated in the engineering mode to fix the TX frequency that was for the purpose of the measurements.

According to its specifications, the EUT must comply with the requirements of the Section 15.207, 15.209 and 15.247 under the FCC Rules Part 15 Subpart C.

#### 3.3 GENERAL TEST PROCEDURES

#### **Conducted Emissions**

The EUT is placed on the turntable, which is 0.8 m above ground plane. According to the requirements in Section 13.1.4.1 of ANSI C63.4: 2003 Conducted emissions from the EUT measured in the frequency range between 0.15 MHz and 30MHz using CISPR Quasi-peak and average detector modes.

#### **Radiated Emissions**

The EUT is placed on a turn table, which is 0.8 m above ground plane. The turntable shall rotate 360 degrees to determine the position of maximum emission level. EUT is set 3m away from the receiving antenna, which varied from 1m to 4m to find out the highest emission. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical. In order to find out the maximum emissions, exploratory radiated emission measurements were made according to the requirements in Section 13.1.4.1 of ANSI C63.4: 2003.

#### 3.5 DESCRIPTION OF TEST MODES

The EUT (model: LGL) had been tested under operating condition.

Software used to control the EUT for staying in continuous transmitting mode was programmed.

This device is for handheld operation only.

The power line conducted emissions below 30MHz, which was measured in the following condition: in normal link mode with USB charging cable and docking mode.

After verification, the worst emission was found in docking mode and the worst case was recorded.

#### IEEE 802.11b mode:

Channel 1(2412MHz), Channel 6(2437MHz) and Channel 11(2462MHz) with 1Mbps data rate were chosen for the final testing.

## IEEE 802.11g mode:

Channel 1(2412MHz), Channel 6(2437MHz) and Channel 11(2462MHz) with 6Mbps data rate were chosen for the final testing.

The field strength of spurious emission was measured in the following position: EUT stand-up position (Z axis), lie-down position (X, Y axis). The worst emission was found in lie-down position (X axis) and the worst case was recorded.

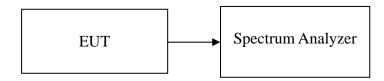

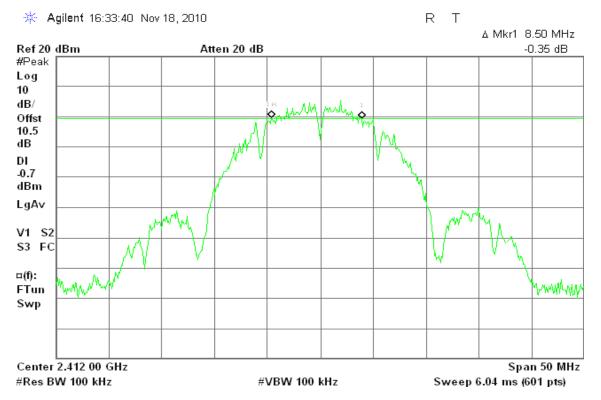

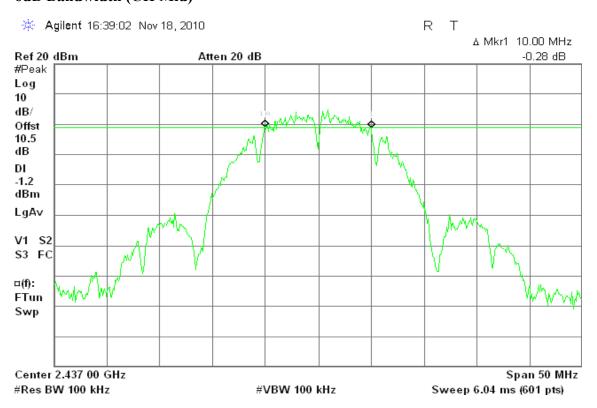

## 6dB Bandwidth (CH Low)



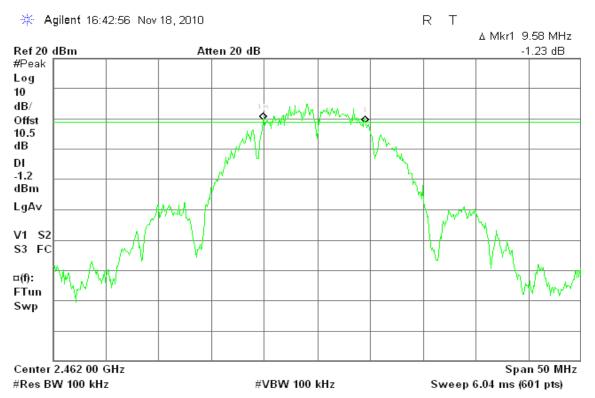
## 6dB Bandwidth (CH Mid)

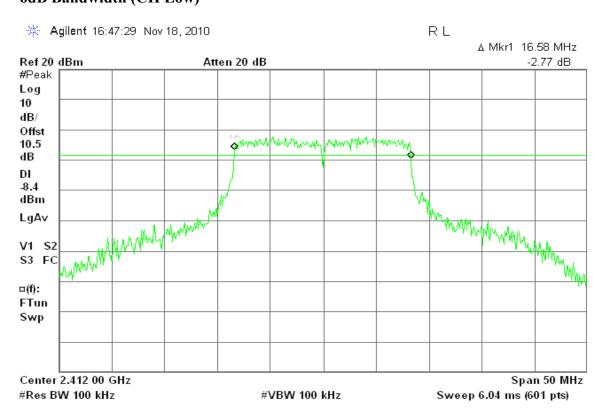

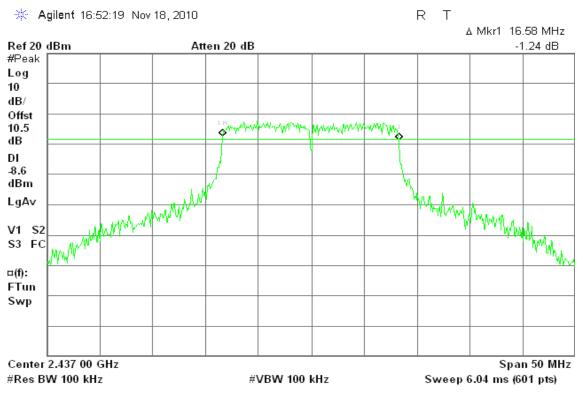

Detector mode: Peak Polarity: Vertical



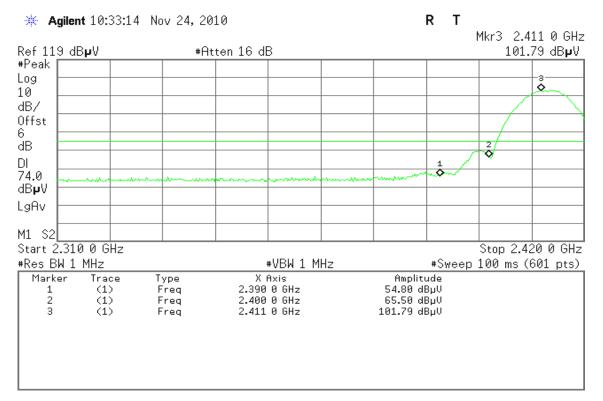
Detector mode: Average Polarity: Vertical



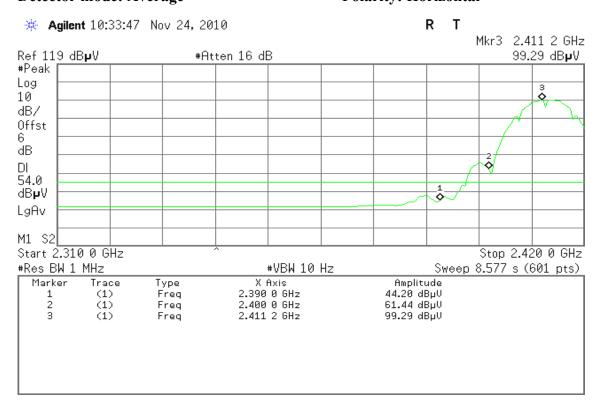

## Detector mode: Average Polarity: Horizontal

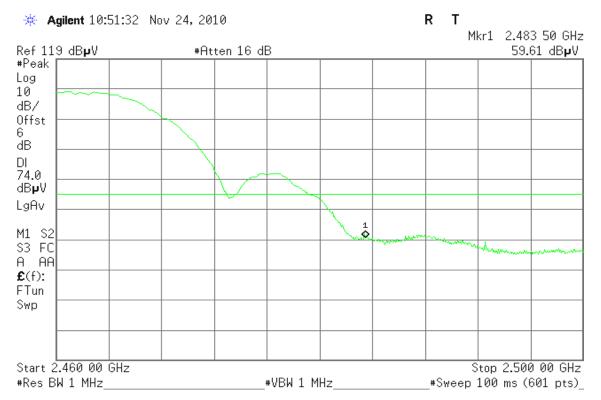

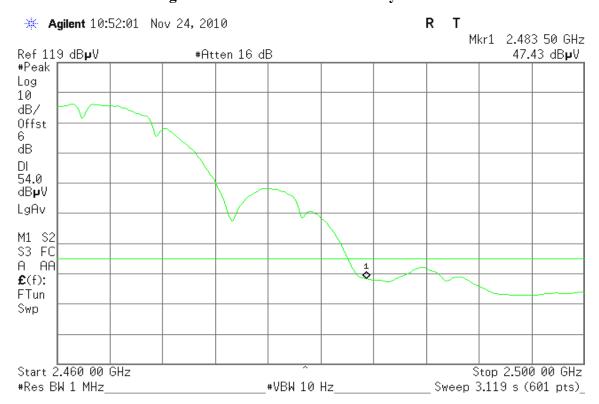

#### **Polarity: Vertical Detector mode: Average**

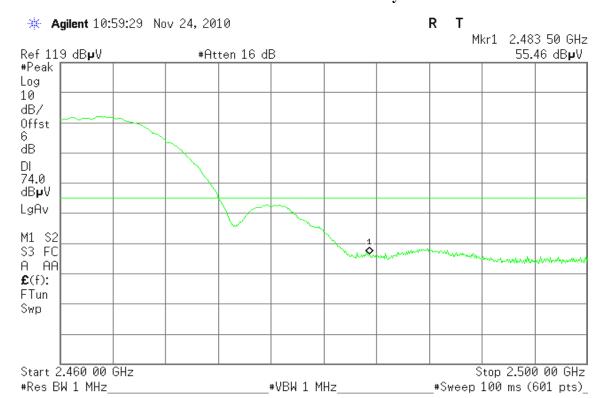

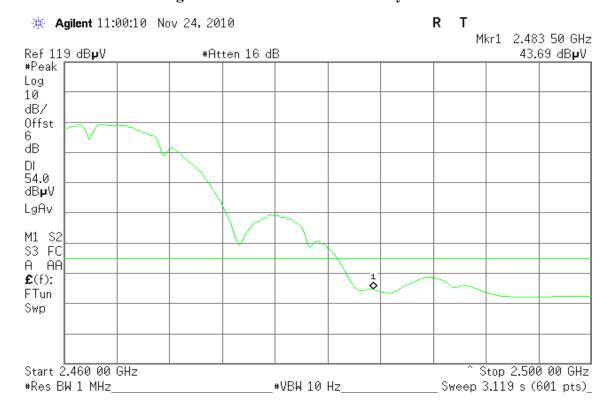
#### **Detector mode: Peak**

**Polarity: Vertical Detector mode: Peak** 



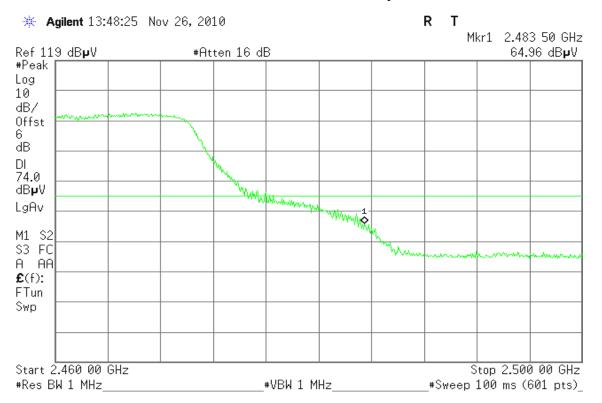

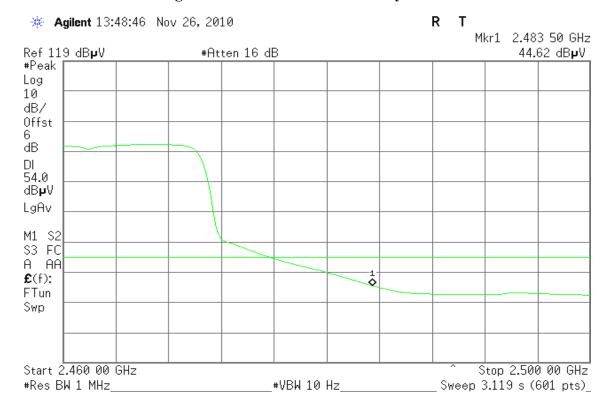

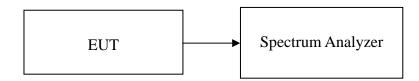

## 7.5 PEAK POWER SPECTRAL DENSITY

## **LIMIT**

- 1. According to §15.247(e), for digitally modulated systems, the power spectral density conducted from the intentional radiator to the antenna shall not be greater than 8 dBm in any 3 kHz band during any time interval of continuous transmission.

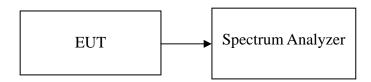
# 7.6 SPURIOUS EMISSIONS

#### 7.6.1 Conducted Measurement

## **LIMIT**

According to §15.247(d), in any 100 kHz bandwidth outside the frequency bands in which the spread spectrum intentional radiator in operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits. In addition, radiated emissions which fall in the restricted bands, as defined in §15.205(a), must also comply with the radiated emission limits specified in 15.209(a) (see Section 15.205(c)).

### $30MHz \sim 1GHz$



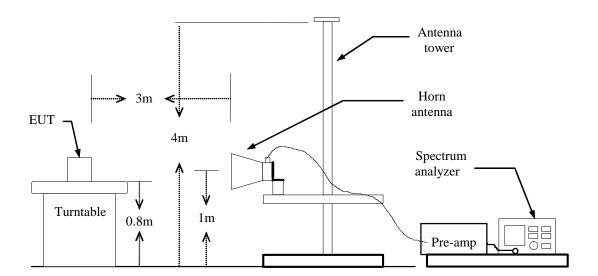

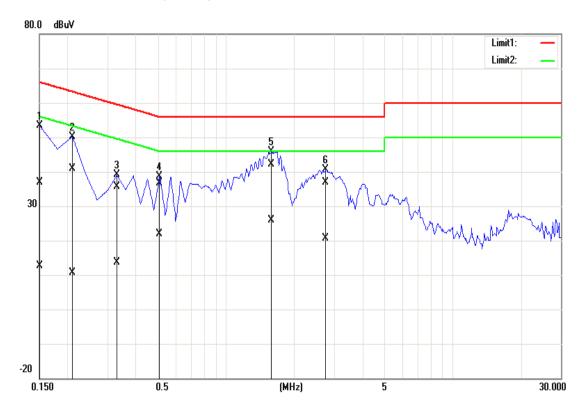

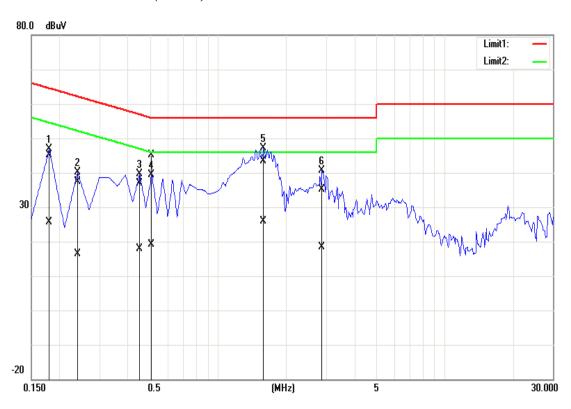
