5.2 The SAR Measurement System

A photograph of the SAR measurement System is given in F-1.

This SAR Measurement System uses a Computer-controlled 3-D stepper motor system (Speag Dasy 4 professional system). A Model ES3DV3 3088 E-field probe is used to determine the internal electric fields. The SAR can be obtained from the equation $SAR = \sigma (|E|^2) / \rho$ where σ and ρ are the conductivity and mass density of the tissue-Simulate.

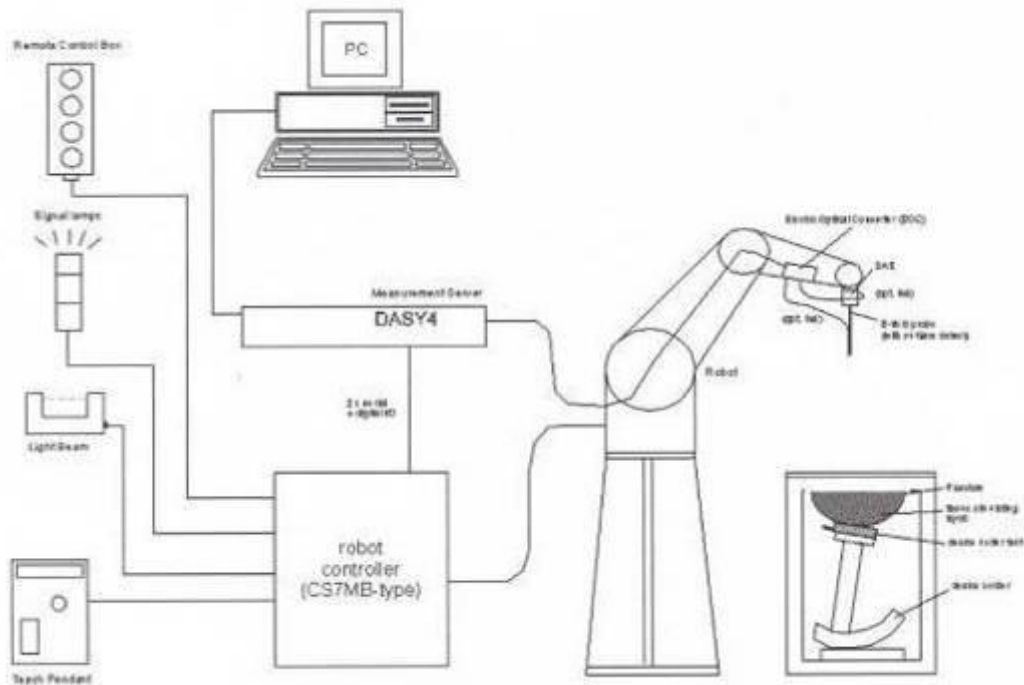
The DASY4 system for performing compliance tests consists of the following items:

A standard high precision 6-axis robot (Stabile RX family) with controller, teach pendant and software. An arm extension for accommodation the data acquisition electronics (DAE).

A dosimetric probe, i.e., an isotropic E-field probe optimized and calibrated for usage in tissue simulating liquid. The probe is equipped with an optical surface detector system.

A data acquisition electronics (DAE) which performs the signal amplification, signal multiplexing, AD-conversion, offset measurements, mechanical surface detection, collision detection, etc. The unit is battery powered with standard or rechargeable batteries. The signal is optically transmitted to the EOC.


The Electro-optical converter (EOC) performs the conversion between optical and electrical of the signals for the digital communication to DAE and for the analog signal from the optical surface detection. The EOC is connected to the measurement server.




F-1. SAR System Configuration

- The function of the measurement server is to perform the time critical tasks such as signal filtering, control of the robot operation and fast movement interrupts.
- A probe alignment unit which improves the (absolute) accuracy of the probe positioning.
- A computer operating Windows xp.
- DASY4 software.
- Remote control with teach pendant and additional circuitry for robot safety such as warning lamps, etc.
- The SAM twin phantom enabling testing left-hand, right-hand and Body Worn usage.
- The device holder for handheld mobile phones.
- Tissue simulating liquid mixed according to the given recipes.
- Validation dipole kits allowing to validating the proper functioning of the system.

F-2. Device Holder for Transmitters

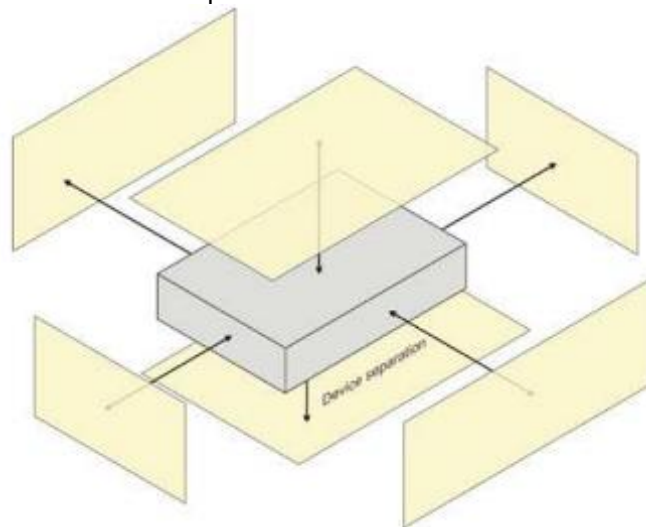
- The SAR in the phantom is approximately inversely proportional to the square of the distance between the source and the liquid surface. For a source in 5mm distance, a positioning uncertainty of $\pm 0.5\text{mm}$ would produce a SAR uncertainty of $\pm 20\%$. An accurate device positioning is therefore crucial for accurate and repeatable measurements. The positions, in which the devices must be measured, are defined by the standards.
- The DASY device holder is designed to cope with different positions given in the standard. It has two scales for the device rotation (with respect to the body axis) and the device inclination (with respect to the line between the ear reference points). The rotation centres for both scales are the ear reference point (ERP). Thus the device needs no repositioning when changing the angles.
- The DASY device holder has been made out of low-loss POM material having the following dielectric parameters: relative permittivity $\epsilon = 3$ and loss tangent $\delta = 0.02$. The amount of dielectric material has been reduced in the closest vicinity of the device, since measurements have suggested that the influence of the clamp on the test results could thus be lowered.

6 Description of Test Position

6.1 The Body Test Position

The SAR evaluation shall be performed for all surfaces of the DUT that are accessible during intended use, as indicated in Figure 11. The separation distance in testing shall correspond to the intended use distance as specified in the user instructions provided by the manufacturer. If the intended use is not specified, all surfaces of the DUT shall be tested directly against the flat phantom.

The surface of the generic device (or the surface of the carry accessory holding the DUT) pointing towards the flat phantom shall be parallel to the surface of the phantom.

7.1.2 Measurement for Tissue Simulate Liquid

The dielectric properties for this Tissue Simulate Liquids were measured by using the Agilent Model 85070D Dielectric Probe (rates frequency band 200 MHz to 20 GHz) in conjunction with Agilent E5071B Network Analyzer (300 KHz-8500 MHz). The Conductivity (σ) and Permittivity (ρ) are listed in Table 3. For the SAR measurement given in this report. The temperature variation of the Tissue Simulate Liquids was $22 \pm 2^\circ\text{C}$.

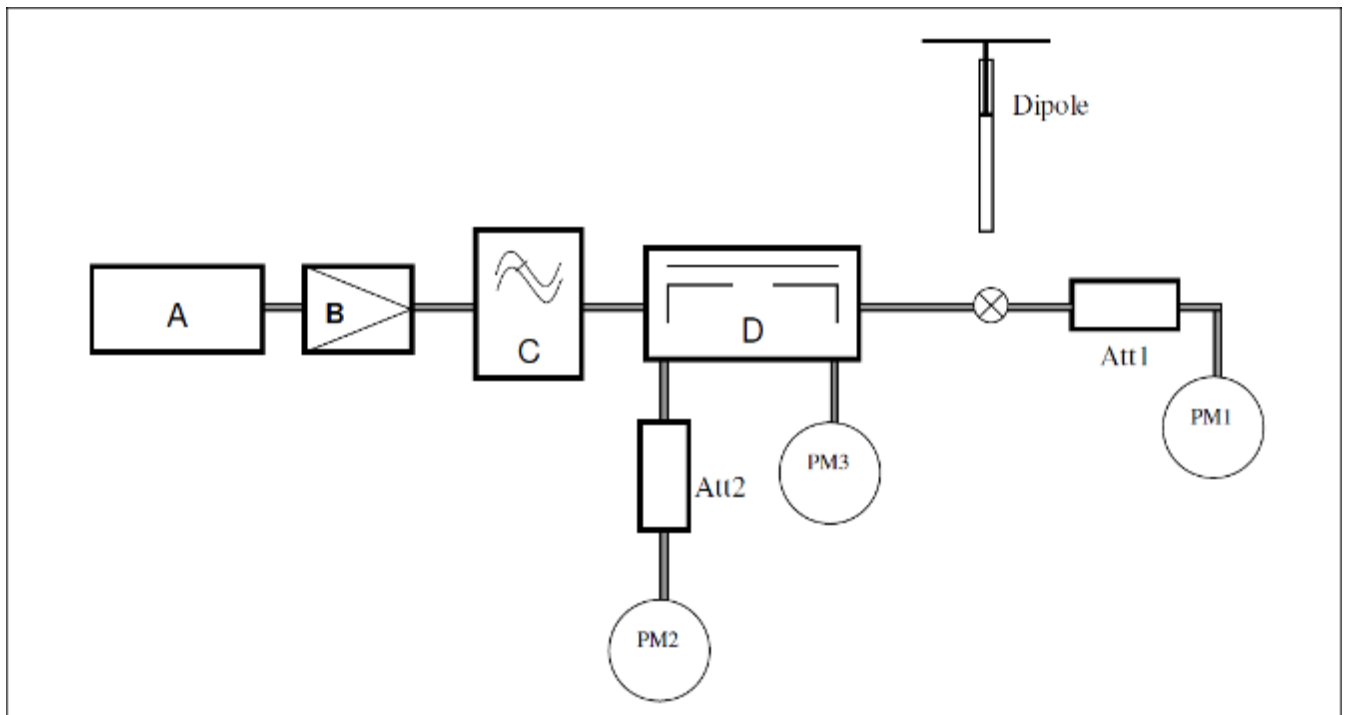

7.2 SAR System Validation

The microwave circuit arrangement for system verification is sketched in F-11. The daily system accuracy verification occurs within the flat section of the SAM phantom. A SAR measurement was performed to see if the measured SAR was within +/- 10% from the target SAR values. The tests were conducted on the same days as the measurement of the EUT. The obtained results from the system accuracy verification are displayed in the table C-1 (A power level of 250mw was input to the dipole antenna). During the tests, the ambient temperature of the laboratory was in the range 22°C, the relative humidity was in the range 60% and the liquid depth above the ear reference points was above 15 cm in all the cases. It is seen that the system is operating within its specification, as the results are within acceptable tolerance of the reference values.

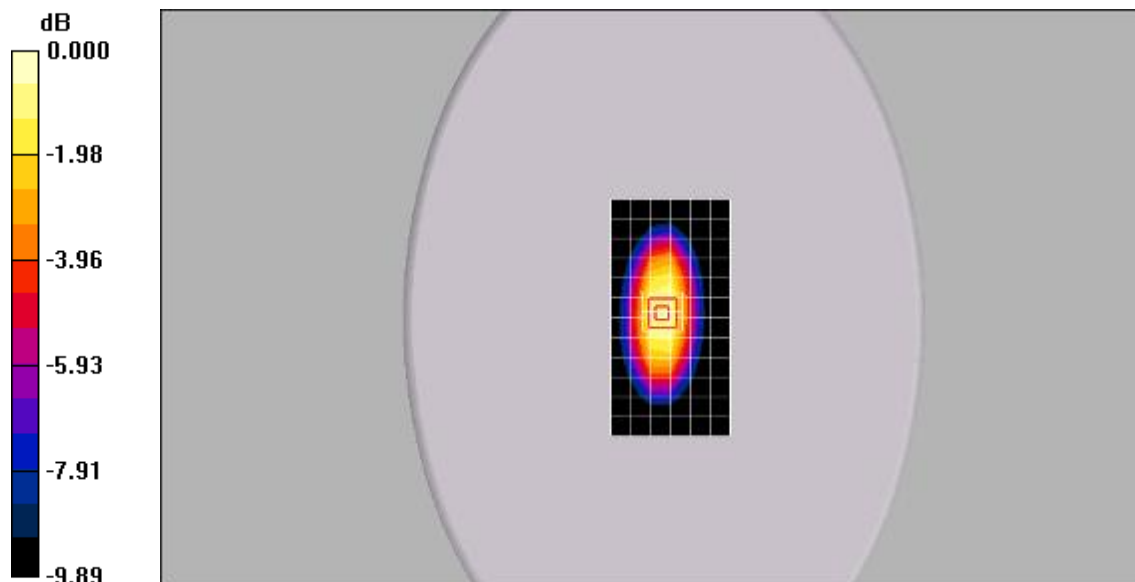

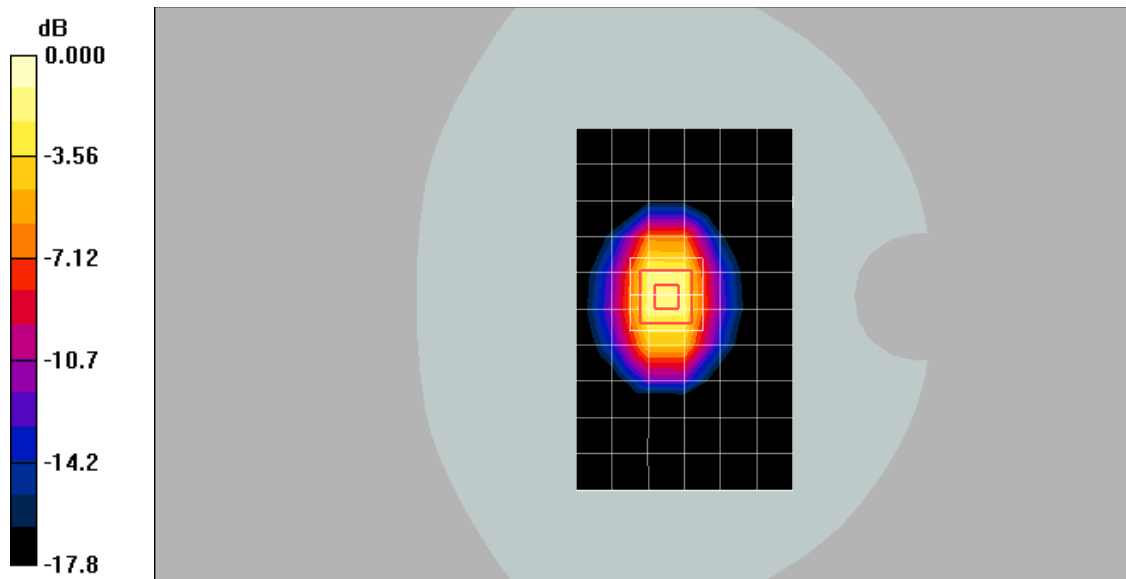

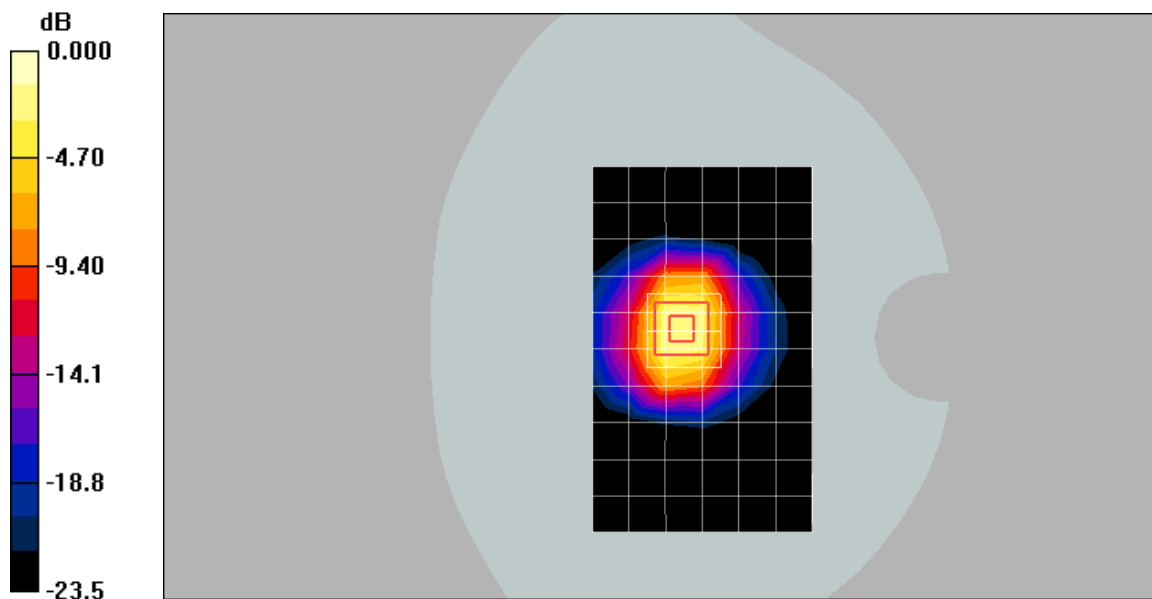

8 Test results and Measurement Data

8.1 Operation Configurations

8.1.1 GSM Test Configuration

SAR tests for GSM 850 and GSM 1900, a communication link is set up with a base station by air link. Using CMU200 the power lever is set to “5”and “0” in SAR of GSM 850 and GSM 1900. The tests in the band of GSM 850 and GSM 1900 are performed in the mode of GPRS/EGPRS function. Since the GPRS class is 10 for this EUT, it has at most 2 timeslots in uplink and at most 4 timeslots in downlink, the maximum total timeslot is 5. The EGPRS class is 10 for this EUT, it has at most 2 timeslots in uplink, and at most 4 timeslots in downlink, the maximum total timeslot is 5.

When SAR tests for EGPRS mode is necessary, GMSK modulation should be used to minimize SAR measurement error due to higher peak-to-average power (PAR) ratios inherent in 8-PSK.

8.1.2 WiFi Test Configuration

For the 802.11b/g/n SAR tests, a communication link is set up with the test mode software for Wi-Fi mode test. The Absolute Radio Frequency Channel Number (ARFCN) is allocated to 1, 6 and 11 respectively in the case of 2450 MHz during the test at the each test frequency channel .the EUT is operated at the RF continuous emission mode. Each channel should be tested at the rate which the average output power is maximum.802.11b/g/n operating modes are tested independently according to the service requirements in each frequency band. 802.11b/g/n modes are tested on channel 1, 6, 11; however if output power reduction is necessary for channels 1 and/or 11 to meet restricted band requirements the highest output channel closest to each of these channels must be tested instead.

SAR is not required for 802.11g/n channels when the maximum average output power is less than 0.25dB higher than that measured on the corresponding 802.11b channels.

8.2 Measurement procedure

8.2.1 Scanning procedure

Step 1: Power reference measurement

The SAR measurement was taken at a selected spatial reference point to monitor power variations during testing. This fixed location point was measured and used as a reference value.

Step 2: Area scan

The SAR distribution at the exposed side of the head was measured at a distance of 4mm from the inner surface of the shell. The area covered the entire dimension of the head and the horizontal grid spacing was 15mm*15mm or 10mm*10mm. Based on the area scan data, the area of the maximum absorption was determined by spline interpolation.

Step 3: Zoom scan

Around this point, a volume of 30mm*30mm*30mm (fine resolution volume scan, zoom scan) was assessed by measuring 7*7*7 points. On this basis of this data set, the spatial peak SAR value was evaluated with the following procedure:

The data at the surface was extrapolated, since the centre of the dipoles is 2.0mm away from the tip of the probe and the distance between the surface and the lowest measuring point is 1.2mm. (This can be variable. Refer to the probe specification). The extrapolation was based on a least square algorithm. A polynomial of the fourth order was calculated through the points in z-axes. This polynomial was then used to evaluate the points between the surface and the probe tip. The maximum interpolated value was searched with a straight-forward algorithm. Around this maximum the SAR values averaged over the spatial volumes (1g or 10g) were computed using the 3D-Spline interpolation algorithm. The volume was integrated with the trapezoidal algorithm. One thousand points (10*10*10) were interpolated to calculate the average. All neighbouring volumes were evaluated until no neighboring volume with a higher average value was found.

Step 4: Power reference measurement (drift)

The SAR value at the same location as in step 1 was again measured. (If the value changed by more than 5%, the evaluation should be done repeatedly)

8.2.2 Data Storage

The DAS4 software stores the acquired data from the data acquisition electronics as raw data (in microvolt readings from the probe sensors), together with all necessary software parameters for the data evaluation (probe calibration data, liquid parameters and device frequency and modulation data) in measurement files with the extension “.DAE3”. The software evaluates the desired unit and format for output each time the data is visualized or exported. This allows verification of the complete software setup even after the measurement and allows correction of incorrect parameter settings. For example, if a measurement has been performed with a wrong crest factor parameter in the device setup, the parameter can be corrected afterwards and the data can be re-evaluated. The measured data can be visualized or exported in different units or formats, depending on the selected probe type ([V/m], [A/m], [°C], [m W/g], [m W/cm²], [dBrel], etc.). Some of these units are not available in certain situations or show meaningless results, e.g., a SAR output in a lossless media will always be zero. Raw data can also be exported to perform the evaluation with other software packages.

8.2.3 Data Evaluation by SEMCAD

The SEMCAD software automatically executes the following procedures to calculate the field units from the microvolt readings at the probe connector. The parameters used in the evaluation are stored in the configuration modules of the software:

These parameters must be set correctly in the software. They can be found in the component documents or they can be imported into the software from the configuration files issued for the DASY4 components. In the direct measuring mode of the multimeter option, the parameters of the actual system setup are used. In the scan visualization and export modes, the parameters stored in the corresponding document files are used.

The first step of the evaluation is a linearization of the filtered input signal to account for the compression characteristics of the detector diode. The compensation depends on the input signal, the diode type and the DC-transmission factor from the diode to the evaluation electronics.

If the exciting field is pulsed, the crest factor of the signal must be known to correctly compensate for peak power. The formula for each channel can be given as:

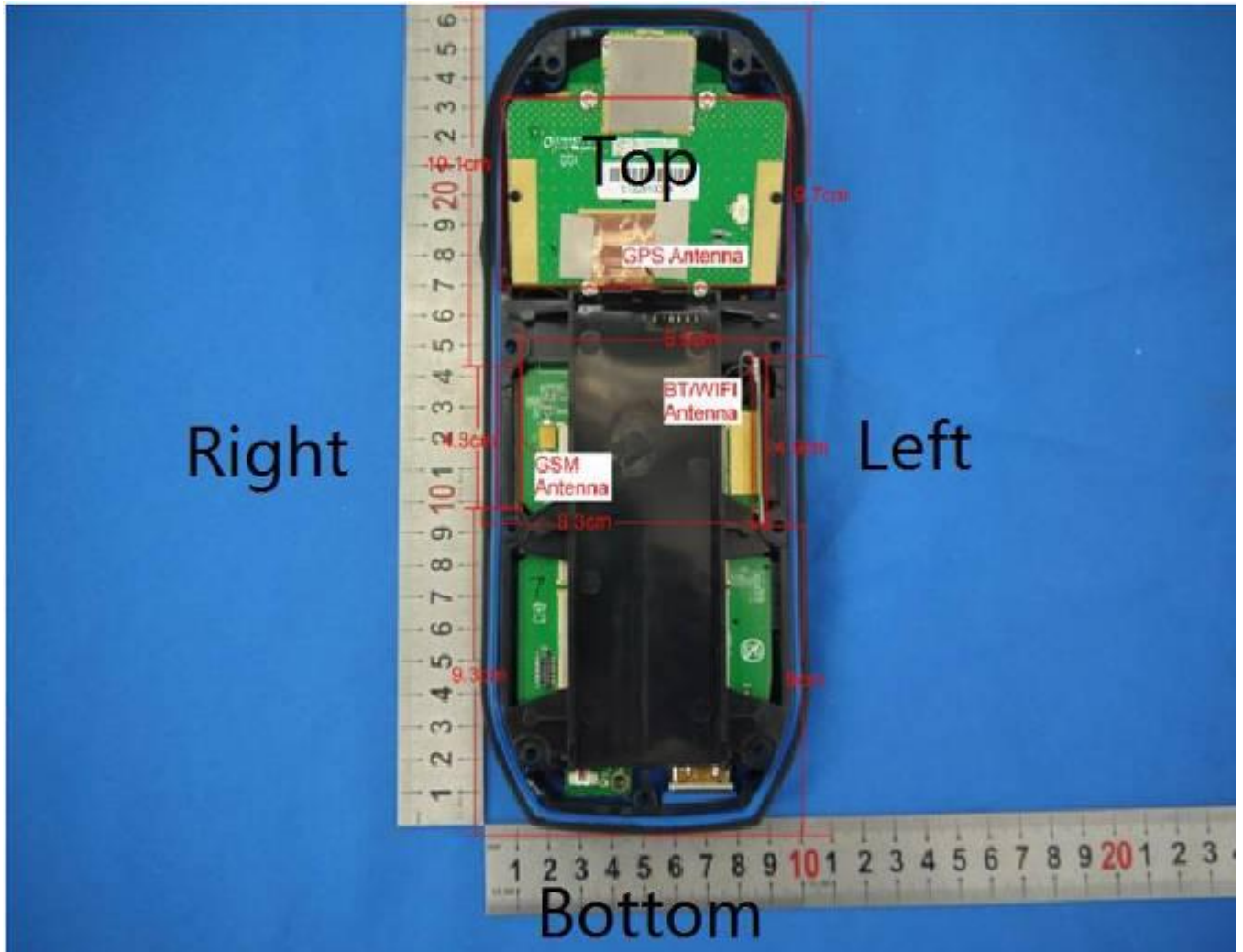

Note: The back surface and edges of the tablet should be tested for SAR compliance with the tablet touching the phantom. The SAR Exclusion Threshold in KDB 447498D01 v05r01 can be applied to determine SAR test exclusion for adjacent edge configurations. The closest distance from the antenna to an adjacent tablet edge is used to determine if SAR testing is required for the adjacent edges, with the adjacent edge positioned against the phantom and the edge containing the antenna positioned perpendicular to the phantom.



8.5.2 Stand-alone SAR

Per FCC KDB 447498 D01 v05r01, the SAR exclusion threshold for distances <50mm is defined by the following equation:

$$\frac{\text{Max Power of Channel (mW)}}{\text{Test Separation Dist (mm)}} * \sqrt{\text{Frequency(GHz)}} \leq 3.0$$

Note:

When the minimum *test separation distance* is < 5 mm, a distance of 5 mm is applied to determine SAR test exclusion.

- 1) Based on the maximum conducted power of Wi-Fi and the antenna to use separation distance, Stand-alone SAR evaluation is required for Wi-Fi; $[(56.23/5) * \sqrt{2.412}] = 17.47 > 3.0$.
- 2) Based on the maximum conducted power of BT and the antenna to use separation distance, Stand-alone SAR evaluation is not required for BT; $[(0.79/5) * \sqrt{2.480}] = 0.25 < 3.0$.

8.5.3 Simultaneous SAR

- 1) Simultaneous Transmission SAR evaluation is not required for GSM and Wi-Fi, because the sum SAR of them is $1.184 < 1.6\text{W/kg}$.
- 2) Per FCC KDB 447498 D01 v05r01, when standalone SAR test exclusion applies to an antenna that transmits simultaneously with other antennas, the standalone SAR must be estimated according to following to determine simultaneous transmission SAR test exclusion

$$\text{Estimated SAR} = \frac{\sqrt{f(\text{GHz})}}{7.5} * \frac{(\text{Max Power of channel, mW})}{\text{Min. Separation Distance, mm}}$$

$$\text{So for } \text{SAR}_{(\text{BT})} = \frac{\sqrt{2.480}}{7.5} * \frac{0.79}{5} = 0.03\text{W/kg}$$

Simultaneous Transmission SAR evaluation is not required for GSM and BT, because the sum SAR of them is $1.214 < 1.6\text{W/kg}$.

- 3) Simultaneous Transmission SAR evaluation is not required for BT and Wi-Fi, because they share the same antenna and cannot transmit at the same time by design.

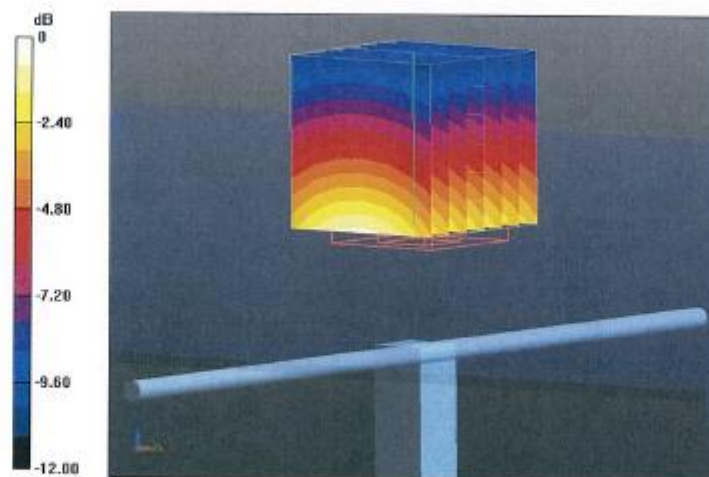

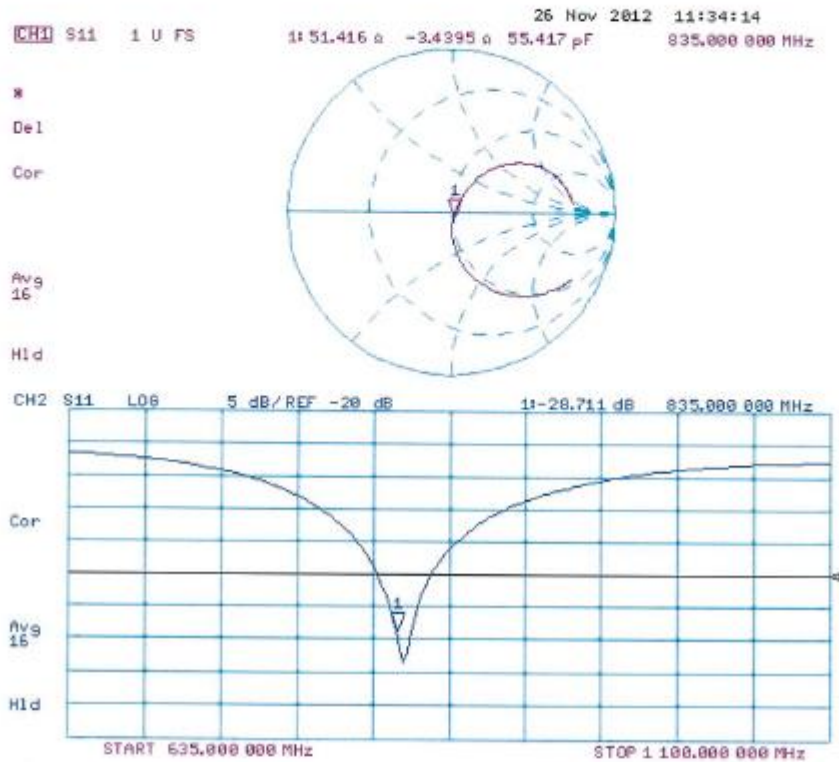

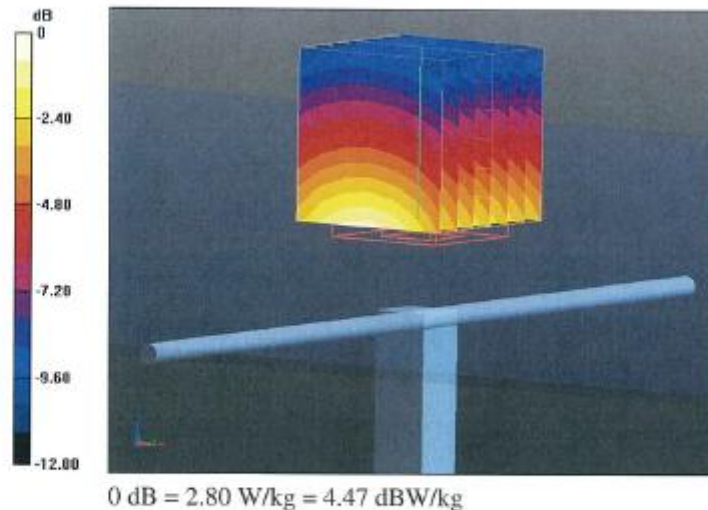

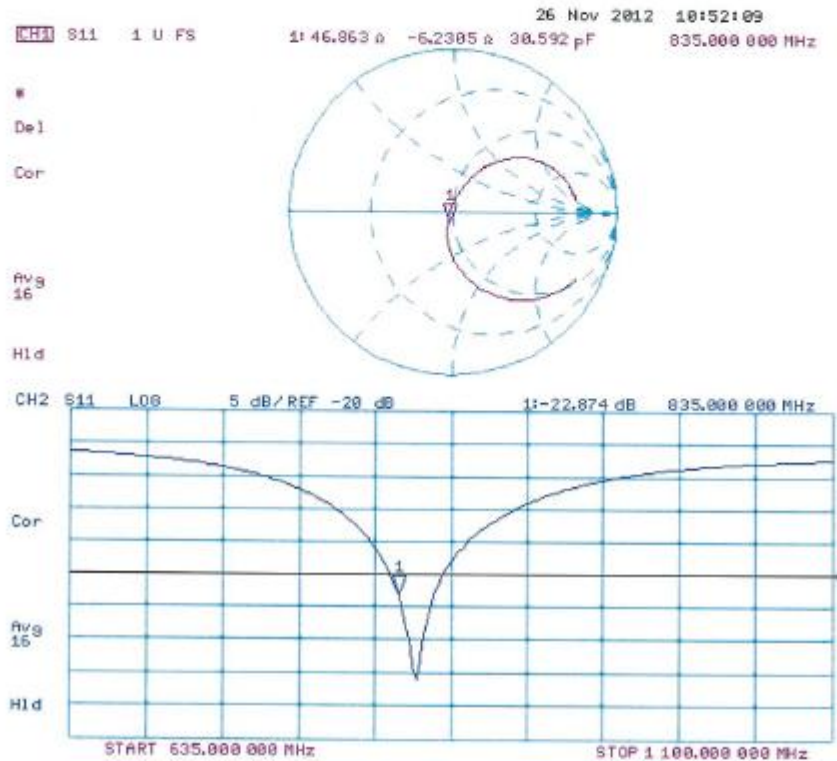

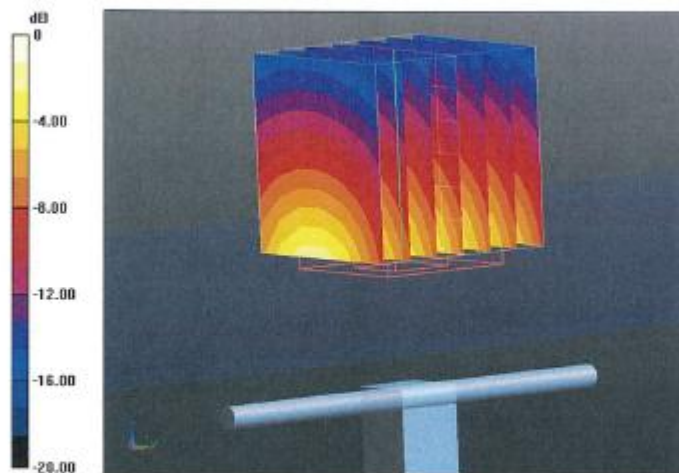

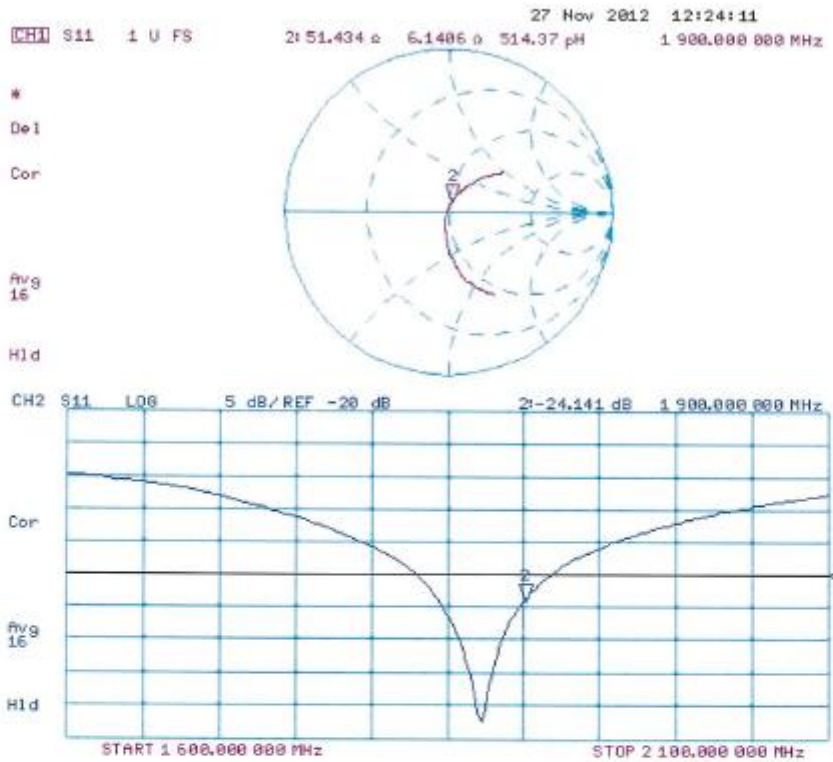

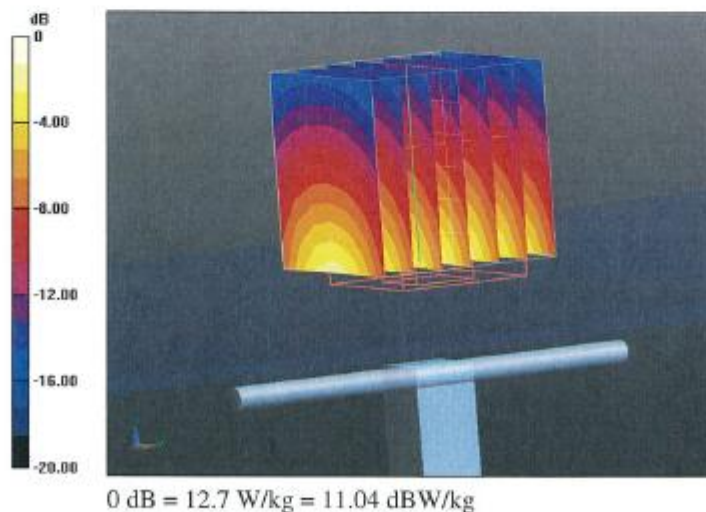

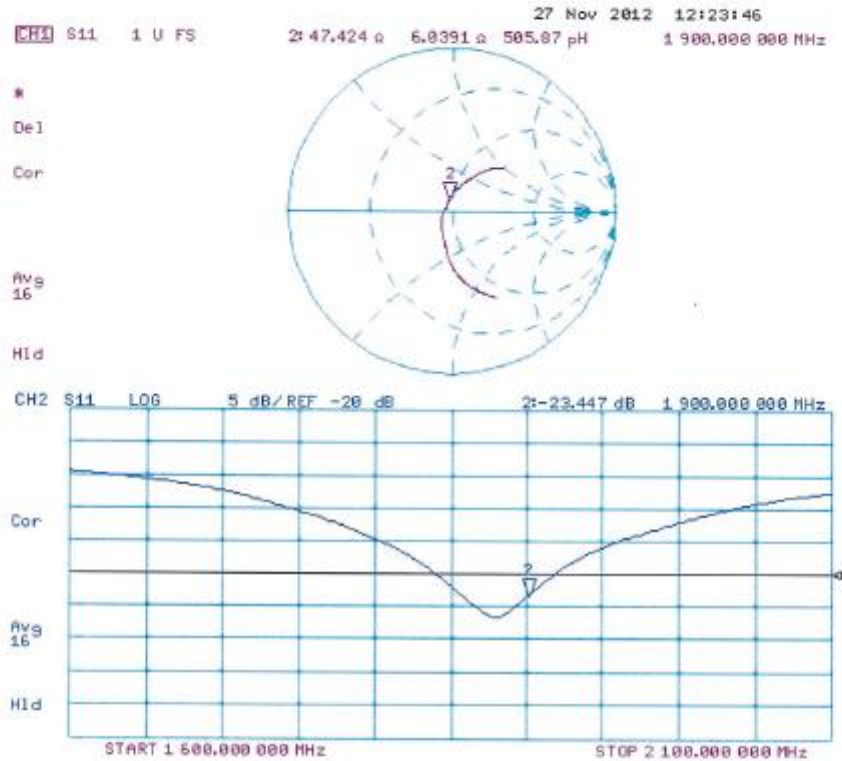
