## 1. " **1** ,**2** ,**3** ,**4** ,**5** ,**6** " buttons:

These six buttons are used to set the fan speed as follows:

1 =One speed 2 =Tow speed 3 =Three speed

**4**=Four speed **5**=Five speed **6** = Six speed

### 2. **"OFF"** button:

This button turns the fan off.

3. " button:

This button will make forward or reverse the fan.

# 4. The "UP LIGHT" "DOWN LIGHT" button turns the light

ON orOFF. Press and release the button to turn
